RELATING TO PUBLIC OFFICERS AND EMPLOYEES--RETIREMENT SYSTEM --  
CONTRIBUTION AND BENEFITS

Introduced By: Senators Paiva Weed, Goodwin, and Ruggerio

Date Introduced: October 18, 2011

It is enacted by the General Assembly as follows:

1           SECTION 1. Legislative intent and findings.

2           (a) It is the intention of the general assembly, in enacting this, the Rhode Island  
3 Retirement Security Act of 2011, to ensure the sustainability of the state's public retirement  
4 systems. In thoroughly reviewing the condition of the retirement systems throughout the State of  
5 Rhode Island and assessing the need for comprehensive reform thereof, the general assembly  
6 finds and declares that:

7           (1) The State of Rhode Island has one of the lowest funded and most vulnerable statewide  
8 pension systems in the country.

9           (2) The State of Rhode Island has suffered deeply through the recent recession and  
10 continues to endure some of the highest unemployment and foreclosure rates in the United States.

11           (3) The current condition of Rhode Island's critically underfunded pension system,  
12 combined with the state's continuing financial instability and existing onerous tax burden,  
13 threatens the base pensions of current and future public workers, hampers the ability of the state  
14 to provide its citizens with vital services necessary for the public's health, safety and welfare, and  
15 places an unsustainable financial burden on all Rhode Island citizens and taxpayers.

16           (4) The state retirement system's unfunded liability exceeds \$7 billion as measured by  
17 well-established and accepted public accounting standards.

18           (5) The largest portion of the retirement system, the Employees Retirement System of

1 Rhode Island (ERSRI) fund for teachers and state employees, is funded at a level of 48% which is  
2 well below benchmarks for a viable, sustainable and adequately funded system.

3 (6) Annual government contributions to ERSRI more than doubled between fiscal years  
4 2005 and 2011 and those contributions are estimated to double again in fiscal year 2013 to exceed  
5 over \$600 million. Without immediate and comprehensive legislative action future contributions  
6 will continue to grow dramatically and exceed \$1 billion dollars in necessary annual  
7 contributions.

8 (7) If pension contributions continue to grow at the current and projected levels, they will  
9 be unaffordable and the pension security of our valued public employees will be placed in  
10 jeopardy.

11 (8) It is critical and of paramount importance to ensure that the public pension plans in  
12 Rhode Island can provide secure pension benefits to our public employees.

13 (9) Life expectancy is increasing dramatically as evidenced by the significant changes  
14 made to the mortality tables in the most recent experience study conducted by the actuary for the  
15 ERSRI and the Municipal Employees Retirement System (MERS). It is essential that these new  
16 life expectancy trends be recognized and that retirement ages be increased in a manner that will  
17 provide for a fiscally sound balance between the career length of active employees and the  
18 expected length of years in which a retiree will receive plan benefits.

19 (10) The vast majority of the unfunded liability for ERSRI is attributable to service  
20 rendered by employees who have already retired, and a very significant portion of this unfunded  
21 liability is represented by future cost of living adjustments (COLAs). Although the pension  
22 benefits of active employees have been reduced by recent legislative reforms, retirees still receive  
23 all the benefits that were in place before the legislative changes. In order to provide a sound  
24 benefit program for all members of the retirement system, and to provide current and future  
25 employees with adequate benefit levels that will enable the state and its cities and towns to attract  
26 and retain a highly qualified workforce, it is essential that the COLA benefits for retirees be  
27 impacted as part of this comprehensive reform of the retirement system.

28 (11) The national credit rating agencies that evaluate the security of Rhode Island's debt  
29 offerings have consistently and unanimously emphasized the significant threat posed by the  
30 unfunded liabilities of the state's current retirement system. Rapidly escalating pension costs  
31 were a critical factor in the negative outlook for the state's credit rating recently issued by  
32 Moody's Investors Service.

33 (12) Future downgrades in the public debt markets related to the rising costs and  
34 expenses of the currently existing state pension system will substantially increase Rhode Island's

1 capital cost structure and adversely affect and greatly diminish the state's ability to address  
2 critical infrastructure needs for education, transportation and other crucial public projects.

3 (13) While plans in the Municipal Employees Retirement System (MERS), with an  
4 average funding level of 73%, are generally more adequately funded than the ERS plans, annual  
5 contributions to the MERS plans will increase dramatically in Fiscal Year 2013 at an average rate  
6 of more than 90% for MERS police and fire plans, and greater than 60% for MERS general  
7 municipal employee plans. The dramatically increasing costs from rising contributions to the  
8 MERS plan will result in the further erosion of the ability of towns and cities to provide services  
9 necessary for the health, safety and welfare of their residents.

10 (14) The fiscal peril related to the growing and substantial unfunded pension liabilities  
11 may necessitate other Rhode Island communities filing for bankruptcy protection which has  
12 already been shown to jeopardize and result in the reduction of significant percentages of the base  
13 of pensions of its retired public servants.

14 (15) The looming pension crisis has also impacted the ability of many Rhode Island  
15 communities to access the debt markets and has resulted in Moody's Investors Service taking  
16 negative action on numerous localities which adversely impacts the taxpayers and their ability to  
17 provide vital public services.

18 (16) The myriad of pension program designs throughout Rhode Island creates  
19 inefficiencies and it is efficient, equitable and fiscally prudent, wherever feasible, to promote  
20 similar plan designs for public employees in similar employment positions.

21 (b) To advance and maintain the long-term stability of the public pension programs  
22 sponsored by the State of Rhode Island and its municipalities, the general assembly further finds  
23 and declares that it is of critical and immediate public importance that these public pension  
24 programs be restructured:

25 (1) To ensure that the state and its cities and towns will be able to provide retirement  
26 benefits that will enable our public employees to enjoy a dignified retirement.

27 (2) To ensure a secure and adequate source of retirement funds for public retiree benefits.

28 (3) To ensure that the cost of current and future benefits is not so great and onerous that it  
29 jeopardizes the ability and obligation of the state and its town and cities to fund the costs of  
30 providing our children with an excellent public education; rebuilding and sustaining our  
31 economy; maintaining roads and bridges; providing assistance, care, and support of our neediest  
32 and most vulnerable citizens; and addressing other essential public programs and purposes.

33 (4) The general assembly expressly finds and declares that the situation currently  
34 confronting the State of Rhode Island's publicly financed pension systems has reached an

1 emergency stage and must be addressed without delay and the enactment of the Rhode Island  
2 Retirement Security Act of 2011 is reasonable and necessary to achieve and protect the  
3 compelling public interests listed herein. The general assembly further finds and declares that the  
4 achievement of those compelling public interests, on balance, far outweigh any impact that such  
5 enactment might have upon the expectations of active and retired members of the affected  
6 pension systems as to potential future pension benefits.

7 SECTION 1. Section 36-8-1 of the General Laws in Chapter 36-8 entitled "Retirement  
8 System - Administration" is hereby amended to read as follows:

9 **36-8-1. Definition of terms.** -- The following words and phrases as used in chapters 8 to  
10 10 of this title unless a different meaning is plainly required by the context, shall have the  
11 following meanings:

12 (1) "Accumulated contributions" shall mean the sum of all the amounts deducted from  
13 the compensation of a member and credited to his or her individual pension account ~~together with~~  
14 ~~regular interest thereon.~~

15 (2) "Active member" shall mean any employee of the State of Rhode Island as defined in  
16 this section for whom the retirement system is currently receiving regular contributions pursuant  
17 to sections 36-10-1 and 36-10-1.1.

18 (3) "Actuarial equivalent" shall mean an allowance or benefit of equal value to any other  
19 allowance or benefit when computed upon the basis of the actuarial assumptions and tables in use  
20 by the system .

21 (4) "Annuity reserve" shall mean the present value of all payments to be made on account  
22 of any annuity, benefit, or retirement allowance granted under the provisions of chapter 10 of this  
23 title computed upon the basis of such mortality tables as shall be adopted from time to time by the  
24 retirement board with regular interest.

25 (5) (a) "Average compensation" for members eligible to retire as of September 30, 2009  
26 shall mean the average of the highest three (3) consecutive years of compensation, within the total  
27 service when the average compensation was the highest. For members eligible to retire on or after  
28 October 1, 2009, "Average compensation" shall mean the average of the highest five (5)  
29 consecutive years of compensation within the total service when the average compensation was  
30 the highest.

31 (b) For members who become eligible to retire on or after July 1, 2012, if more than one  
32 half (1/2) of the member's total years of service consist of years of service during which the  
33 member devoted less than thirty (30) business hours per week to the service of the state, but the  
34 member's average compensation consists of three (3) or more years during which the member

1 devoted more than thirty (30) business hours per week to the service of the state, such member's  
2 average compensation shall mean the average of the highest ten (10) consecutive years of  
3 compensation within the total service when the average compensation was the highest.

4 (6) "Beneficiary" shall mean any person in receipt of a pension, an annuity, a retirement  
5 allowance, or other benefit as provided by chapter 10 of this title.

6 (7) "Casual employee" shall mean those persons hired for a temporary period, a period of  
7 emergency or an occasional period ~~to perform special jobs or functions not necessarily related to~~  
8 ~~the work of regular employees.~~

9 (8) "Compensation" as used in chapters 8 through 10 of this title, chapters 16 and 17 of  
10 title 16, and chapter 21 of title 45 shall mean salary or base wages earned and paid for the  
11 performance of duties for covered employment, including regular longevity or incentive plans  
12 approved by the board, but shall not include payments made for overtime or any other reason  
13 other than performance of duties ~~reasons other than performance of duties or activities~~, including  
14 but not limited to the types of payments listed below:

15 (i) Payments contingent on the employee having terminated or died;

16 (ii) Payments made at termination for unused sick leave, vacation leave, or compensatory  
17 time;

18 (iii) Payments contingent on the employee terminating employment at a specified time in  
19 the future to secure voluntary retirement or to secure release of an unexpired contract of  
20 employment;

21 (iv) Individual salary adjustments which are granted primarily in anticipation of the  
22 employee's retirement;

23 (v) Additional payments for performing temporary or extra duties beyond the normal or  
24 regular work day or work year.

25 (9) "Employee" shall mean any officer or employee of the state of Rhode Island whose  
26 business time is devoted exclusively to the services of the state, but shall not include one whose  
27 duties are of a casual or seasonal nature. The retirement board shall determine who are employees  
28 within the meaning of this chapter. The governor of the state, the lieutenant governor, the  
29 secretary of state, the attorney general, the general treasurer, and the members of the general  
30 assembly, ex officio, shall not be deemed to be employees within the meaning of that term unless  
31 and until they elect to become members of the system as provided in § 36-9-6, but in no case shall  
32 it deem as an employee, for the purposes of this chapter, any individual who devotes less than  
33 twenty (20) business hours per week to the service of the state and who receives less than the  
34 equivalent of minimum wage compensation on an hourly basis for his or her services, except as

1 provided in § 36-9-24. Any commissioner of a municipal housing authority any member of a part-  
2 time state, municipal or local board, commission, committee or other public authority shall not be  
3 deemed to be an employee within the meaning of this chapter.

4 (10) "Full actuarial costs" or "full actuarial value" shall mean the lump sum payable by a  
5 member claiming service credit for certain employment for which that payment is required which  
6 is determined according to the age of the member and the employee's annual rate of  
7 compensation at the time he or she applies for service credit and which is expressed as a rate  
8 percent of the employee's annual rate of compensation to be multiplied by the number of years  
9 for which he or she claims service credit as prescribed in a schedule adopted by the retirement  
10 board from time to time on the basis of computation by the actuary. Except as provided in  
11 sections 16-16-7.1, 36-5-3, 36-9-31, 36-10-10.4, 45-21-53, 36-10-8, 45-21-29, 8-3-16(b), 8-8-  
12 10.1(b), 42-28-22.1(b) and 28- 30- 18.1(b).

13 (i) all AH service credit purchases requested after June 16, 2009 and prior to July 1, 2012,  
14 ~~except military credit a provided by § 36-9-31 and 16-16-7.1,~~ shall be at full actuarial value. and

15 (ii) all service credit purchases requested after June 30, 2012 shall be at full actuarial  
16 value which shall be determined using the system's assumed investment rate of return minus one  
17 percent (1%).

18 The rules applicable to a service credit purchase shall be the rules of the retirement  
19 system in effect at the time the purchase application is submitted to the retirement system.

20 (11) "Inactive member" shall mean a member who has withdrawn from service as an  
21 employee but who has not received a refund of contributions.

22 (12) ~~Member~~ Members shall mean any person included in the membership of the  
23 retirement system as provided in sections 36-9-1 -- 36-9-7.

24 (13) "Prior service" shall mean service as a member rendered before July 1, 1936,  
25 certified on his or her prior service certificate and allowable as provided in section 36-9-28.

26 (14) "Regular interest" shall mean interest ~~at the rate of two percent (2%) per annum,~~  
27 ~~compounded annually, or at such other rate determined from the actual experience of the system~~  
28 ~~as may be prescribed from time to time by the board.~~ at the assumed investment rate of return,  
29 compounded annually, as may be prescribed from time to time by the retirement board.

30 (15) "Retirement allowance" shall mean annual payments for life made after retirement  
31 under and in accordance with chapters 8 to 10 of this title. All allowances shall be paid in equal  
32 monthly installments beginning as of the effective date thereof; provided, that a smaller pro rata  
33 amount may be paid for part of a month where separation from service occurs during the month  
34 in which the application was filed, and when the allowance ceases before the last day of the

1 month.

2 (16) "Retirement board" or "board" shall mean the board provided in section 36-8-3 to  
3 administer the retirement system.

4 (17) "Retirement system" shall mean the employees' retirement system of the State of  
5 Rhode Island as defined in section 36-8-2.

6 (18) "Service" shall mean service as an employee of the State of Rhode Island as  
7 described in subdivision ~~(8)~~ (9) of this section.

8 (19) "Social Security retirement age" shall mean a member's full retirement age as  
9 determined in accordance with the federal Old Age, Survivors and Disability Insurance Act, not  
10 to exceed age sixty-seven (67).

11 (20) ~~(19)~~ "Total service" shall mean prior service as defined above, plus service rendered  
12 as a member on or after July 1, 1936.

13 SECTION 2. Chapter 36-8 of the General Laws entitled "Retirement System -  
14 Administration" is hereby amended by adding thereto the following section:

15 **36-8-4.1. Fiduciary and continuing education requirements.** -- (a) A member of the  
16 board shall discharge duties with respect to the retirement system:

17 (1) Solely in the interest of the participants and beneficiaries;

18 (2) For the exclusive purpose of providing benefits to participants and beneficiaries and  
19 paying reasonable expenses of administering the system;

20 (3) With the care, skill, and caution under the circumstances then prevailing which a  
21 prudent person acting in a like capacity and familiar with those matters would use in the conduct  
22 of an activity of like character and purpose;

23 (4) Impartially, taking into account any differing interests of participants and  
24 beneficiaries;

25 (5) Incurring only costs that are appropriate and reasonable; and

26 (6) In accordance with a good-faith interpretation of the law governing the retirement  
27 system.

28 (b) The retirement board shall establish mandatory continuing education requirements for  
29 members of the board.

30 (c) In the event the retirement board takes any action(s) contrary to the recommendation  
31 of the plan actuary, the executive director shall within thirty (30) days, provide notice of such  
32 action(s) to all plan members, the governor, the speaker of the house of representatives and the  
33 president of the senate.

34 SECTION 4. Section 36-8-8.1 of the General Laws in Chapter 36-8 entitled "Retirement

1 System - Administration" is hereby repealed.

2 ~~**36-8-8.1. Disclosure of special pension benefits.** --- (a) (1) The retirement board is~~  
3 ~~directed to conduct an audit of all special pension benefits conferred on or after January 1, 1970,~~  
4 ~~to date by statute, by the retirement board, or by other public officials or agencies, and report its~~  
5 ~~findings to the governor and to the general assembly no later than March 15, 1993. The report~~  
6 ~~shall disclose all beneficiaries of special pension benefits and shall describe in detail, by~~  
7 ~~beneficiary, the nature of the special pension benefits received, including pension credits or~~  
8 ~~retirement benefits that were purchased by, awarded to, conferred on, or obtained by individuals~~  
9 ~~other than for full time service as a paid employee of the state of Rhode Island. In addition, the~~  
10 ~~report shall describe the manner and method by which those special pension benefits were~~  
11 ~~conferred. For each beneficiary of special pension benefits, the report will calculate the~~  
12 ~~contribution actuarially required to support the special pension benefits conferred and the actual~~  
13 ~~contribution of the beneficiary, adjusted for the ordinary contribution of the state to the retirement~~  
14 ~~system under section 36-10-2 and the investment return of the fund. The report will:~~

15 ~~(i) Disclose for each beneficiary the difference between the actual contribution of the~~  
16 ~~member and the contribution actuarially required to fund the special pension benefit;~~

17 ~~(ii) Render a judgment as to whether the conferral of each benefit, by legislation or~~  
18 ~~otherwise, was correct, lawful and appropriate; and~~

19 ~~(iii) Recommend appropriate remedial legislation and/or administrative action including,~~  
20 ~~where warranted, the repeal of specific legislation conferring inappropriate and/or unwarranted~~  
21 ~~retirement benefits upon individuals.~~

22 ~~(2) The report will include a description by the actuary of the effect on the retirement~~  
23 ~~fund of the special pension benefits described and quantified in the report, and will be certified as~~  
24 ~~true and accurate.~~

25 ~~(3) The cost of the audit and the report shall not exceed the sum of five hundred~~  
26 ~~thousand dollars (\$500,000).~~

27 ~~(b) In each subsequent annual report filed pursuant to section 36-8-8, the retirement~~  
28 ~~board will disclose all special pension benefits awarded to any individual or group during the~~  
29 ~~reporting period and disclose for each member receiving the special pension benefits the~~  
30 ~~difference between the actual contribution of the member and the contribution actuarially~~  
31 ~~required to fund the special pension benefits awarded. The report will include a description by the~~  
32 ~~actuary of the effect on the retirement fund of the special pension benefits described and~~  
33 ~~quantified in the report.~~

34 ~~(c) The retirement board shall take all steps necessary and proper to timely implement~~



1 ~~the provisions of this section, and shall, through March 15, 1993, report to the governor and the~~  
2 ~~general assembly on a continuing basis its progress towards and means of effectuating these~~  
3 ~~legislative purposes.~~

4 SECTION 3. Section 36-8-9 of the General Laws in Chapter 36-8 entitled "Retirement  
5 System - Administration" is hereby amended to read as follows:

6 **36-8-9. Legal adviser – Treasurer – Executive officers and secretary.** – (a) There shall  
7 be a legal counsel to the board who shall be appointed by the general treasurer. The general  
8 treasurer shall be ex-officio chairperson and treasurer of the retirement board and he or she shall  
9 be responsible for appointing the custodian of the funds ~~and the treasurer thereof~~. There shall also  
10 be an executive director who shall be appointed by the retirement board. The executive director  
11 shall be in charge of administration of the retirement system and shall serve as secretary to the  
12 retirement board. In addition, the retirement board shall appoint an assistant director who shall  
13 serve as director and/or secretary in the absence of the director.

14 (b) Any negotiated agreement entered into after June 1, 1992, between any state or  
15 municipal agency or department and an employee or employees, whose conditions are contrary to  
16 the general laws or the rules, regulations, and policies as adopted and promulgated by the  
17 retirement board shall be null and void unless and until approved by formal action of the  
18 retirement board for good cause shown.

19 SECTION 4. Sections 36-9-2.1, 36-9-5, 36-9-20, 36-9-21, 36-9-25.1, 36-9-26 and 36-9-  
20 31.1 of the General Laws in Chapter 36-9 entitled "Retirement System-Membership and Service  
21 Credits" are hereby amended to read as follows:

22 **36-9-2. Membership of persons employed after establishment of system.** – All  
23 employees as defined in chapter 8 of this title who became employees on or after July 1, 1936,  
24 shall, under contract of their employment become members of the retirement system and shall  
25 receive no pension or retirement allowance from any other pension or retirement system  
26 supported wholly or in part by the State of Rhode Island, except as provided in chapter 10.3 of  
27 title 36 and section 36-9-3, nor shall they be required to make contributions under any other  
28 pension or retirement system of the state except as provided in chapter 10.3 of title 36, anything  
29 to the contrary notwithstanding; provided, however, that this section shall not apply to those  
30 employees who may be required or elect to participate in a retirement program existing by virtue  
31 of chapter 17.1 of title 16 or section 36-10-9.1.

32 **36-9-5. Officers and employees exempt – Former court judges and clerks.** – (a) The  
33 members of the general assembly and the general officers of the state, except to the extent herein  
34 provided, the judges of the supreme, superior, family, district courts, the traffic tribunal, judges of

1 the workers' compensation court except to the extent herein provided, school teachers as defined  
2 by section 16-16-1 except to the extent provided by chapter 17 of title 16, and members of the  
3 Rhode Island state police shall be exempt from the provisions of chapters 8 – 10 of this title;  
4 provided, however, that any justice or associate justice or judge of the supreme court, superior  
5 court, family court, district court, or traffic tribunal, chairperson of the workers' compensation  
6 court, or judge of the workers' compensation court who was a member of the retirement system  
7 prior to becoming a justice or associate justice or judge, shall, upon his or her filing with the  
8 retirement board a written waiver of all benefits under the provisions of section 8-3-7 – 8-3-11 or  
9 28-30-15 – 28-30-18 be permitted to elect to remain a member of the retirement system by paying  
10 into the retirement system such sums as provided in section 36-10-1 computed on his or her  
11 salary as a justice, associate justice, or judge and shall be eligible for all benefits under this title.

12 (b) Any justice, associate justice, or judge who shall have retired in accordance with the  
13 provisions of this section and who shall be recalled to service shall be recalled in accordance with  
14 the provisions of section 8-3-7~~(b)~~(c), section 28-30-15(b), or section 28-30-16, or section 28-30-  
15 16.1.

16 **36-9-20. Credit for service as a teacher, municipal employee, or legislator.** – (a) Any  
17 state employee who shall have rendered service as a teacher as defined under the provisions of  
18 chapters 16 and 17 of title 16 shall be entitled to credit for that service for the various purposes of  
19 this system, provided the member shall have been a contributing member of this system for that  
20 period. Any state employee who shall have been a contributing member of the municipal system  
21 as defined under the provisions of chapter 21 of title 45 shall be given credit for that service for  
22 the various purposes of this system, provided the member's contributions are transferred to this  
23 system. All contributions made by the member shall be transferred into this system for the periods  
24 of service and the retirement system shall calculate the full actuarial value of the accrued benefit  
25 with the former employer. If the full actuarial value of the accrued benefit with the former  
26 employer is greater than the total employee contributions transferred, the retirement system shall  
27 also transfer the difference between the full actuarial value of the accrued benefit with the former  
28 employer and the employee's contributions from the account of the former employer to the  
29 account of the current employer. In any case in which a member shall have received a refund or  
30 refunds of contributions made to the system, the allowance of the aforesaid credit for service shall  
31 be conditioned upon the payment of the full actuarial cost as defined in subsection 36-8-1(910).  
32 Any service as defined herein for which no contributions were made may be granted provided the  
33 member pays to the retirement system the full actuarial cost as defined in section 36-8-1(910).  
34 Any state employee or teacher as defined under the provisions of chapters 16 and 17 of title 16

1 who shall have been employed by a municipality which did not elect to accept chapter 21 of title  
2 45 as provided in section 45-21-4 shall be given credit for that service for the various purposes of  
3 this system, provided that the employee shall have met the definitional requirements of  
4 "employee" as stated in section 45-21-2(5) and provided the member pays to the retirement  
5 system an amount equal to the full actuarial value of the credit as certified by the retirement  
6 board; provided, however, that any state employee who shall have been employed by a  
7 municipality which did not elect to accept chapter 21 of title 45 as provided in section 45-21-4  
8 shall be given credit for that service for the various purposes of this system, to a maximum period  
9 of four (4) years, provided the member pays to the retirement system the full actuarial cost as  
10 defined in subsection 36-8-1(910). Nothing in this section shall be deemed to allow the purchase  
11 of four (4) years of service for credit in more than one retirement system.

12 (b) The retirement board shall fix and determine rules and regulations to govern the  
13 provisions of this section.

14 **36-9-21. Service information submitted by department heads.** – It shall be the duty of  
15 the head of each department and agency to ~~submit~~ furnish at the times and in the manner that the  
16 retirement board and/or the retirement system may direct, to the retirement board a statement  
17 showing information concerning the name, title, compensation, duties, date of birth, and length of  
18 service of each member employed, and ~~such~~ any other information which the retirement board or  
19 retirement system considers necessary for the proper execution of this chapter, and to give prompt  
20 notice of all appointments, removals, deaths, resignations, leaves of absence and changes in pay  
21 of members as the retirement board may require.

22 **36-9-25.1. Leave service credits.** – (a) Notwithstanding any other provisions of the  
23 retirement law or rulings of the retirement board in accordance with the powers vested therein,  
24 state employees with at least one year of service who have been granted by their appointing  
25 authority a leave of absence without pay to further their education in the field of their state  
26 employment, shall be entitled to credit as service for the various purposes of their retirement  
27 system, provided the person, upon completion of his or her educational leave, returns to state  
28 service for at least one year; and provided further that the employee makes arrangements to pay  
29 into the retirement system on or before the date of retirement and in such manner as the  
30 retirement board may prescribe an amount equal to the full actuarial cost as defined in subsection  
31 36-8-1(9 10) based upon his or her expected compensation but for the granting of leave without  
32 pay.

33 (b) Any state employee who is granted a leave of absence without pay for illness, injury,  
34 or any other reason may receive credit therefor by making the full actuarial cost as defined in

1 subsection 36-8-1 (9-10); provided the employee returns to state service for at least one year  
2 upon completion of the leave. Credit for leaves of absence shall be limited in the aggregate during  
3 the total service of an employee to a period of four (4) years.

4 **36-9-26. Credits for layoffs.** -- (a) Members who are laid off for any reason and are not  
5 on leave without pay may purchase up to one years' credit for retirement purposes; provided the  
6 member did not withdraw his or her retirement contributions while on layoff, and returns to active  
7 membership; provided, further, that the member purchases that credit upon his or her return to  
8 service from the layoff and pays into the retirement system the full actuarial cost as defined in  
9 subsection 36-8-1 (9-10).

10 (b) The retirement board shall fix and determine rules and regulations to govern the  
11 provisions of this section.

12 **36-9-31.1. Peace corps, teacher corps, and volunteers in service to America.** --

13 (a) Any active member who served in the peace corps, teacher corps, or in Volunteers in  
14 service to America may purchase credit for that service up to a maximum of four (4) years in the  
15 aggregate; provided, that any member on an official leave of absence for illness or injury shall be  
16 eligible to purchase those credits while on the leave of absence.

17 (b) The cost to purchase these credits shall be the full actuarial cost as defined in  
18 subsection 36-8-1(9-10) of that service in the peace corps, teacher corps, or VISTA, up to a  
19 maximum of four (4) years.

20 SECTION 5. Sections 36-10-1, 36-10-2, 36-10-2.1, 36-10-8, 36-10-9, 36-10-9.1, 36-10-  
21 9.2, 36-10-9.3, 36-10-9.6, 36-10-10, 36-10-10.2, 36-10-10.4, 36-10-11, 36-10-18, 36-10-19.1, 36-  
22 10-33, 36-10-35 and 36-10-37 of the General Laws in Chapter 36-10 entitled "Retirement  
23 System-Contributions and Benefits" are hereby amended to read as follows:

24 **36-10-1. Member contributions – Deduction from compensation.** – (a) Prior to July 1,  
25 2012, each ~~Each~~ member of the retirement system shall contribute an amount equal to eight and  
26 ~~one-half~~ three-quarters percent ~~( 8.75%) (8.5%)~~ of his or her compensation as his or her share of  
27 the cost of annuities, benefits, and allowances. Effective July 1, 2012, each member of the  
28 retirement system shall contribute an amount equal to three and three quarters percent (3.75%) of  
29 his or her compensation, except for correctional officers as defined in section 36-10-9.2 who shall  
30 contribute an amount equal to eight and three quarters percent (8.75%) of his or her  
31 compensation.  ~~;provided, however, that each member will also initially contribute one-eighth of~~  
32 ~~one percent (0.125%) in the fiscal year beginning July 1, 1989, and one-eighth of one percent~~  
33 ~~(0.125%) in the fiscal year beginning July 1, 1990. Any contributions made by employees prior to~~  
34 ~~July 1, 1990, for the purpose of providing health benefits to retirees as provided in section 36-12-~~

1 ~~4 shall be transferred to each employee's retirement annuity account. Every person being a~~  
2 ~~member of the general assembly and electing to participate in the benefits provided of section 36-~~  
3 ~~9-6, shall contribute an amount equal to thirty percent (30%) of his or her compensation.~~ The  
4 contributions shall be made in the form of deductions from compensation.

5 (b) The deductions provided for herein shall be made notwithstanding that the minimum  
6 compensation provided by law for any member shall be reduced thereby. Every member shall be  
7 deemed to consent and agree to the deductions made and provided for herein and ~~shall~~ receipt of  
8 ~~for~~ his or her full compensation and payment of compensation, less the deductions, shall be a full  
9 and complete discharge and acquittance of all claims and demands whatsoever for the services  
10 rendered by the person during the period covered by the payment except as to the benefit  
11 provided under this chapter.

12 **36-10-2. State contributions.** – (a) The State of Rhode Island shall make its contribution  
13 for the maintenance of the system, including the proper and timely payment of benefits in  
14 accordance with the provisions of this chapter and chapters 8, 16, 28, 31 and 42 of this title, by  
15 annually appropriating an amount equal to a percentage of the total compensation paid to the  
16 active membership. The percentage shall be computed by the actuary employed by the retirement  
17 system and shall be certified by the retirement board to the director of administration on or before  
18 the fifteenth day of October in each year. In arriving at the yearly employer contribution the  
19 actuary shall determine the value of:

- 20 (1) The contributions made by the members;  
21 (2) Income on investments; and  
22 (3) Other income of the system.

23 (b) The Actuary shall thereupon compute the yearly employer contribution that will:

- 24 (1) Pay the actuarial estimate of the normal cost for the next succeeding fiscal year;  
25 (2) Amortize the unfunded liability of the system ~~as of June 30, 1999 utilizing a time~~  
26 ~~period not to exceed thirty (30) years~~ in accordance with section 36-10-2.1(b).

27 ~~(3) Provided, that the employer contribution shall be deferred from the effective date of~~  
28 ~~this act until June 15, 2010. The amounts that would have been contributed shall be deposited in a~~  
29 ~~special fund and not used for any purpose.~~

30 (c) The State of Rhode Island shall remit to the general treasurer the employer's share of  
31 the contribution for state employees, state police, and judges on a payroll frequency basis, and for  
32 teachers in a manner pursuant to section 16-16-22.

33 (d) In accordance with the intent of section 36-8-20 that the retirement system satisfy the  
34 requirements of section 401(a) of the Internal Revenue Code of 1986, the state shall pay to the

1 retirement system:

2 (i) By June 30, 1995, an amount equal to the sum of the benefits paid to state legislators  
3 pursuant to section 36-10-10.1 in excess of ten thousand dollars (\$10,000) per member (plus  
4 accrued interest on such amount at eight percent (8%)) for all fiscal years beginning July 1, 1991,  
5 and ending June 30, 1995, but this amount shall be paid only if section 36-10-10.1(e) becomes  
6 effective January 1, 1995; and

7 (ii) By December 31, 1994, twenty million seven hundred eighty eight thousand eight  
8 hundred twelve dollars and nineteen cents (\$20,788,812.19) plus accrued interest on that amount  
9 at eight percent (8%) compounded monthly beginning March 1, 1991, and ending on the date this  
10 payment is completed (reduced by amortized amounts already repaid to the retirement system  
11 with respect to the amounts withdrawn by the state during the fiscal year July 1, 1990 – June 30,  
12 1991); and

13 (iii) By June 30, 1995, the sum of the amounts paid by the retirement system for retiree  
14 health benefits described in section 36-12-4 for all fiscal years beginning July 1, 1989, and ending  
15 June 30, 1994, to the extent that the amounts were not paid from the restricted fund described in  
16 subsection (c).

17 (2) Any and all amounts paid to the retirement system under this subsection shall not  
18 increase the amount otherwise payable to the system by the State of Rhode Island under  
19 subsection (a) for the applicable fiscal year. The actuary shall make such adjustments in the  
20 amortization bases and other accounts of the retirement system as he or she deems appropriate to  
21 carry out the provisions and intent of this subsection.

22 (e) In addition to the contributions provided for in subsection (a) through (c) and in order  
23 to provide supplemental employer contributions to the retirement system, commencing in fiscal  
24 year 2006, and each year thereafter:

25 (1) Except for fiscal year 2009, fiscal year 2010 and fiscal year 2011, for each fiscal year  
26 in which the actuarially determined state contribution rate for state employees, [including state](#)  
27 [contributions under chapter 36-10.3](#), is lower than that for the prior fiscal year, the governor shall  
28 include an appropriation to that system equivalent to twenty percent (20%) of the rate reduction  
29 for the state's contribution rate for state employees to be applied to the actuarial accrued liability  
30 of the state employees' retirement system for state employees for each fiscal year.

31 (2) Except for fiscal year 2009, fiscal year 2010 and fiscal year 2011, for each fiscal year  
32 in which the actuarially determined state contribution rate for teachers, [including state](#)  
33 [contributions under chapter 36-10.3](#), is lower than that for the prior fiscal year, the governor shall  
34 include an appropriation to that system equivalent to twenty percent (20%) of the rate reduction

1 for the state's share of the contribution rate for teachers to be applied to the actuarial accrued  
2 liability of the state employees' retirement system for teachers for each fiscal year.

3 (3) The amounts to be appropriated shall be included in the annual appropriation bill and  
4 shall be paid by the general treasurer into the retirement system.

5 (f) While the retirement system's actuary shall not adjust the computation of the annual  
6 required contribution for the year in which supplemental contributions are received, such  
7 contributions once made may be treated as reducing the actuarial liability remaining for  
8 amortization in the next following actuarial valuation to be performed.

9 **36-10-2.1. Actuarial cost method.** – (a) To determine the employer contribution rate for  
10 the State of Rhode Island for fiscal year 2002 and for all fiscal years subsequent, the actuary shall  
11 compute the costs under chapter 10 of title 36 using the entry age normal cost method. Effective  
12 July 1, 2012, the entry age normal cost method shall be as defined in Accounting Standard No. 27  
13 of the Governmental Accounting Standards Board as in effect from time to time.

14 (b) The determination of the employer contribution rate for fiscal year 2013 ~~2002 and~~  
15 ~~hereafter~~ shall include a reamortization of the current Unfunded Actuarial Accrued Liability  
16 (UAAL) over a closed twenty-five (25) year period. After an initial period of five (5) years, future  
17 actuarial gains and losses occurring within a plan year will be amortized over individual new  
18 twenty (20) year closed periods ~~period not to exceed thirty (30) years.~~

19 **36-10-8. Refund of contributions – Repayment and restoration of credits.** – A  
20 member who withdraws from service or ceases to be a member for any reason other than death or  
21 retirement shall be paid on demand a refund consisting of the accumulated contributions standing  
22 to his or her credit in his or her individual account ~~in the annuity savings account~~, without  
23 interest. Any member receiving a refund shall thereby forfeit and relinquish all accrued rights as a  
24 member of the system together with credits for total service previously granted to the member;  
25 provided, however, that if any member who has received a refund shall subsequently reenter the  
26 service and again become a member of the system, he or she shall have the privilege of restoring  
27 all money previously received or disbursed to his or her credit as a refund of contributions, plus  
28 regular interest for the period from the date of refund to the date of the restoration. Upon the  
29 repayment of such refund including accrued interest as herein provided, the member shall again  
30 receive credit for the amount of total service which he or she had previously forfeited by the  
31 acceptance of the refund. The restoration of that credit shall be permitted only after the member  
32 shall have rendered at least one year of continuous service following his or her latest reentry into  
33 service for which he or she shall have made contributions to this system.

34 **36-10-9. Retirement on service allowance – In general.** – Retirement of a member on a



1 service retirement allowance shall be made by the retirement board as follows:

2 (1)(a)(i) Any member may retire upon his or her written application to the retirement  
3 board as of the first day of the calendar month in which the application was filed; provided, the  
4 member was separated from service prior thereto; and further provided, however, that if  
5 separation from service occurs during the month in which application is filed, the effective date  
6 shall be the first day following that separation from service; and provided further that the member  
7 on his or her retirement date attained the age of sixty (60) and completed at least ten (10) years of  
8 contributory service on or before July 1, 2005 or who, regardless of age, has completed twenty-  
9 eight (28) years of total service and has completed at least ten (10) years of contributory service  
10 on or before July 1, 2005, and who retire before October 1, 2009 or are eligible to retire as of  
11 September 30, 2009.

12 (ii) For members who become eligible to retire on or after October 1, 2009 and prior to  
13 July 1, 2012, benefits are available to members who have attained the age of sixty-two (62) and  
14 completed at least ten (10) years of contributory service. For members in service as of October 1,  
15 2009 who were not eligible to retire as of September 30, 2009 but become eligible to retire prior  
16 to July 1, 2012, the minimum retirement age of sixty-two (62) will be adjusted downward in  
17 proportion to the amount of service the member has earned as of September 30, 2009. The  
18 proportional formula shall work as follows:

19 (1) The formula shall determine the first age of retirement eligibility under the laws in  
20 effect on September 30, 2009 which shall then be subtracted from the minimum retirement age of  
21 sixty-two (62).

22 (2) The formula shall then take the member's total service credit as of September 30,  
23 2009 as the numerator and the years of service credit determined under (1) as the denominator.

24 (3) The fraction determined in (2) shall then be multiplied by the age difference  
25 determined in (1) to apply a reduction in years from age sixty-two (62).

26 (b)(i) Any member, who has not completed at least ten (10) years of contributory service  
27 on or before July I, 2005, may retire upon his or her written application to the retirement board as  
28 of the first day of the calendar month in which the application was filed; provided, the member  
29 was separated from service prior thereto; and further provided, however, that if separation from  
30 service occurs during the month in which application is filed, the effective date shall be the first  
31 day following that separation from service; provided, the member or his or her retirement date  
32 had attained the age of fifty-nine (59) and had completed at least twenty-nine (29) years of total  
33 service or provided that the member on his or her retirement date had attained the age of sixty-  
34 five (65) and had completed at least ten (10) years of contributory service; or provided, that the



1 member on his or her retirement date had attained the age of fifty-five (55) and had completed  
2 twenty (20) years of total service provided, that the retirement allowance, as determined  
3 according to the formula in § 36-10-10 is reduced actuarially for each month that the age of the  
4 member is less than sixty-five (65) years, and who retire before October 1, 2009 or are eligible to  
5 retire as of September 30, 2009.

6 (ii) For members who become eligible to retire on or after October 1, 2009 and prior to  
7 July 1, 2012, benefits are available to members who have attained the age of sixty-two (62) and  
8 completed at least twenty-nine (29) years of total service or have attained the age of sixty-five  
9 (65) and completed at least ten (10) years of contributory service. For members in service as of  
10 October 1, 2009 who were not eligible to retire as of September 30, 2009 but become eligible to  
11 retire prior to July 1, 2012, who have a minimum retirement age of sixty-two (62), the retirement  
12 age will be adjusted downward in proportion to the amount of service the member has earned as  
13 of September 30, 2009. The proportional formula shall work as follows:

14 (1) The formula shall determine the first age of retirement eligibility under the laws in  
15 effect on September 30, 2009 which shall then be subtracted from the minimum retirement age of  
16 sixty-two (62).

17 (2) The formula shall then take the member's total service credit as of September 30,  
18 2009 as the numerator and the years of service credit determined under (1) as the denominator.

19 (3) The fraction determined in (2) above shall then be multiplied by the age difference  
20 determined in (1) to apply a reduction in years from age sixty-two (62).

21 (c) Effective July 1, 2012, the following shall apply to all members not eligible to retire  
22 prior to July 1, 2012:

23 (i) A member with contributory service on or after July 1, 2012, shall be eligible to retire  
24 upon the completion of at least five (5) years of contributory service and attainment of the  
25 member's Social Security retirement age.

26 (ii) For members with five (5) or more years of contributory service as of June 30, 2012,  
27 with contributory service on and after July 1, 2012, who have a retirement age of Social Security  
28 Retirement Age, the retirement age will be adjusted downward in proportion to the amount of  
29 service the member has earned as of June 30, 2012, but in no event shall a member's retirement  
30 age under this subparagraph (ii) be prior to the attainment of age fifty-nine (59) or prior to the  
31 member's retirement age determined under the laws in effect on June 30, 2012. The proportional  
32 formula shall work as follows:

33 (1) The formula shall determine the first age of retirement eligibility under the laws in  
34 effect on June 30, 2012 which shall then be subtracted from Social Security retirement age;

1           (2) The formula shall then take the member's total service credit as of June 30, 2012 as  
2 the numerator and the projected service at retirement age in effect on June 30, 2012 as the  
3 denominator;

4           (3) The fraction determined in (2) shall then be multiplied by the age difference  
5 determined in (1) to apply a reduction in years from Social Security retirement age.

6           (iii) A member who has completed twenty (20) or more years of total service and who  
7 has attained an age within five (5) years of the eligible retirement age under subparagraphs (c)(i)  
8 or (c)(ii) above, may elect to retire provided that the retirement allowance shall be reduced  
9 actuarially for each month that the age of the member is less than the eligible retirement age  
10 under subparagraphs (c)(i) or (c)(ii) above.

11           (iv) Notwithstanding any other provisions of section 36-10-9(c), a member who has  
12 completed ten (10) or more years of contributory service as of June 30, 2012, may elect to retire  
13 at his or her eligible retirement date as determined under paragraphs (1)(a) and (1)(b) above  
14 provided that a member making an election under this paragraph shall receive the member's  
15 retirement benefit determined and calculated based on the member's service and average  
16 compensation as of June 30, 2012. This provision shall be interpreted and administered in a  
17 manner to protect a member's accrued benefit on June 30, 2012.

18           (2) Any faculty employee at a public institution of higher education under the jurisdiction  
19 of the board of governors for higher education shall not be involuntarily retired upon attaining the  
20 age of seventy (70) years.

21           (3) Except as specifically provided in section 36-10-9.1, section 36-10-12 – 36-10-15,  
22 and section 45-21-19 – 45-21-22, (I) On or prior to June 30, 2012 no member shall be eligible for  
23 pension benefits under this chapter unless the member shall have been a contributing member of  
24 the employee's retirement system for at least ten (10) years, or (II) For members in active  
25 contributory service on or after July 1, 2012, the member shall have been a contributing member  
26 of the retirement system for at least five (5) years.

27           (ii) Provided, however, a person who has ten (10) years service credit on or before June  
28 16, 1991, shall be vested.

29           (iii) Furthermore, any past service credits purchased in accordance with section 36-9-38  
30 shall be counted towards vesting.

31           (iv) Any person who becomes a member of the employees' retirement system pursuant to  
32 section 45-21-4 shall be considered a contributing member for the purpose of chapter 21 of title  
33 45 and this chapter.

34           (v) Notwithstanding any other provision of law, no more than five (5) years of service

1 credit may be purchased by a member of the system. The five (5) year limit shall not apply to any  
2 purchases made prior to January 1, 1995. A member who has purchased more than five (5) years  
3 of service credits before January 1, 1995, shall be permitted to apply those purchases towards the  
4 member's service retirement. However, no further purchase will be permitted. Repayment in  
5 accordance with applicable law and regulation of any contribution previously withdrawn from the  
6 system shall not be deemed a purchase of service credit.

7 (vi) Notwithstanding any other provision of law, effective July 1, 2012, except for  
8 purchases under sections 16-16-7.1, 36-5-3, 36-9-31, 36-10-10.4, and 45-21-53, (A) For service  
9 purchases for time periods prior to a member's initial date of hire, the purchase must be made  
10 within three (3) years of the member's initial date of hire, (B) For service purchases for time  
11 periods for official periods of leave as authorized by law, the purchase must be made within three  
12 (3) years of the time the official leave was concluded by the member. Notwithstanding the  
13 preceding sentence, service purchases from time periods prior to June 30, 2012 may be made on  
14 or prior to June 30, 2015.

15 (4) No member of the employees' retirement system shall be permitted to purchase  
16 service credits for casual, ~~or~~ seasonal, or temporary employment, or emergency appointment, for  
17 employment as a page in the general assembly, or for employment at any state college or  
18 university while the employee is a student or graduate assistant of the college or university.

19 (5) Except as specifically provided in section 16-16-6.2 and 16-16-6.4, a member shall  
20 not receive service credit in this retirement system for any year or portion of it, which counts as  
21 service credit in any other retirement system in which the member is vested or from which the  
22 member is receiving a pension and/or any annual payment for life. This subsection shall not apply  
23 to any payments received pursuant to the federal Social Security Act or to payments from a  
24 military pension earned prior to participation in state or municipal employment, or to military  
25 service credits earned prior to participation in state or municipal employment.

26 (6) A member who seeks to purchase or receive service credit in this retirement system  
27 shall have the affirmative duty to disclose to the retirement board whether or not he or she is a  
28 vested member in any other retirement system and/or is receiving a pension, retirement  
29 allowance, or any annual payment for life. The retirement board shall have the right to investigate  
30 as to whether or not the member has utilized the same time of service for credit in any other  
31 retirement system. The member has an affirmative duty to cooperate with the retirement board  
32 including, by way of illustration and not by way of limitations the duty to furnish or have  
33 furnished to the retirement board any relevant information which is protected by any privacy act.

34 (7) A member who fails to cooperate with the retirement board shall not have the time of

1 service counted toward total service credit until such time as the member cooperates with the  
2 retirement board and until such time as the retirement board determines the validity of the service  
3 credit.

4 (8) A member who knowingly makes a false statement to the retirement board regarding  
5 service time or credit shall not be entitled to a retirement allowance and is entitled only to the  
6 return of his or her contributions without interest.

7 **36-10-9.2. Retirement on service allowance – Correctional officers.** – (a) This section  
8 shall apply to the retirement of members employed as assistant director (adult services), assistant  
9 deputy director, chief of inspection, and associate directors, correctional officer, chief of security,  
10 work rehabilitation program supervisor, supervisor of custodial records and reports, and  
11 classification counselor within the department of corrections.

12 (b)(i) Any member who has attained the age of fifty (50) years may be retired subsequent  
13 to the proper execution and filing of a written application; provided, however, that the member  
14 shall have completed twenty (20) years of total service within the department of corrections and  
15 who retires before October 1, 2009 or is eligible to retire as of September 30, 2009.

16 (ii) For members who become eligible to retire on or after October 1, 2009 benefits are  
17 available to members who have attained the age of fifty-five (55) and have completed at least  
18 twenty-five (25) years of total contributory service within the department of corrections. For  
19 members in service as of October 1, 2009 who were not eligible to retire as of September 30,  
20 2009 but who are eligible to retire on or prior to June 30, 2012, the minimum retirement age of  
21 fifty-five (55) will be adjusted downward in proportion to the amount of service the member has  
22 earned as of September 30, 2009. The proportional formula shall work as follows:

23 (1) The formula shall determine the first age of retirement eligibility under the laws in  
24 effect on September 30, 2009 which shall then be subtracted from the minimum retirement age of  
25 fifty-five (55).

26 (2) The formula shall then take the member's total service credit as of September 30,  
27 2009 as the numerator and the years of service credit determined under (1) as the denominator.

28 (3) The fraction determined in (2) shall then be multiplied by the age difference  
29 determined in (1) to apply a reduction in years from age fifty-five (55).

30 (c) Any member with contributory service on or after July 1, 2012, who has completed at  
31 least five (5) years of contributory service but who has not completed twenty-five (25) years of  
32 contributory service, shall be eligible to retire upon the attainment of the member's Social  
33 Security retirement age.

34 **36-10-9.3. Retirement on service allowance - Registered nurses.** -- (a) This section

1 shall apply to the retirement of members employed as registered nurses within the department of  
2 behavioral healthcare, developmental disabilities and hospitals.

3 (b) Any member who has attained the age of fifty (50) years may be retired subsequent to  
4 the proper execution and filing of written application; provided, however, that the member shall  
5 have completed twenty-five (25) years of total service within the department of behavioral  
6 healthcare, developmental disabilities and hospitals and who retires before October 1, 2009 or is  
7 eligible to retire as of September 30, 2009.

8 (c) For members who become eligible to retire on or after October 1, 2009, benefits are  
9 available to members who have attained the age of fifty-five (55) and have completed at least  
10 twenty-five (25) years of total service within the department of behavioral healthcare,  
11 developmental disabilities and hospitals. For members in service as of October 1, 2009 who were  
12 not eligible to retire as of September 30, 2009 but who are eligible to retire on or prior to June 30,  
13 2012, the minimum retirement age of fifty-five (55), the retirement age will be adjusted  
14 downward in proportion to the amount of service the member has earned as of September 30,  
15 2009. The proportional formula shall work as follows:

16 (1) The formula shall determine the first age of retirement eligibility under the laws in

19 (2) The formula shall then take the member's total service credit as of September 30,  
20 2009 as the numerator and the years of service credit determined under (1) as the denominator.

21 (3) The fraction determined in (2) shall then be multiplied by the age difference  
22 determined in (1) to apply a reduction in years from age fifty-five (55).

23 **36-10-9.6. Aeronautics inspectors – Retirement.** – (a) This section shall only apply to  
24 the retirement of members employed as aeronautics inspectors.

25 (b) In determining the creditable ~~credible~~ service of any aeronautics inspector employed  
26 by the State of Rhode Island for the purpose of retirement of a service retirement allowance, not  
27 including a deferred retirement allowance, there may be added to, and included in, total service as  
28 defined in this chapter, not more than four (4) years of applied work experience, the experience to  
29 be defined as a pilot or aeronautics inspector. The service shall not be counted as credible service  
30 unless the member shall pay into the retirement system the contribution equal to ten percent  
31 (10%) of the member's first year earnings as an aeronautics inspector for the first year purchased,  
32 ten percent (10%) of the member's second year earnings as an aeronautics inspector for the  
33 second year purchased, ten percent (10%) of the member's third year earnings as an aeronautics  
34 inspector for the third year purchased, and ten percent (10%) of the member's fourth year

1 earnings as an aeronautics inspector for the fourth year purchased. Application to purchase credit  
2 and payment for each year of the year for which he or she claims credit shall be made on or  
3 before December 31, 1987. Thereafter, a member applying for credits shall pay full actuarial  
4 costs.

5 **36-10-10. Amount of service retirement allowance.** – (a)(1)(i) For employees eligible  
6 to retire on or before September 30, 2009, upon retirement for service under section 36-10-9, a  
7 member whose membership commenced before July 1, 2005 and who has completed at least ten  
8 (10) years of contributory service on or before July 1, 2005 shall receive a retirement allowance  
9 which shall be determined in accordance with schedule A below [for service prior to July 1, 2012](#):

22 service on or after October 1, 2009 [and prior to July 1, 2012](#).

23 (2) Upon retirement for service under section 36-10-9, a member whose membership  
24 commenced after July 1, 2005, or who has not completed at least ten (10) years of contributory  
25 service as of July 1, 2005, shall, receive a retirement allowance which shall be determined in  
26 accordance with Schedule B below [for service prior to July 1, 2012](#):

1 (b) The retirement allowance of any member whose membership commenced before July  
2 1, 2005 and who has completed at least ten (10) years of contributory service on or before July 1,  
3 2005 shall be in an amount equal to the percentage allowance specified in subsection (a)(1) of his  
4 or her average highest three (3) consecutive years of compensation multiplied by the number of  
5 years of total service, but in no case to exceed eighty percent (80%) of the compensation payable  
6 at completion of thirty-five (35) years of service; provided, however, for employees retiring on or  
7 after October 1, 2009 who were not eligible to retire as of September 30, 2009 the calculation  
8 shall be based on the average highest five (5) consecutive years of compensation. Any member  
9 who has in excess of thirty-five (35) years on or before June 2, 1985, shall not be entitled to any  
10 refund, and any member with thirty-five (35) years or more on or after June 2, 1985, shall  
11 contribute from July 1, 1985, until his or her retirement. The retirement allowance of any member  
12 whose membership commenced after July 1, 2005 or who had not completed at least ten (10)  
13 years of contributory service as of July 1, 2005, shall, be in an amount equal to the percentage  
14 allowance specified in Schedule B of his or her average highest three (3) consecutive years of  
15 compensation multiplied by the number of years of total service, but in no case to exceed  
16 seventy-five percent (75%) of the compensation payable at the completion of thirty-eight (38)  
17 years of service; provided, however, for employees retiring on or after October 1, 2009 who were  
18 not eligible to retire as of September 30, 2009 the calculation shall be based on the average  
19 highest five (5) consecutive years of compensation.

20 (c) Any member with thirty-eight (38) years or more of service prior to December 31,  
21 1985, shall not be required to make additional contributions. Contributions made between  
22 December 31, 1985, and July 1, 1987, by members with thirty-eight (38) or more years of service  
23 prior to December 31, 1985, shall be refunded by the retirement board to the persons, their heirs,  
24 administrators, or legal representatives.

25 (d) For service prior to July 1, 2012, the retirement allowance of a member shall be  
26 determined in accordance with subsections (a)(1) and (a)(2) above. For service on and after July 1,  
27 2012, a member's retirement allowance shall be equal to one percent (1%) of the member's

19 [retirement percentage allowance on June 30, 2012 or ~~eighty percent \(80%\)~~ seventy-five percent](#)  
20 [\(75%\).](#) Any member who has in excess of thirty-five (35) years on or before July 1, 1987, shall  
21 not be entitled to any refund. Any member with thirty-five (35) years or more on or after July 1,  
22 1987, shall contribute from July 1, 1987, until his or her retirement, provided, however, that any  
23 member with thirty-eight (38) years of service prior to July 1, 1987, shall not be required to  
24 contribute.

25 **36-10-10.4. Effect of deferral and/or reduction of salary.** – (a) If subsequent to January  
26 1, 1991, a member sustains a loss of salary due to a deferral of salary or a reduction in salary in  
27 order to avoid shutdowns, layoffs, or because of a retrenchment of state or local finances, then in  
28 calculating the service retirement allowance of the member, the amount of salary deferred and/or  
29 the amount of the reduction of salary shall not reduce the amount of annual compensation of the  
30 member for the purpose of establishing his or her highest three (3) consecutive years of

2 **36-10-18. Optional benefits.** -- (a) A beneficiary, or, if the beneficiary be an  
3 incompetent, then the beneficiary's spouse or domestic partner or if there is no spouse or domestic  
4 partner, a guardian of the beneficiary's estate, may elect to receive the benefit in a retirement  
5 allowance, payable throughout life, or the beneficiary may then elect to receive the actuarial  
6 equivalent, at that time, of the beneficiary's retirement allowance in a lesser retirement allowance  
7 as determined by actuarial calculation, which shall be payable throughout life with the provision  
8 that:

9 (1) *Option 1.* Upon the beneficiary's death, the beneficiary's lesser retirement allowance  
10 shall be continued throughout the life of and paid to such person having an insurable interest in  
11 the beneficiary's life, as the beneficiary, the beneficiary's spouse or domestic partner, or the  
12 beneficiary's guardian so electing, shall nominate by written designation duly acknowledged and  
13 filed with the retirement board at the time of his or her retirement.

14 (2) *Option 2.* Upon the beneficiary's death, one-half (1/2) of the beneficiary's lesser  
15 retirement allowance shall be continued throughout the life of and paid to such person, having an  
16 insurable interest in the beneficiary's life, as the beneficiary, the beneficiary's spouse or domestic  
17 partner, or the beneficiary's guardian so electing, shall nominate by written designation duly  
18 acknowledged and filed with the retirement board at the time of the beneficiary's retirement.

19 (b)(1) For purposes of any election under this section or section 36-10-19.1, the member,  
20 member's spouse or domestic partner, or guardian, as the case may be, may designate more than  
21 one person to receive benefits after the member's death, provided that the designation shall  
22 specify the portion of the actuarial equivalent of the member's retirement allowance to be paid to  
23 each person, and provided further that the aggregate actuarial value of the portions shall not  
24 exceed the actuarial equivalent of the member's retirement benefit determined:

25 (i) In the case of an election under this section) as of the date of the member's retirement;

27 (ii) In the case of an election under section 36-10-19.1 as of the member's date of death.

28 (2) A member selecting more than one person to receive benefits under this section or  
29 section 36-10-19.1 may only select beneficiaries from among his or her children, adopted  
30 children, step-children, and/or spouse or domestic partner.

31 (c) If prior to July 1, 2012, a member elected an optional form of benefit other than a life  
32 annuity in accordance with paragraph (a) above, the member may elect to change his or her form  
33 of benefit to a life annuity by filing an election with the retirement board on or before June 30,  
34 2013, provided that the member's beneficiary is still alive at the time the election is filed.

1           **36-10-19.1. Optional annuity protection - In service.** -- (a) Upon the death of a  
2 member having: ~~(1) At~~ At least ten (10) years of membership service on or before June 30, 2012;  
3 or (2) For active contributing members on or after July 1, 2012, at least five (5) years of  
4 membership service, the spouse or domestic partner of the member shall have the option to elect  
5 to receive option one as provided in section 36-10-18(a) in lieu of a return of contributions,  
6 provided the spouse or domestic partner is the designated beneficiary of the member's retirement  
7 account. The election shall be based upon the amount of retirement allowance or actuarial  
8 equivalent that may accrue at the date of death of the member.

24           **36-10-33. Penalty for fraudulent claim or statement.** -- Every person who knowingly  
25 or willfully makes, presents, or in anyway procures the making or presentation of any false or  
26 fraudulent affidavit or affirmation concerning any claim for pension or payment thereof, shall, in  
27 every case, forfeit a sum not exceeding ten thousand dollars (\$10,000) ~~one thousand dollars~~  
28 ~~(\$1,000)~~, in addition to the repayment of any and all money received from the retirement system  
29 because of a false or fraudulent claim or statement, with interest, at the rate of twelve percent  
30 (12%) per annum, to be sued and recovered by and in the name of the retirement board of the  
31 retirement system, and when recovered, paid over to and thereupon become a part of the funds of  
32 the retirement system.

33           **36-10-35. Additional benefits payable to retired employees.** -- (a) All state employees  
34 and all beneficiaries of state employees receiving any service retirement or ordinary or accidental

1 disability retirement allowance pursuant to the provisions of this title on or before December 31,  
2 1967, shall receive a cost of living retirement adjustment equal to one and one-half percent  
3 (1.5%) per year of the original retirement allowance, not compounded, for each calendar year the  
4 retirement allowance has been in effect. For the purposes of computation, credit shall be given for  
5 a full calendar year regardless of the effective date of the retirement allowance. This cost of living  
6 adjustment shall be added to the amount of the retirement allowance as of January 1, 1968, and an  
7 additional one and one-half percent (1.5%) shall be added to the original retirement allowance in  
8 each succeeding year during the month of January, and provided further, that this additional cost  
9 of living increase shall be three percent (3%) for the year beginning January 1, 1971, and each  
10 year thereafter, through December 31, 1980. Notwithstanding any of the above provisions, no  
11 employee receiving any service retirement allowance pursuant to the provisions of this title on or  
12 before December 31, 1967, or the employee's beneficiary, shall receive any additional benefit  
13 hereunder in an amount less than two hundred dollars (\$200) per year over the service retirement  
14 allowance where the employee retired prior to January 1, 1958.

15 (b) All state employees and all beneficiaries of state employees retired on or after January  
16 1, 1968, who are receiving any service retirement or ordinary or accidental disability retirement  
17 allowance pursuant to the provisions of this title shall, on the first day of January next following  
18 the third anniversary date of the retirement, receive a cost of living retirement adjustment, in  
19 addition to his or her retirement allowance, in an amount equal to three percent (3%) of the  
20 original retirement allowance. In each succeeding year thereafter through December 31, 1980,  
21 during the month of January, the retirement allowance shall be increased an additional three  
22 percent (3%) of the original retirement allowance, not compounded, to be continued during the  
23 lifetime of the employee or beneficiary. For the purposes of computation, credit shall be given for  
24 a full calendar year regardless of the effective date of the service retirement allowance.

25 (c) Beginning on January 1, 1981, for all state employees and beneficiaries of the state  
26 employees receiving any service retirement and all state employees, and all beneficiaries of state  
27 employees, who have completed at least ten (10) years of contributory service on or before July 1,  
28 2005 pursuant to the provisions of this chapter, and for all state employees, and all beneficiaries  
29 of state employees who receive a disability retirement allowance pursuant to section 36-10-12 –  
30 36-10-15, the cost of living adjustment shall be computed and paid at the rate of three percent  
31 (3%) of the original retirement allowance or the retirement allowance as computed in accordance  
32 with section 36-10-35.1, compounded annually from the year for which the cost of living  
33 adjustment was determined to be payable by the retirement board pursuant to the provisions of  
34 subsection (a) or (b) of this section. Such cost of living adjustments are available to members who

1 retire before October 1, 2009 or are eligible to retire as of September 30, 2009.

2 (2) The provisions of this subsection shall be deemed to apply prospectively only and no  
3 retroactive payment shall be made.

4 (3) The retirement allowance of all state employees and all beneficiaries of state  
5 employees who have not completed at least ten (10) years of contributory service on or before  
6 July 1, 2005 or were not eligible to retire as of September 30, 2009, shall, on the month following  
7 the third anniversary date of retirement, and on the month following the anniversary date of each  
8 succeeding year be adjusted and computed by multiplying the retirement allowance by three  
9 percent (3%) or the percentage of increase in the Consumer Price Index for all Urban Consumers  
10 (CPI-U) as published by the United States Department of Labor Statistics determined as of  
11 September 30 of the prior calendar year, whichever is less; the cost of living adjustment shall be  
12 compounded annually from the year for which the cost of living adjustment was determined  
13 payable by the retirement board; provided, that no adjustment shall cause any retirement  
14 allowance to be decreased from the retirement allowance provided immediately before such  
15 adjustment.

16 (d) For state employees not eligible to retire in accordance with this chapter as of  
17 September 30, 2009 and not eligible upon passage of this article, and for their beneficiaries, the  
18 cost of living adjustment described in subsection (3) above shall only apply to the first thirty-five  
19 thousand dollars (\$35,000) of retirement allowance, indexed annually, and shall commence upon  
20 the third (3rd) anniversary of the date of retirement or when the retiree reaches age sixty-five  
21 (65), whichever is later. The thirty-five thousand dollar (\$35,000) limit shall increase annually by  
22 the percentage increase in the Consumer Price Index for all Urban Consumers (CPI-U) as  
23 published by the United States Department of Labor Statistics determined as of September 30 of  
24 the prior calendar year or three percent (3%), whichever is less. The first thirty-five thousand  
25 dollars (\$35,000) of retirement allowance, as indexed, shall be multiplied by the percentage of  
26 increase in the Consumer Price Index for all Urban Consumers (CPI-U) as published by the  
27 United States Department of Labor Statistics determined as of September 30 of the prior calendar  
28 year or three percent (3%), whichever is less, on the month following the anniversary date of each  
29 succeeding year. For state employees eligible to retire as of September 30, 2009 or eligible upon  
30 passage of this article, and for their beneficiaries, the provisions of this subsection (d) shall not  
31 apply.

32 (e) All legislators and all beneficiaries of legislators who are receiving a retirement  
33 allowance pursuant to the provisions of section 36-10-9.1 for a period of three (3) or more years,  
34 shall, commencing January 1, 1982, receive a cost of living retirement adjustment, in addition to

1 a retirement allowance, in an amount equal to three percent (3%) of the original retirement  
2 allowance. In each succeeding year thereafter during the month of January, the retirement  
3 allowance shall be increased an additional three percent (3%) of the original retirement  
4 allowance, compounded annually, to be continued during the lifetime of the legislator or  
5 beneficiary. For the purposes of computation, credit shall be given for a full calendar year  
6 regardless of the effective date of the service retirement allowance.

7 (f) The provisions of section 45-13-7 – 45-13-10 shall not apply to this section.

8 (g)(1) Notwithstanding the prior paragraphs of this section, and subject to paragraph (g)  
9 (2) below, for all present and former employees, active and retired members, and beneficiaries  
10 receiving any retirement, disability or death allowance or benefit of any kind, the annual benefit  
11 adjustment provided in any calendar year under this section shall be equal to (A) multiplied by  
12 (B) where (A) is equal to the percentage determined by subtracting five and one-half percent  
13 (5.5%) (the “subtrahend”) from the Five-Year Average Investment Return of the retirement  
14 system determined as of the last day of the plan year preceding the calendar year in which the  
15 adjustment is granted, said percentage not to exceed four percent (4%) and not to be less than  
16 zero percent (0%), and (B) is equal to the lesser of the member’s retirement allowance or the first  
17 twenty-five thousand dollars (\$25,000) of retirement allowance, such twenty-five thousand  
18 dollars (\$25,000) amount to be indexed annually in the same percentage as determined under  
19 (g)(1)(A) above. The “Five-Year Average Investment Return” shall mean the average of the  
20 investment returns of the most recent five (5) plan years as determined by the retirement board.  
21 Subject to paragraph (g)(2) below, the benefit adjustment provided by this paragraph shall  
22 commence upon the third (3rd) anniversary of the date of retirement or the date on which the  
23 retiree reaches his or her Social Security retirement age, whichever is later. In the event the  
24 retirement board adjusts the actuarially assumed rate of return for the system, either upward or  
25 downward, the subtrahend shall be adjusted either upward or downward in the same amount.

26 (2) Except as provided in paragraph (g)(3), the benefit adjustments under this section for  
27 any plan year shall be suspended in their entirety unless the GASB Funded Ratio of the  
28 Employees’ Retirement System of Rhode Island, the Judicial Retirement Benefits Trust and the  
29 State Police Retirement Benefits Trust, calculated by the system’s actuary on an aggregate basis,  
30 exceeds eighty percent (80%) in which event the benefit adjustment will be reinstated for all  
31 members for such plan year.

32 In determining whether a funding level under this paragraph (g)(2) has been achieved, the  
33 actuary shall calculate the funding percentage after taking into account the reinstatement of any  
34 current or future benefit adjustment provided under this section. “GASB Funded Ratio” shall

1 mean the ratio of the actuarial value of assets to the actuarial accrued liability.

2 (3) Notwithstanding paragraph (g)(2), in each fifth plan year commencing after June 30,  
3 2012 commencing with the plan year ending June 30, 2017, and subsequently at intervals of five  
4 plan years, a benefit adjustment shall be calculated and made in accordance with paragraph (g)(1)  
5 above until the GASB Funded Ratio of the Employees' Retirement System of Rhode Island, the  
6 Judicial Retirement Benefits Trust and the State Police Retirement Benefits Trust, calculated by  
7 the system's actuary on an aggregate basis, exceeds eighty percent (80%).

8 (4) Notwithstanding any other provision of this chapter, the provisions of this paragraph  
9 (g) of Section 36-10-35 shall become effective July 1, 2012 and shall apply to any benefit  
10 adjustment not granted on or prior to June 30, 2012.

11 **36-10-37. Retirement benefits for certain general state officers.** -- Any person who  
12 has served as governor, lieutenant governor, attorney general, secretary of state, or general  
13 treasurer for a period of twenty (20) consecutive years shall be entitled, upon his or her  
14 resignation or retirement, to receive annually during his or her life a sum equal to three quarters  
15 (3/4) of the salary he or she was receiving at the time of his or her resignation or retirement. This  
16 section shall not apply to any person initially elected as governor, lieutenant governor, attorney  
17 general, secretary of state, or general treasurer on or after July 1, 2012.

18 SECTION 6. Title 36 of the General Laws entitled "PUBLIC OFFICERS AND  
19 EMPLOYEES" is hereby amended by adding thereto the following chapter:

20 CHAPTER 10.2

21 PENSION PROTECTION ACT

22 **36-10.2-1. Short title.** – This chapter shall be known and may be cited as the "Rhode  
23 Island Pension Protection Act".

24 **36-10.2-2. Purpose.** – The purpose of the Rhode Island Pension Protection Act is to  
25 provide current, retired and future public employees financial retirement security by codifying  
26 procedures that will promote the sustainability and longevity of the state's retirement systems.  
27 The act will implement a fair process to be used to facilitate needed changes in times of fiscal  
28 distress.

29 **36-10.2-3. Definitions.** – As used in this chapter, the following terms, unless the context  
30 requires a different interpretation, have the following meanings:

31 (1) "Retirement board" or "board" means the retirement board of the Employees'  
32 Retirement System of the State of Rhode Island as defined in Chapter 36-8.

33 (2) "Actuary" means the actuary selected from time to time and employed by the board in  
34 accordance with Chapter 36-8.

1           (3) “Plan” or “plans” means any plan or plans that are part of the following public  
2 retirement systems: the Employees’ Retirement System of Rhode Island (ERS); the Municipal  
3 Employees’ Retirement System of Rhode Island (MERS); the Rhode Island State Police  
4 Retirement Benefits Trust (SPRBT); and the Rhode Island Judicial Retirement Benefits Trust  
5 (JRBT).

6           (4) “Funded percentage” means the percentage equal to a fraction— the numerator of  
7 which is the actuarial value of the plan’s assets, as determined by the actuary, and the  
8 denominator of which is the accrued liability of the plan, determined by the actuary using  
9 actuarial assumptions approved by the board.

10           **36-10.2-4. Actuarial valuation methodology.** – Actuarial accounting methods used by  
11 the actuary in determining the funded percentage shall be determined by the board in compliance  
12 with all applicable public pension accounting laws, rules and regulations. The actuary or the  
13 board shall not, year to year, change actuarial methods for the sole purpose of achieving a more  
14 favorable funding or fiscal result. Any actuarial assumptions not determined by the board shall  
15 be made by the actuary in good faith and in accordance with accepted actuarial standards.

16           **36-10.2-5. Determination of endangered status.** – A plan is in endangered status for a  
17 plan year if the retirement board determines, in consultation with the plan actuary, that the plan:

18           (i) Has a funded percentage of fifty percent (50%) or less; and (ii) The plan’s funded  
19 percentage has decreased for five (5) consecutive plan years.

20           **36-10.2-6. Annual certification and notice requirements.** – (1) Not later than  
21 November 1<sup>st</sup> of each plan year of a plan, the actuary shall certify to the board and the executive  
22 director of the retirement system whether or not a plan is in endangered status for such a plan  
23 year.

24           (2) In any case in which the actuary certifies that a plan is in endangered status for a plan  
25 year, the executive director of the retirement system shall, not later than thirty (30) business days  
26 following the certification, provide notification of the endangered status to the members,  
27 beneficiaries, the general assembly, the governor, the general treasurer and any local or municipal  
28 employer of a MERS plan determined to be in endangered status.

29           **36-10.2-7. Funding improvement strategy procedure.** – (1) In any case in which a plan  
30 is in endangered status for a plan year, except for a plan year where a plan is already in a funding  
31 improvement period and meeting its scheduled funding targets for the three (3) consecutive prior  
32 plan years, a funding improvement strategy shall be implemented not later than June 30<sup>th</sup>  
33 following the date the plan was certified as being in endangered status under section 36-10.2-6.  
34 The plan actuary shall submit preliminary funding improvement strategies including a default



1 strategy as described in subparagraphs (3) and (4) to the board for review not later than January  
2 1<sup>st</sup> following the date the plan was certified as being in endangered status under section 36-10.2-  
3 6.

4 (2) The funding improvement strategy shall be formulated to achieve, based on  
5 reasonably anticipated experience and reasonable actuarial assumptions, the following  
6 requirements:

7 (a) The plan's funded percentage shall improve in accordance with paragraph (i) or  
8 paragraph (ii), applying the paragraph that produces the greater funded percentage increase for  
9 the plan in a ten (10) year period.

10 (i) As of the close of a ten (10) year funding improvement period, the plan's funded  
11 percentage shall equal or exceed the sum of:

12 (I) The plan's funded percentage as of the beginning of the plan year that the actuary  
13 initially certified the plan as endangered; plus

14 (II) Fifty percent (50%) of the difference between eighty percent (80%) and the plan's  
15 funded percentage under paragraph (I); or

16 (ii) The plan's funded percentage shall improve at the rate of at least one percent (1%)  
17 annually until the plan's funded percentage equals or exceeds eighty percent (80%).

18 (b) In the event that the state or a local municipality, as the employer of a plan,  
19 determines that, based on reasonable actuarial assumptions and upon exhaustion of all reasonable  
20 measures, the plan cannot reasonably be expected to meet the guidelines of subdivisions (i) and  
21 (ii), then the employer's legislative governing body shall provide a report to the retirement board,  
22 no later than March 1<sup>st</sup> following the date the plan was certified as being in endangered status  
23 under section 36-10.2-6, explaining why the plan is not reasonably expected to meet the  
24 guidelines of subdivisions (i) or (ii) and provide a reasonable funding improvement strategy to  
25 emerge from endangered status.

26 (3) Not later than January 1<sup>st</sup> following the date the plan was certified as being in  
27 endangered status under 36-10.2-6, the actuary shall provide to the board, and in the case of  
28 MERS plan shall also provide to the impacted local municipality's legislative governing body, at  
29 least five (5) funding improvement strategies but no more than ten (10) funding improvement  
30 strategies showing revised benefit structures, revised contribution structures, or both, which, if  
31 adopted, may reasonably be expected to enable the plan to meet the applicable requirements  
32 found in subparagraph (2).

33 (4) In addition to any funding improvement strategies provided by the board in  
34 subparagraph (3), the board shall include a default funding improvement strategy ("Default A")

1 that shall show increases in employer and employee contributions under the plan necessary to  
2 achieve the applicable requirements found in subsection (2), assuming no amendments to reduce  
3 future benefit accruals under the plan.

4 (5) Not later than April 1<sup>st</sup> following the date the plan was certified as being in  
5 endangered status under section 36-10.2-6, the board shall submit the “Default A” strategy as  
6 described in subparagraph (4) and one additional funding improvement strategy, as selected by  
7 the board, to the general assembly.

8 (6) Not later than June 30<sup>th</sup> following the date the plan was certified as being in  
9 endangered status under section 36-10.2-6, the general assembly shall select and enact into law  
10 one of the two (2) submitted funding improvement strategies. If no funding improvement strategy  
11 is approved by the general assembly by June 30<sup>th</sup>, the “Default A” strategy as described in  
12 subparagraph (4) shall be enacted into law effective July 1<sup>st</sup> following the date the plan was  
13 certified as being in endangered status under section 36-10.2-6. “Default A” shall remain in  
14 effect until either the actuary certifies under section 36-10.2-6 for a plan year that the plan is no  
15 longer in endangered status or the general assembly selects a funding improvement strategy  
16 consistent with the provisions of this chapter.

17 **36-10.2-8. Funding improvement period.** – (1) The funding improvement period for  
18 any funding improvement strategy adopted pursuant to this chapter shall begin on the first day of  
19 July immediately after the adoption date of the funding improvement strategy.

20 (2) The funding improvement period shall be a ten (10) year period unless the actuary  
21 certifies under section 36-10.2-6 for a plan year that the plan is no longer in endangered status. In  
22 such a case, the funding improvement period shall end as of the close of the preceding plan year.

23 (3) A plan may not be amended during the funding improvement period so as to be  
24 inconsistent with the funding improvement strategy.

25 **36-10.2-9. Transition period.** – Effective for plan years beginning July 1, 2012 any new  
26 legislation enacted contemporaneously with this chapter that is expected to improve the funding  
27 percentage of such a plan to eighty percent (80%) or greater within a reasonable funding  
28 improvement period not to exceed twenty (20) years shall be considered to constitute a funding  
29 improvement strategy. The funding improvement period shall be governed by such enacted  
30 legislation and shall begin July 1, 2012.

31 **36-10.2-10. Severability.** – The holding of any section or sections or parts hereof to be  
32 void, ineffective, or unconstitutional for any cause shall not be deemed to affect any other section  
33 or part hereof.

34 SECTION 7. Title 36 of the General Laws entitled "PUBLIC OFFICERS AND

1 EMPLOYEES" is hereby amended by adding thereto the following chapter:

2 CHAPTER 10.3

3 DEFINED CONTRIBUTION RETIREMENT PLAN

4 **36-10.3-1. Definitions.** – As used in this chapter, the following terms, unless the context  
5 requires a different interpretation, shall have the following meanings:

6 (1) “Compensation” means compensation as defined in section 36-8-1(8).

7 (2) “Employee” means an employee as defined in section 36-8-1(9) effective July 1,  
8 2012.

9 (3) “Employer” means the State of Rhode Island or the local municipality which employs  
10 a member of the Employees Retirement System under chapters 8 through 10 of title 36 or chapter  
11 16 of title 16 (ERS) or the Municipal Employees Retirement System under chapters 21 and 21.2  
12 of title 45 (MERS).

13 (4) “Plan” means the retirement plan established by this chapter.

14 (5) A “public safety member” shall mean a member of MERS who is a municipal fire  
15 fighter or a municipal policeman or policewoman as defined in section 45-21.2-2 who does not  
16 participate in Social Security under the Federal Old Age, Survivors, and Disability income  
17 program.

18 (6) “Regular member” means: (i) An employee who is a member of ERS other than  
19 correctional officers as defined in section 36-10-9.2; or (ii) A member of MERS other than a  
20 public safety member.

21 (7) The “retirement board” or “board” shall mean the retirement board of the Employees  
22 Retirement System of Rhode Island as defined in Chapter 36-8. The retirement board shall be the  
23 plan administrator and plan trustee and shall administer the plan in accordance with section 36-8-  
24 4.1.

25 (8) “State investment commission” or “commission” means the state investment  
26 commission as defined in section 35-10-1.

27 (9) “Supplemental employer” includes any employer that provides supplemental  
28 contributions to the defined contribution retirement plan as provided in section 36-10.3-3.

29 (10) “Supplemental member” is defined in section 36-10.3-3.

30 **36-10.3-2. Establishment.** – (1) A defined contribution retirement plan is established for  
31 members of the of the Employees’ Retirement System of Rhode Island (ERS) and the Municipal  
32 Employees’ Retirement System of Rhode Island (MERS).

33 (2) The defined contribution retirement plan is a plan in which retirement savings are  
34 accumulated in an individual account for the exclusive benefit of the member or beneficiaries.

1 The plan is established effective July 1, 2012, at which time contributions by employers and  
2 members begin.

3 (3) The defined contribution plan established by this chapter is intended to qualify under  
4 26 U.S.C. 401(a), 414(d), and 414(k) (Internal Revenue Code) in effect from time to time as a  
5 qualified governmental retirement plan established and maintained by the state for its employees,  
6 for the employees of participating political subdivisions, public corporations, and public  
7 organizations of the state, and for the employees of other employers whose participation is  
8 authorized by this chapter.

9 (4) (a) *Exclusive benefit.* All funds of the plan shall be held in one or more trusts, in one  
10 or more custodial accounts treated as trusts in accordance with section 401(f) of the Internal  
11 Revenue Code, or in a combination thereof. Under any trust or custodial account, it shall be  
12 impossible at any time prior to the satisfaction of all liabilities with respect to employees and their  
13 beneficiaries, for any part of the corpus or income to be used for, or diverted to, purposes other  
14 than the payment of retirement savings benefits to employees and their beneficiaries. However,  
15 this requirement shall not prohibit: (i) The return of a contribution within six (6) months after the  
16 plan administrator determines that the contribution was made by a mistake of fact; or (ii) The  
17 payment of expenses of the plan in accordance with applicable law.

18 (b) *Vesting on plan termination.* In the event of the termination (within the meaning of  
19 the Internal Revenue Code) of the plan, the amounts credited to members' accounts shall become  
20 fully and immediately vested.

21 (c) *Forfeitures.* Amounts forfeited by an employee shall not be applied to increase the  
22 benefits of any other employee, and shall reduce employer contributions as shall be set forth in  
23 the plan document.

24 (d) *Required distributions.* In no event shall a member receive contributions in any year  
25 that exceed the limitation set forth in section 415(c) of the Internal Revenue Code.

26 (e) *Limitation on benefits.* Benefits shall not be payable to the extent that they exceed the  
27 limitations imposed by section 415 of the Internal Revenue Code, 26 U.S.C. section 415, as  
28 adjusted from time to time pursuant to section 415(d) of the Internal Revenue Code. In no event  
29 shall the member receive a retirement benefit in any year that exceeds the limitations set forth in  
30 section 415(b) of the Internal Revenue Code.

31 (f) *Limitation on compensation.* Benefits and contributions shall not be computed with  
32 reference to any compensation that exceeds the maximum dollar amount permitted by section  
33 401(a)(17) of the Internal Revenue Code as adjusted for increases in the cost-of-living.

34 (5) The state investment commission shall select an appropriate third-party administrator

1 for the plan and shall adopt such plan, trust and/or custodial documents, with such features and  
2 attributes as the commission determines necessary or advisable in its discretion to effectuate the  
3 provisions of this chapter in accordance with the following:

4 (a) The commission shall select a firm or company to provide retirement plan investment,  
5 plan administration, and communication services to employees who participate in the defined  
6 contribution plan. The plan shall provide for appropriate long-term retirement oriented  
7 investments, and shall include annuity or annuity-like options as determined by the commission.  
8 In determining the firm or the company to provide these plan services, the commission shall  
9 consider all of the following:

10 (i) The financial stability of the company or firm.

11 (ii) The cost of the investments, plan administration, and services to the members.

12 (iii) The experience of the company or firm in providing defined contribution retirement  
13 plans.

14 (iv) The experience of the company or firm in providing plan education, counseling, and  
15 advice to participants of defined contribution plans.

16 (v) Any criminal convictions, securities or antitrust law violations, material civil or  
17 regulatory fines or judgments against the company or firm which the company or firm shall be  
18 required to disclose to the commission as part of the selection process.

19 (b) The defined contribution retirement plan shall include an option that any  
20 disbursement of the accumulated assets in a participant's defined contribution plan account or  
21 accounts may be made as a life annuity. The defined contribution retirement plan may offer  
22 participants a menu of lifetime annuity options, either fixed or variable, or a combination of both.

23 (c) Accumulations in the defined contribution plan are intended to be for retirement  
24 purposes and loans or hardship distribution options permitted under the plan, if any, shall be  
25 structured for the primary purpose of this plan to support members in their retirement.

26 (d) The plan shall provide education, counseling and objective employee-specific plan  
27 advice to employees.

28 (e) The plan shall include a limited number of investment options which shall include  
29 either: (i) Investment portfolio options that are constructed to reflect different risk profiles such as  
30 conservative, moderate and aggressive; and/or (ii) Options constructed to reflect different risk  
31 profiles that automatically reallocate and rebalance contributions as an employee ages.

32 **36-10.3-3. Supplemental participation for local public employers.** – Employers that  
33 include job positions, other than public safety positions, that do not participate in Social Security  
34 under the Federal Old Age, Survivors and Disability Income program, but which currently

1 contribute to ERS or MERS on behalf of such positions, shall make supplemental contributions to  
2 the plan on behalf of regular members in such positions as a supplemental employer in  
3 accordance with subsection 36-10.3-6(a). A supplemental employer may request a different level  
4 of supplemental contributions in accordance with subsection 36-10.3-6(b) by an ordinance or  
5 resolution of its governing body. A regular member in such positions shall be referred to as a  
6 “supplemental member” in section 36-10.3-6.

7 **36-10.3-4. Member contributions.** – (1) Each regular member shall contribute to the  
8 member's individual account in the plan an amount equal to five percent (5%) of the member's  
9 compensation from July 1 to the following June 30.

10 (2) Each public safety member not participating in Social Security under the Federal Old  
11 Age, Survivors and Disability Income program, shall contribute to the member's individual  
12 account an amount equal to three percent (3%) of the member's compensation from July 1 to the  
13 following June 30.

14 (3) Contributions by supplemental members shall be governed by section 36-10.3-6.

15 (4) The employer shall deduct the contribution from the member's compensation at the  
16 end of each payroll period, and the contribution shall be credited by the plan to the member's  
17 individual account. The contributions shall be deducted from the member's compensation before  
18 the computation of applicable federal taxes and shall be treated as employer contributions under  
19 26 U.S.C. 414(h)(2). A member shall not have the option of making the payroll deduction directly  
20 in cash instead of having the contribution picked up by the employer.

21 (5) Contributions of employees shall be made by payroll deductions. Every member shall  
22 be considered to consent to payroll deductions. It is of no consequence that a payroll deduction  
23 may cause the compensation paid in cash to an employee to be reduced below the minimum  
24 required by law. Payment of an employee's compensation, less payroll deductions, is a full and  
25 complete discharge and satisfaction of all claims and demands by the employee relating to  
26 remuneration of services during the period covered by the payment, except with respect to the  
27 benefits provided under the plan.

28 (6) Additional voluntary member contributions may be permitted in accordance with this  
29 section in such manner as determined in the discretion of the commission.

30 **36-10.3-5. Employer contributions.** – (1) An employer shall contribute to each regular  
31 member's individual account an amount equal to one percent (1%) of the member's  
32 compensation at the end of each payroll period from July 1 to the following June 30.

33 (2) An employer shall contribute to the individual account of each public safety member,  
34 not participating in Social Security under the Federal Old Age, Survivors and Disability Income

1 program, an amount equal to three percent (3%) of the member's compensation from July 1 to the  
2 following June 30.

3 (3) Contributions by supplemental employers shall be governed by section 36-10.3-6.

4 **36-10.3-6. Supplemental employer and member contributions.** – (a) A supplemental  
5 member shall contribute to the member's individual account an amount equal to two percent (2%)  
6 of the member's compensation from July 1 to the following June 30 in addition to the  
7 requirements of section 36-10.3-4. For such members, a supplemental employer shall contribute  
8 to the member's individual account an amount equal to two percent (2%) of the member's  
9 compensation from July 1 to the following June 30 in addition to the requirements of section 36-  
10 10.3-5.

11 (b) A supplemental employer may request a different level of supplemental member  
12 contributions and supplemental employer contributions subject to the approval of the state  
13 investment commission.

14 **36-10.3-7. Vesting of contributions.** – (1) The total amount contributed by the member,  
15 including associated investment gains and losses, shall immediately vest in the member and is  
16 non-forfeitable.

17 (2) The total amount contributed by the employer, including associated investment gains  
18 and losses, vests with the member and is nonforfeitable upon completion of three (3) years of  
19 contributory service. Service credited under ERS or MERS prior to the effective date of this plan  
20 shall be credited to members for vesting purposes.

21 **36-10.3-8. Investments.** – The state investment commission shall determine from time to  
22 time the investment options available under the plan and a member may direct his or her account  
23 among the investment options offered under the plan pursuant to the plan documents.

24 **36-10.3-9. Distributions.** – The plan documents shall specify the distribution options  
25 available under the plan which shall include a lump sum and rollover distribution option, and may  
26 include such installment, annuity, hardship, loan or death benefit options as determined by the  
27 state investment commission in its discretion subject to section 36-10.3-2(5).

28 **36-10.3-10. Rollover contributions and distributions.** – (1) An employee entering the  
29 plan may elect, at the time and in the manner prescribed by the administrator, to have all or part  
30 of a direct rollover distribution from an eligible retirement plan owned by the member paid  
31 directly into the member's individual account.

32 (2) Rollover contributions do not count as a purchase of membership service for the  
33 purpose of determining years of service.

34 (3) A distributee may elect, at the time and in the manner prescribed by the administrator,

1 to have all or part of an eligible rollover distribution paid directly to an eligible retirement plan  
2 specified by the distributee in the direct rollover.

3 (4) In this section:

4 (a) "Direct rollover" means the payment of an eligible rollover distribution by the plan to  
5 an eligible retirement plan specified by a distributee who is eligible to elect a direct rollover;

6 (b) "Distributee" means a member, or a beneficiary who is the surviving spouse or  
7 domestic partner of the member, or an alternate payee;

8 (c) "Eligible retirement plan" means:

9 (i) An individual retirement account described in 26 U.S.C. 408(d)(3)(A);

10 (ii) An annuity plan described in 26 U.S.C. 403(a);

11 (iii) A qualified trust described in 26 U.S.C. 401(a);

12 (iv) An annuity plan described in 26 U.S.C. 403(b);

13 (v) A governmental plan described in 26 U.S.C. 457(b);

14 (vi) An individual retirement annuity defined in 26 U.S.C. 408(b); or

15 (vii) On or after January 1, 2008, a Roth IRA described in 26 U.S.C. 408A;

16 (d) "Eligible rollover distribution" means a distribution of all or part of a total account to  
17 a distributee, except for:

18 (i) A distribution that is one of a series of substantially equal installments payable not less  
19 frequently than annually over the life expectancy of the distributee or the joint and last survivor  
20 life expectancy of the distributee and the distributee's designated beneficiary, as defined in 26  
21 U.S.C. 401(a)(9);

22 (ii) A distribution that is one of a series of substantially equal installments payable not  
23 less frequently than annually over a specified period of ten (10) years or more;

24 (iii) A distribution that is required under 26 U.S.C. 401(a)(9);

25 (iv) The portion of any distribution that is not includable in gross income; however, a  
26 portion under this paragraph may be transferred only to an individual retirement account or  
27 annuity described in 26 U.S.C. 408(a) or (b), to a qualified plan described in 26 U.S.C. 401(a) or  
28 403(a), or to an annuity contract described in 26 U.S.C. 403(b), that agrees to separately account  
29 for amounts transferred, including separately accounting for the portion of the distribution that is  
30 includable in gross income and the portion of the distribution that is not includable in gross  
31 income; and

32 (v) Other distributions that are reasonably expected to total less than two hundred dollars  
33 (\$200) during a year.

34 **36-10.3-11. Annual report and statement.** – The retirement board shall submit to the



1 governor, the general treasurer, the auditor general, the speaker of the house of representatives  
2 and the president of the senate, on or before the first day of December of each fiscal year, an  
3 annual report including a financial statement of the plan for the fiscal year of the state next  
4 preceding said date. The retirement board shall cause to be published for distribution among the  
5 members of the system a financial statement summarizing the results of operations for the fiscal  
6 year.

7 **36-10.3-12. Severability.** – The holding of any section or sections or parts hereof to be  
8 void, ineffective, or unconstitutional for any cause shall not be deemed to affect any other section  
9 or part hereof.

10 SECTION 8. Sections 16-16-1, 16-16-5, 16-16-6.1, 16-16-6.2, 16-16-6.4, 16-16-7.2, 16-  
11 16-8, 16-16-12, 16-16-13, 16-16-22, 16-16-22.1 and 16-16-40 of the General Laws in Chapter 16-  
12 16 entitled "Teachers' Retirement" are hereby amended to read as follows:

13 **16-16-1. Definitions.** – (a) The following words and phrases used in this chapter, unless a  
14 different meaning is plainly required by the context, have the following meanings:

15 (1) "Active member" means any teacher as defined in this section for whom the  
16 retirement system is currently receiving regular contributions pursuant to section 16-16-22 and  
17 16-16-22.1.

18 Except as otherwise provided in this section, the words and phrases used in this chapter,  
19 so far as applicable, have the same meanings as they have in chapters 8 to 10 of title 36.

20 (2) "Beneficiary" means any person in receipt of annuity, benefit, or retirement allowance  
21 from the retirement system as provided in this chapter.

22 (3) "Child" includes a stepchild of a deceased member who has been a stepchild for at

25 (4) "Former spouse divorced" means a person divorced from a deceased member, but  
26 only if the person meets one of the following conditions:

27 (i) Is the mother or father of the deceased member's child(ren);

28 (ii) Legally adopted the deceased member's child(ren) while married to the deceased  
29 member and while the child(ren) was under the age of eighteen (18) years; or

30 (iii) Was married to the deceased member at the time both of them legally adopted a  
31 child(ren) under the age of eighteen (18) years.

32 (5) "Member" means any person included in the membership of the retirement system  
33 under the provisions of this chapter.

34 (6) "Prior service" means service as a teacher rendered prior to the first day of July, 1949,

1 certified on his or her prior service certificate and allowable as prior service under the provisions  
2 of this chapter.

3 (7) "Retired teacher" means any teacher who retired prior to July 1, 1949, pursuant to the  
4 provisions of G.L. 1938, ch. 195, as amended, and who on June 30, 1949, was in receipt of a  
5 pension under the provisions of that chapter.

6 (8) "Retirement system" and "system" means the employees' retirement system of the  
7 State of Rhode Island created by chapter 8 of title 36, and "retirement board" means the board  
8 established under that chapter.

9 (9) "Salary" or "compensation" includes any and all salary paid for teaching services  
10 regardless of whether any part of the salary or compensation is derived from any state or federal  
11 grant or appropriation for teachers' salaries, as the term is defined in section 36-8-1~~(7)~~(8).  
12 "Average compensation" shall be defined in accordance with section 36-8-1(5)(a).

13 (10) "Service" means service as a teacher as described in subdivision (12) of this section.  
14 Periods of employment as teacher, principal, assistant principal, supervisor, superintendent, or  
15 assistant superintendent shall be combined in computing periods of service and employment.

16 (11) "Spouse" means the surviving person who was married to a deceased member, but  
17 only if the surviving person meets one of the following conditions:

18 (i) Was married to the deceased member for not less than one year immediately prior to  
19 the date on which the member died;

20 (ii) Is the mother or father of the deceased member's child(ren);

21 (iii) Legally adopted the deceased member's child(ren) while married to the deceased  
22 member and while the child(ren) was under the age of eighteen (18) years; or

23 (iv) Was married to the deceased member at the time both of them legally adopted a  
24 child(ren) under the age of eighteen (18) years.

25 (12) "Teacher" means a person required to hold a certificate of qualification issued by or  
26 under the authority of the board of regents for elementary and secondary education and who is  
27 engaged in teaching as his or her principal occupation and is regularly employed as a teacher in  
28 the public schools of any city or town in the state, or any formalized, commissioner approved,  
29 cooperative service arrangement. The term includes a person employed as a teacher, supervisor,  
30 principal, assistant principal, superintendent, or assistant superintendent of schools, director,  
31 assistant director, coordinator, consultant, dean, assistant dean, educational administrator, nurse  
32 teacher, and attendance officer or any person who has worked in the field of education or is  
33 working in the field of education that holds a teaching or administrative certificate. ~~and any~~  
34 ~~teacher who serves during a school year at least three quarters (3/4) of the number of days that the~~

1 ~~public schools are required by law to be in session during the year.~~ In determining the number of  
2 days served by a teacher the total number of days served in any public school of any city or town  
3 in the state may be combined for any one school year. The term also includes a school business  
4 administrator whether or not the administrator holds a teaching or administrative certificate, and  
5 also includes occupational therapists and physical therapists licensed by the department of health  
6 and employed by a school committee in the state, or by any formalized, commissioner approved,  
7 cooperative service arrangement

8 (13) "Teaching" includes teaching, supervising, and superintending or assistant  
9 superintending of schools.

10 (14) "Total service" means prior service as defined in subdivision (6) of this section, plus  
11 service rendered as a member of the system on or after the first day of July, 1949.

12 (15) For purposes of this chapter, "domestic partner" shall be defined as a person who,  
13 prior to the decedent's death, was in an exclusive, intimate and committed relationship with the  
14 decedent, and who certifies by affidavit that their relationship met the following qualifications:

15 (i) Both partners were at least eighteen (18) years of age and were mentally competent to  
16 contract;

17 (ii) Neither partner was married to anyone else;

18 (iii) Partners were not related by blood to a degree which would prohibit marriage in the  
19 State of Rhode Island;

20 (iv) Partners resided together and had resided together for at least one year at the time of  
21 death; and

22 (v) Partners were financially interdependent as evidenced by at least two (2) of the  
23 following:

24 (A) Domestic partnership agreement or relationship contract;

25 (B) Joint mortgage or joint ownership of primary residence;

26 (C) Two (2) of: (I) joint ownership of motor vehicle; (II) joint checking account; (III)  
27 joint credit account; (IV) joint lease; and/or

28 (D) The domestic partner had been designated as a beneficiary for the decedent's will,  
29 retirement contract or life insurance.

30 (b) The masculine pronoun wherever used shall also include the feminine pronoun.

31 (c) Any term not specifically defined in this chapter and specifically defined in chapters  
32 36-8 through 36-10 shall have the same definition as set forth in chapters 36-8 through 36-10.

33 **16-16-5. Service creditable.** – (a) In calculating "service", "prior service", or "total  
34 service" as defined in section 16-16-1, every teacher shall be given credit for a year of service for

1 each year in which he or she shall have served as a teacher; provided, that any teacher who  
2 through illness or leave of absence without pay does not serve a full school year may receive  
3 credit for a full school year of service by paying the full actuarial cost as defined in section 36-8-  
4 1(9). Credit for leaves of absence shall be limited, in the aggregate, during the total service of a  
5 teacher to a period of four (4) years; provided, however, every teacher who had been required to  
6 resign for maternity reasons may receive credit for maternity reasons by making contribution to  
7 the system upon her return to teaching the amount she would have contributed to the retirement  
8 system, with regular interest, based upon her expected compensation but for her absence due to  
9 maternity reasons.

10 (b) The retirement board shall fix and determine the time when and the conditions under  
11 which the payments shall be made.

12 (c) Any teacher who serves or who has served during a school year ~~at least three quarters~~  
13 ~~(3/4) of~~ the number of days that the public schools are required by law to be in session during the  
14 year shall be given credit for a year of service for that year. In determining the number of days  
15 served by a substitute teacher the total number of days served in any public school of any city or  
16 town in the state may be combined for any one school year. Any teacher shall be entitled to “prior  
17 service” credit for service prior to July 1, 1949, provided the teacher shall have been in service  
18 during the school year 1949-1950. The teacher shall be entitled to service credit for any year  
19 subsequent to July 1, 1949 in accordance with this chapter, by making contribution to the  
20 retirement system of the full actuarial cost for any such service credit. ~~amount he or she would~~  
21 ~~have contributed to the retirement system had he or she been a member, plus regular interest~~  
22 ~~compounded annually to date of payment, payable at a time or in any manner that may be~~  
23 ~~provided by the rules of the retirement board.~~

24 (d) Any teacher employed in at least a half (1/2) program including a job share program,  
25 or working at least half the number of days that the public schools are required to be in session,  
26 shall remain a contributing member and shall receive credit for that ~~part-time~~ part-time service  
27 on a proportional basis. The purchase of any remaining program or job share time in which the  
28 teacher did not work shall not be permitted.

29 (e) In computing service or in computing compensation, the retirement board shall credit  
30 no more than one year of service on account of all service in one calendar year.

31 (f) Notwithstanding any other section of law, no member of the retirement system shall  
32 be permitted to purchase service credit for any portion of a year for which he or she is already  
33 receiving service credit in this retirement system.

34 **16-16-6.1. Credit for service outside state.** – (a) In determining the creditable service of

1 any teacher employed in any city or town for the purpose of retirement, there may be added to,  
2 and included in, total service as defined in this chapter not more than five (5) years of service as a  
3 teacher in the public school outside this state; provided, however, this service shall not be counted  
4 as creditable service unless the member shall pay into the retirement system a contribution equal  
5 to the full actuarial value of each year of credit for which application is made based upon the  
6 teacher's compensation at the time he or she makes application to purchase credit for each year of  
7 service for which he or she claims credit.

8 (b) Credit for service outside the state [which is purchased under paragraph \(a\) above](#) may  
9 also be used for retirement purposes under the provisions of subsection (a) for teachers who retire  
10 on ordinary disability under ~~section 36-10-13~~ [section 16-16-14](#) provided these teachers have at  
11 least ten (10) years creditable service within the state.

12 (c) The term "outside this state" means service in any state college, university, school, or  
13 public school in any other state of the United States, or in any territory or possession of the  
14 United States, including the Philippine Islands, or in any school under the jurisdiction of the  
15 United States government.

16 (d) The retirement board shall fix and determine by rules and regulations the time when  
17 and the conditions under which payments shall be made.

18 **16-16-6.2. Service credit for appropriate work experience – Contributions.** – (a) In  
19 determining the creditable service of any vocational education teacher employed in any city or  
20 town or by the state for the purpose of retirement or a service retirement allowance (not including  
21 a deferred retirement allowance), there may be added to, and included in, total service as defined  
22 in this chapter not more than five (5) years of "appropriate work experience" pursuant to section  
23 16-60-4(9)(ii). This service shall not be counted as creditable service unless the member shall pay  
24 into the retirement system a contribution equal to the full actuarial costs for each year of service  
25 for which he or she claims credit.

26 (b) Credit for "appropriate work experience" [which is purchased under paragraph \(a\)](#)  
27 [above](#) may also be used for retirement purposes under the provisions of subsection (a) for  
28 teachers who retire on ordinary disability under ~~section 36-10-13~~ [section 16-16-14](#), provided those  
29 teachers have at least ten (10) years' creditable service.

30 (c) The term "appropriate work experience" means service in any industry, business, or  
31 other appropriate enterprise for which certification credit has been given pursuant to the  
32 "standards and qualifications for certification of teachers" as provided in section 16-60-4(9)(ii).

33 **16-16-6.4. Service credit for appropriate work experience – Certified nurse teachers**  
34 **– Contributions.** – (a) In determining the creditable service of any certified nurse teacher

1 employed by the state or by any city or town for the purpose of retirement or a service retirement  
2 allowance (not including a deferred retirement allowance), there may be added to, and included  
3 in, total service as defined in this chapter not more than four (4) years of "appropriate work  
4 experience." The service shall not be counted as creditable service unless the member shall pay  
5 into the retirement system a contribution equal to the full actuarial costs for each year of the  
6 service for which the member claims credit.

7 (b) Credit for "appropriate work experience" [which is purchased under paragraph \(a\)](#)  
8 [above](#) may also be used for retirement purposes under the provisions of subsection (a) for  
9 certified nurse teachers who retire on ordinary disability under section 36-10-13 [or section 16-16-](#)  
10 [14](#), provided the certified nurse teachers have at least ten (10) years' creditable service.

11 (c) The term "appropriate work experience" for the purposes of a certified nurse teacher  
12 means service in any industry, business, or other appropriate enterprise where a member has  
13 worked as a registered nurse and for which no credit for the purposes of retirement has been  
14 granted for either teaching in a school of nursing or for any other appropriate work experience;  
15 provided, however, that no member shall be allowed credit for more than a total of four (4) years  
16 of service credit.

17 **16-16-7.2. Peace corps, teacher corps, and volunteers in service to America – Credit.**

18 = (a) Any active teacher who served in the peace corps, teacher corps, or in volunteers in service  
19 to America may purchase credit for that service, up to a maximum of four (4) years. Any teacher  
20 on an official leave of absence for illness or injury shall be eligible to purchase the credits while  
21 on the leave of absence.

22 (b) The cost to purchase these credits shall be the full actuarial cost as defined in section  
23 36-8-1~~(9)~~[\(10\)](#).

24 **16-16-8. Credit for service as a state or municipal employee.** – Any member who shall

25 have rendered service as a state employee as defined by the provisions of chapter 17 of this title  
26 and chapters 8 – 10 of title 36 or who shall have rendered service as an employee of a  
27 participating municipality, as defined by chapter 21 of title 45, shall be entitled to credit for his or  
28 her service for the various purposes of this system, provided the member shall have been a  
29 contributing member for that period. All contributions made by the member shall be transferred  
30 into this system for the periods of service and the retirement system shall calculate the full  
31 actuarial value of the accrued benefit with the former employer. If the full actuarial value of the  
32 accrued benefit with the former employer is greater than the total employee contributions  
33 transferred, the retirement system shall also transfer the difference between full actuarial value of  
34 the accrued benefit with the former employer and the employee's contributions from the account

1 of the former employer to the account of the current employer. In any case in which a member  
2 shall have received a refund or refunds of contributions made to the system, the allowance of the  
3 credit for service shall be conditioned upon the repayment of the full actuarial cost as defined in  
4 section 36-8-1~~(9)~~(10). Any service as defined in this section for which no contributions were  
5 made may be granted provided the member pays to the retirement system the full actuarial cost as  
6 defined in section 36-8-1~~(9)~~(10). The retirement board shall fix and determine the rules and  
7 regulations needed to govern the provisions of this section.

8 **16-16-12. Procedure for service retirement.** – Retirement of a member on a service  
9 retirement allowance shall be made by the retirement board as follows:

10 (a) Any member may retire upon his or her written application to the retirement board as  
11 of the first day of the calendar month in which the application was filed, provided the member  
12 was separated from service prior to filing the application, and further provided however, that if  
13 separation from service occurs during the month in which the application is filed, the effective  
14 date shall be the first day following the separation from service, and provided further that the  
15 member on retirement date has attained the age of sixty (60) years and has completed at least ten  
16 (10) years of contributory service on or before July 1, 2005, or regardless of age has completed  
17 twenty-eight (28) years of total service and has completed at least ten (10) years of contributory  
18 service on or before July 1, 2005, and who retire before October 1, 2009 or are eligible to retire as  
19 of September 30, 2009.

20 (ii) For teachers who become eligible to retire on or after October 1, 2009 and prior to  
21 July 1, 2012, benefits are available to teachers who have attained the age of sixty-two (62) and  
22 completed at least ten (10) years of contributory service. For teachers in service as of October 1,  
23 2009 who were not eligible to retire as of September 30, 2009 but became eligible to retire prior  
24 to July 1, 2012, the minimum retirement age of sixty-two (62) will be adjusted downward in  
25 proportion to the amount of service the member has earned as of September 30, 2009. The  
26 proportional formula shall work as follows:

27 (A) The formula shall determine the first age of retirement eligibility under the laws in  
28 effect on September 30, 2009 which shall then be subtracted from the minimum retirement age of  
29 sixty-two (62).

30 (B) The formula shall then take the teacher's total service credit as of September 30, 2009  
31 as the numerator and the years of service credit determined under (A) as the denominator.

32 (C) The fraction determined in (B) shall then be multiplied by the age difference in (1) to  
33 apply a reduction in years from age sixty-two (62).

34 (b) Any member, who has not completed at least ten (10) years of contributory service on



1 or before July 1, 2005, may retire upon his or her written application to the retirement board as of  
2 the first day of the calendar month in which the application was filed; provided, the member was  
3 separated from service prior thereto; and further provided, however, that if separation from  
4 service occurs during the month in which application is filed, the effective date shall be the first  
5 day following that separation from service; provided, the member on his or her retirement date  
6 had attained the age of fifty-nine (59) and had completed at least twenty-nine (29) years of total  
7 service; or provided, that the member on his or her retirement date had attained the age of sixty-  
8 five (65) and had completed at least ten (10) years of contributory service; or provided, that the  
9 member on his or her retirement date had attained the age of fifty-five (55) and had completed  
10 twenty (20) years of total service and provided, that the retirement allowance, as determined  
11 according to the formula in section 16-16-13 is reduced actuarially for each month that the age of  
12 the member is less than sixty-five (65) years and who retire before October 1, 2009 or are eligible  
13 to retire as of September 30, 2009.

14 (ii) For teachers who become eligible to retire on or after October 1, 2009 and prior to  
15 July 1, 2012, benefits are available to teachers who have attained the age of sixty-two (62) and  
16 have completed at least twenty-nine (29) years of total service or have attained the age of sixty-  
17 five (65) and completed at least ten (10) years of contributory service. For teachers in service as  
18 of October 1, 2009 who were not eligible to retire as of September 30, 2009 but become eligible  
19 to retire prior to July 1, 2012, who have a minimum retirement age of sixty-two (62), the  
20 retirement age will be adjusted downward in proportion to the amount of service the member has  
21 earned as of September 30, 2009. The proportional formula shall work as follows:

22 (A) The formula shall determine the first age of retirement eligibility under the laws in  
23 effect on September 30, 2009 which shall then be subtracted from the minimum retirement age of  
24 sixty-two (62).

25 (B) The formula shall then take the teacher's total service credit as of September 30, 2009  
26 as the numerator and the years of service credit determined under (A) as the denominator.

27 (C) The fraction determined in (B) shall then be multiplied by the age difference  
28 determined in (A) to apply a reduction in years from age sixty-two (62).

29 (c) Effective July 1, 2012, the following shall apply to all teachers not eligible to retire  
30 prior to July 1, 2012:

31 (i) A teacher with contributory service on or after July 1, 2012, shall be eligible to retire  
32 upon the completion of at least five (5) years of contributory service and attainment of the  
33 teacher's Social Security retirement age.

34 (ii) For teachers with five (5) or more years of contributory service as of June 30, 2012,



1 with contributory service on and after July 1, 2012, who have a retirement age of Social Security  
2 Retirement Age, the retirement age will be adjusted downward in proportion to the amount of  
3 service the teacher has earned as of June 30, 2012, but in no event shall a teacher's retirement age  
4 under this subparagraph (ii) be prior to the attainment of age fifty-nine (59) or prior to the  
5 teacher's retirement age determined under the laws in effect on June 30, 2012. The proportional  
6 formula shall work as follows:

7 (1) The formula shall determine the first age of retirement eligibility under the laws in  
8 effect on June 30, 2012 which shall then be subtracted from Social Security retirement age;

9 (2) The formula shall then take the teacher's total service credit as of June 30, 2012 as the  
10 numerator and the projected service at retirement age in effect on June 30, 2012 as the  
11 denominator;

12 (3) The fraction determined in (2) shall then be multiplied by the age difference  
13 determined in (1) to apply a reduction in years from Social Security retirement age.

14 (iii) A teacher who has completed twenty (20) or more years of total service and who has  
15 attained an age within five (5) years of the eligible retirement age under subdivisions (c)(i) or  
16 (c)(ii) above, may elect to retire provided that the retirement allowance shall be reduced  
17 actuarially for each month that the age of the teacher is less than the eligible retirement age under  
18 subdivisions (c)(i) or (c)(ii) above.

19 (iv) Notwithstanding any other provisions of this section, a teacher who has completed  
20 ten (10) or more years of contributory service as of June 30, 2012, may elect to retire at his or her  
21 eligible retirement date as determined under subsections (a) and (b) above provided that a teacher  
22 making an election under this paragraph shall receive the teacher's retirement benefit determined  
23 and calculated based on the teacher's service and average compensation as of June 30, 2012.  
24 This provision shall be interpreted and administered in a manner to protect a teacher's accrued  
25 benefit on June 30, 2012.

26 ~~(e) Any member also paying into the retirement system under the provisions of chapter 9~~  
27 ~~of title 36 shall not be disqualified from receiving benefits provided by that chapter and the~~  
28 ~~provisions of this chapter simultaneously.~~

29 (d) Except as specifically provided in section 36-10-9.1, 36-10-12 through 36-10-15, and  
30 45-21-19 through 45-21-22, no member shall be eligible for pension benefits under this chapter  
31 unless

32 (i) ~~the~~ The member shall have been a contributing member of the employees' retirement  
33 system for at least ten (10) years; or

34 (ii) For teachers in active contributory service on or after July 1, 2012, the teacher shall

1 have been a contributing member of the employees' retirement system for at least five (5) years.

2 (2) Provided, however, a person who has ten (10) years service credit shall be vested;  
3 provided that for teachers in active contributory service on or after July 1, 2012, a teacher who  
4 has five years of contributory service shall be vested.

5 (3) Furthermore, any past service credits purchased in accordance with section 36-9-38  
6 shall be counted towards vesting.

7 (4) Any person who becomes a member of the employees' retirement system pursuant to  
8 section 45-21-8 shall be considered a contributing member for the purpose of chapter 21 of title  
9 45 and this chapter.

10 (5) Notwithstanding any other provision of law, no more than five (5) years of service  
11 credit may be purchased by a member of the system. The five (5) year limit shall not apply to any  
12 purchases made prior to January 1, 1995. A member who has purchased more than five (5) years  
13 of service credit before January 1, 1995, shall be permitted to apply the purchases towards the  
14 member's service retirement. However, no further purchase will be permitted. ~~Repayment, in~~  
15 ~~accordance with applicable law and regulation, of any contribution previously withdrawn from~~  
16 ~~the system shall not be deemed a purchase of service credit.~~

17 (6) Notwithstanding any other provision of law, effective July 1, 2012, except for  
18 purchases under sections 16-16-7.1, 36-5-3, 36-9-31, 36-10-10.4, and 45-21-53:

19 (i) For service purchases for time periods prior to a teacher's initial date of hire, the  
20 purchase must be made within three (3) years of the teacher's initial date of hire; and

21 (ii) For service purchases for time periods for official periods of leave as authorized by  
22 law, the purchase must be made within three (3) years of the time the official leave was  
23 concluded by the teacher. Notwithstanding paragraphs (i) and (ii) above, service purchases from  
24 time periods prior to June 30, 2012 may be made on or prior to June 30, 2015.

25 (e) No member of the teachers' retirement system shall be permitted to purchase service  
26 credits for casual or seasonal employment, for employment as a temporary or emergency  
27 employee, a page in the general assembly, or for employment at any state college or university  
28 while the employee is a student or graduate of the college or university.

29 (f) Except as specifically provided in section 16-16-6.2 and 16-16-6.4, a member shall  
30 not receive service credit in this retirement system for any year or portion of a year which counts  
31 as service credit in any other retirement system in which the member is vested or from which the  
32 member is receiving a pension and/or any annual payment for life. This subsection shall not apply  
33 to any payments received pursuant to the federal Social Security Act, 42 U.S.C. section 301 et  
34 seq.

1 (g) A member who seeks to purchase or receive service credit in this retirement system  
2 shall have the affirmative duty to disclose to the retirement board whether or not he or she is a  
3 vested member in any other retirement system and/or is receiving a pension, retirement  
4 allowance, or any annual payment for life. The retirement board shall have the right to investigate  
5 as to whether or not the member has utilized the same time of service for credit in any other  
6 retirement system. The member has an affirmative duty to cooperate with the retirement board  
7 including, by way of illustration and not by way of limitation, the duty to furnish or have  
8 furnished to the retirement board any relevant information that is protected by any privacy act.

9 (h) A member who fails to cooperate with the retirement board shall not have the time of  
10 service credit counted toward total service credit until the time the member cooperates with the  
11 retirement board and until the time the retirement board determines the validity of the service  
12 credit.

13 (i) A member who knowingly makes a false statement to the retirement board regarding  
14 service time or credit shall not be entitled to a retirement allowance and is entitled only to the  
15 return of his or her contributions without interest.

16 **16-16-13. Amount of service retirement allowance.** – (a)(1)(i) For teachers eligible to  
17 retire on or before September 30, 2009, upon retirement from service under section 16-16-12 a  
18 teacher whose membership commenced before July 1, 2005 and who has completed at least ten  
19 (10) years of contributory service on or before July 1, 2005, shall, receive a retirement allowance  
20 which shall be determined in accordance with schedule A [for service prior to July 1, 2012.](#)

34 (2) Upon retirement from service under section 16-16-12 a teacher whose membership

2 service as of July 1, 2005 shall receive a retirement allowance which shall be determined in

12 (b) The retirement allowance of any teacher whose membership commenced before July  
13 1, 2005 and who has completed at least ten (10) years of contributory service on or before July 1,  
14 2005 shall be in an amount equal to the percentage allowance specified in subsection (a)(1) of his  
15 or her average highest three (3) consecutive years of compensation multiplied by the number of  
16 years of total service, but in no case to exceed eighty percent (80%) of the compensation, payable  
17 at completion of thirty-five (35) years of service; provided, however, for teachers retiring on or  
18 after October 1, 2009 who were not eligible to retire as of September 30, 2009 the calculation  
19 shall be based on the average highest five (5) consecutive years of compensation.

20 The retirement allowance of any teacher whose membership commenced after July 1,  
21 2005 or who has not completed at least ten (10) years of contributory service as of July 1, 2005  
22 shall be in an amount equal to the percentage allowance specified in Schedule B of his or her  
23 average highest three (3) consecutive years of compensation multiplied by the number of years of  
24 total service, but in no case to exceed seventy-five percent (75%) of the compensation, payable at  
25 completion of thirty-eight (38) years of service; provided, however, for teachers retiring on or  
26 after October 1, 2009 who were not eligible to retire as of September 30, 2009 the calculation  
27 shall be based on the average highest five (5) consecutive years of compensation.

28 Any teacher who has in excess of thirty-five (35) years on or before June 2, 1985 shall  
29 not be entitled to any refund, and any teacher with thirty-five (35) years or more on or after June  
30 2, 1985 shall contribute from July 1, 1985 until his or her retirement.

31 [\(c\) For service prior to July 2012, the retirement allowance of a teacher shall be](#)  
32 [determined in accordance with subsections \(a\)\(1\) and \(a\)\(2\) above. For service on and after July](#)  
33 [1, 2012, a teacher's retirement allowance shall be equal to one percent \(1%\) of the teacher's](#)  
34 [average compensation multiplied by the teacher's years of service on and after July 1, 2012. In no](#)

1 event shall a teacher's retirement allowance exceed the maximum limitations set forth in  
2 subsection (b) above.

3 **16-16-22. Contributions to state system.** – (a) Prior to July 1, 2012, each ~~Each~~ teacher  
4 ~~member~~ shall contribute into the system nine and one-half percent (9.5%) of compensation as his  
5 or her share of the cost of annuities, benefits, and allowances. Effective July 1, 2012, each teacher  
6 shall contribute an amount equal to three and three quarters percent (3.75%) of his or her  
7 compensation. The employer contribution on behalf of teacher members of the system shall be in  
8 an amount that will pay a rate percent of the compensation paid to the members, according to the  
9 method of financing prescribed in the State Retirement Act in chapters 8 – 10 and 10.3 of title 36.  
10 This amount shall be paid forty percent (40%) by the state, and sixty percent (60%) by the city,  
11 town, local educational agency, or any formalized commissioner approved cooperative service  
12 arrangement by whom the teacher members are employed, with the exception of teachers who  
13 work in federally funded projects and further with the exception of any supplemental  
14 contributions by a local municipality employer under chapter 36-10.3 which supplemental  
15 employer contributions shall be made wholly by the local municipality. Provided, however, that  
16 the rate percent paid shall be rounded to the nearest hundredth of one percent (.01%).

17 (b) The employer contribution on behalf of teacher members of the system who work in  
18 fully or partially federally funded programs shall be prorated in accordance with the share of the  
19 contribution paid from the funds of the federal, city, town, or local educational agency, or any  
20 formalized commissioner approved cooperative service arrangement by whom the teacher  
21 members are approved.

22 (c) In case of the failure of any city, town, or local educational agency, or any formalized  
23 commissioner approved cooperative service arrangement to pay to the state retirement system the  
24 amounts due from it under this section within the time prescribed, the general treasurer is  
25 authorized to deduct the amount from any money due the city, town, or local educational agency  
26 from the state.

27 (d) The employer's contribution shared by the state shall be paid in the amounts  
28 prescribed in this section for the city, town, or local educational agency and under the same  
29 payment schedule. Notwithstanding any other provisions of this chapter, the city, town, or local  
30 educational agency or any formalized commissioner approved cooperative service arrangement  
31 shall remit to the general treasurer of the state the local employer's share of the teacher's  
32 retirement payments on a monthly basis, payable by the fifteenth (15th) of the following month,  
33 ~~provided that the employer contribution shall be deferred from the effective date of this act until~~  
34 ~~June 15, 2010.~~ The amounts that would have been contributed shall be deposited by the state in a

1 special fund and not used for any purpose. The general treasurer, upon receipt of the local  
2 employer's share, shall effect transfer of a matching amount of money from the state funds  
3 appropriated for this purpose by the general assembly into the retirement fund, ~~provided that for~~  
4 ~~the period from the effective date of this act until June 15, 2010, the general treasurer shall not~~

6 Upon reconciliation of the final amount owed to the retirement fund for the employer  
7 share, the state shall ensure that any local education aid reduction assumed for the FY 2010  
8 revised budget in excess of the actual savings is restored to the respective local entities.

9 **16-16-22.1. City or town payment of teacher member contributions.** -- (a) Each city  
10 or town, pursuant to the provisions of section 414(h)(2) of the United States Internal Revenue  
11 Code, 26 U.S.C. section 414(h)(2), may, pursuant to appropriate local action by the city or town,  
12 pick up and pay the contributions which would be payable by the employees as teacher members  
13 under section 16-16-22. The contributions so picked up shall be treated as employer contributions  
14 in determining tax treatment under the United States Internal Revenue Code; ~~however, each city~~  
15 ~~or town shall continue to withhold federal and state income taxes based upon these contributions~~  
16 ~~until the internal revenue service rules that pursuant to 26 U.S.C. section 414(h)(2) these~~  
17 ~~contributions shall not be included as gross income of the employee until the time they are~~  
18 ~~distributed.~~ Employee contributions picked up pursuant to this section shall be treated and  
19 identified as teacher member contributions for all purposes of the retirement system except as  
20 specifically provided to the contrary in this section.

21 (b) Teacher member contributions picked up by a city or town shall be paid from the  
22 same source of funds used for the payment of compensation to a teacher member. A deduction  
23 shall be made from a teacher member's compensation equal to the amount of his or her  
24 contributions picked up by his or her city or town employer. This deduction, however, shall not  
25 reduce his or her compensation for purposes of computing benefits under the retirement system  
26 pursuant to this chapter or chapter 10 of title 36. Picked up contributions shall be transmitted to  
27 the retirement system in accordance with the provisions of section 16-16-22 and section 36-10-1.

28 **16-16-40. Additional benefits payable to retired teachers.** -- (a) All teachers and all  
29 beneficiaries of teachers receiving any service retirement or ordinary or accidental disability  
30 retirement allowance pursuant to the provisions of this chapter and chapter 17 of this title, on or  
31 before December 31, 1967, shall receive a cost of living retirement adjustment equal to one and  
32 one-half percent (1.5%) per year of the original retirement allowance, not compounded, for each  
33 year the retirement allowance has been in effect. For purposes of computation credit shall be  
34 given for a full calendar year regardless of the effective date of the retirement allowance. This

1 cost of living retirement adjustment shall be added to the amount of the service retirement  
2 allowance as of January 1, 1970, and payment shall begin as of July 1, 1970. An additional cost  
3 of living retirement adjustment shall be added to the original retirement allowance equal to three  
4 percent (3%) of the original retirement allowance on the first day of January, 1971, and each year  
5 thereafter through December 31, 1980.

6 (b) All teachers and beneficiaries of teachers receiving any service retirement or ordinary  
7 disability retirement allowance pursuant to the provisions of this title who retired on or after  
8 January 1, 1968, shall, on the first day of January, next following the third (3rd) year on  
9 retirement, receive a cost of living adjustment, in addition to his or her retirement allowance, an  
10 amount equal to three percent (3%) of the original retirement allowance. In each succeeding year  
11 thereafter, on the first day of January, the retirement allowance shall be increased an additional  
12 three percent (3%) of the original retirement allowance, not compounded, to be continued through  
13 December 31, 1980.

14 (c) Beginning on January 1, 1981, for all teachers and beneficiaries of teachers receiving  
15 any service retirement and all teachers and all beneficiaries of teachers who have completed at  
16 least ten (10) years of contributory service on or before July 1, 2005, pursuant to the provisions of  
17 this chapter, and for all teachers and beneficiaries of teachers who receive a disability retirement  
18 allowance pursuant to section 16-16-14 – 16-16-17, the cost of living adjustment shall be  
19 computed and paid at the rate of three percent (3%) of the original retirement allowance or the  
20 retirement allowance as computed in accordance with section 16-16-40.1, compounded annually  
21 from the year for which the cost of living adjustment was determined to be payable by the  
22 retirement board pursuant to the provisions of subsection (a) or (b) of this section. Such cost of  
23 living adjustments are available to teachers who retire before October 1, 2009 or are eligible to  
24 retire as of September 30, 2009.

25 (2) The provisions of this subsection shall be deemed to apply prospectively only and no  
26 retroactive payment shall be made.

27 (3) The retirement allowance of all teachers and all beneficiaries of teachers who have  
28 not completed at least ten (10) years of contributory service on or before July 1, 2005 or were not  
29 eligible to retire as of September 30, 2009, shall, on the month following the third anniversary  
30 date of the retirement, and on the month following the anniversary date of each succeeding year  
31 be adjusted and computed by multiplying the retirement allowance by three percent (3%) or the  
32 percentage of increase in the Consumer Price Index for all Urban Consumers (CPI-U) as  
33 published by the United States Department of Labor Statistics, determined as of September 30 of  
34 the prior calendar year, whichever is less; the cost of living adjustment shall be compounded

1 annually from the year for which the cost of living adjustment was determined payable by the  
2 retirement board; provided, that no adjustment shall cause any retirement allowance to be  
3 decreased from the retirement allowance provided immediately before such adjustment.

4 (d) For teachers not eligible to retire in accordance with this chapter as of September 30,  
5 2009 and not eligible upon passage of this article, and for their beneficiaries, the cost of living  
6 adjustment described in subsection (3) above shall only apply to the first thirty-five thousand  
7 dollars (\$35,000) of retirement allowance, indexed annually, and shall commence upon the third  
8 (3rd) anniversary of the date of retirement or when the retiree reaches age sixty-five (65),  
9 whichever is later. The thirty-five thousand dollar (\$35,000) limit shall increase annually by the  
10 percentage increase in the Consumer Price Index for all Urban Consumer (CPI-U) as published  
11 by the United States Department of Labor Statistics determined as of September 30 of the prior  
12 calendar year or three percent (3%), whichever is less. The first thirty-five thousand dollars  
13 (\$35,000), as indexed, of retirement allowance shall be multiplied by the percentage of increase  
14 in the Consumer Price Index for all Urban Consumers (CPI-U) as published by the United States  
15 Department of Labor Statistics determined as of September 30 of the prior calendar year or three  
16 percent (3%), whichever is less, on the month following the anniversary date of each succeeding  
17 year. For teachers eligible to retire as of September 30, 2009 or eligible upon passage of this  
18 article, and for their beneficiaries, the provisions of this subsection (d) shall not apply.

19 (e)(1) Notwithstanding the prior paragraphs of this section, and subject to paragraph (e)  
20 (2) below, for all present and former teachers, active and retired teachers, and beneficiaries  
21 receiving any retirement, disability or death allowance or benefit of any kind, the annual benefit  
22 adjustment provided in any calendar year under this section shall be equal to (A) multiplied by  
23 (B) where (A) is equal to the percentage determined by subtracting five and one-half percent  
24 (5.5%) (the “subtrahend”) from the Five-Year Average Investment Return of the retirement  
25 system determined as of the last day of the plan year preceding the calendar year in which the  
26 adjustment is granted, said percentage not to exceed four percent (4%) and not to be less than  
27 zero percent (0%), and (B) is equal to the lesser of the teacher’s retirement allowance or the first  
28 twenty-five thousand dollars (\$25,000) of retirement allowance, such twenty-five thousand  
29 dollars (\$25,000) amount to be indexed annually in the same percentage as determined under  
30 paragraph (e)(1)(A) above. The “Five-Year Average Investment Return” shall mean the average  
31 of the investment returns of the most recent five (5) plan years as determined by the retirement  
32 board. Subject to paragraph (e)(2) below, the benefit adjustment provided by this paragraph shall  
33 commence upon the third (3rd) anniversary of the date of retirement or the date on which the  
34 retiree reaches his or her Social Security retirement age, whichever is later. In the event the



1 retirement board adjusts the actuarially assumed rate of return for the system, either upward or  
2 downward, the subtrahend shall be adjusted either upward or downward in the same amount.

3 (2) Except as provided in paragraph (e)(3), the benefit adjustments under this section for  
4 any plan year shall be suspended in their entirety unless the GASB Funded Ratio of the  
5 Employees' Retirement System of Rhode Island, the Judicial Retirement Benefits Trust and the  
6 State Police Retirement Benefits Trust, calculated by the system's actuary on an aggregate basis,  
7 exceeds eighty percent (80%) in which event the benefit adjustment will be reinstated for all  
8 teachers for such plan year.

9 In determining whether a funding level under this paragraph (e)(2) has been achieved, the  
10 actuary shall calculate the funding percentage after taking into account the reinstatement of any  
11 current or future benefit adjustment provided under this section. "GASB Funded Ratio" shall  
12 mean the ratio of the actuarial value of assets to the actuarial accrued liability.

13 (3) Notwithstanding paragraph (e)(2), in each fifth plan year commencing after June 30,  
14 2012 commencing with the plan year ending June 30, 2017, and subsequently at intervals of five  
15 plan years, a benefit adjustment shall be calculated and made in accordance with paragraph (e)(1)  
16 above until the GASB Funded Ratio of the Employees' Retirement System of Rhode Island, the  
17 Judicial Retirement Benefits Trust and the State Police Retirement Benefits Trust, calculated by  
18 the system's actuary on an aggregate basis, exceeds eighty percent (80%).

19 (4) Notwithstanding any other provisions of this chapter, the provisions of this paragraph  
20 (e) of section 16-16-40 shall become effective July 1, 2012, and shall apply to any benefit  
21 adjustments not granted on or prior to June 30, 2012.

22 SECTION 11. Sections 45-21-2, 45-21-6, 45-21-7, 45-21-8, 45-21-8.1, 45-21-9, 45-21-  
23 12.1, 45-21-14.2, 45-21-16, 45-21-17, 45-21-17.2, 45-21-18, 45-21-30, 45-21-35, 45-21-41, 45-  
24 21-46, 45-21-51.1, 45-21-52, 45-21-58 and 45-21-66 of the General Laws in Chapter 45-21  
25 entitled "Retirement of Municipal Employees are hereby amended to read as follows:

26 **45-21-2. Definitions.** -- The following words and phrases as used in this chapter have the  
27 following meanings unless a different meaning is plainly required by the context:

28 (1) "Accumulated contributions" means the sum of all amounts deducted from the  
29 compensation of a member and credited to his or her individual account in the members'  
30 contribution reserve account.

31 (2) "Active member" means any employee of a participating municipality as defined in  
32 this section for whom the retirement system is currently receiving regular contributions pursuant  
33 to sections 45-21-41, 45-21-41.1 or 45-21.2-14.

34 (3) "Actuarial reserve" means the present value of all payments to be made on account of

1 any annuity, retirement allowance, or benefit, computed upon the basis of mortality tables  
2 adopted by the retirement board with regular interest.

3 (4) "Beneficiary" means any person in receipt of a retirement allowance, annuity, or  
4 other benefit as provided by this chapter.

5 (5) For purposes of this chapter, "domestic partner" shall be defined as a person who,  
6 prior to the decedent's death, was in an exclusive, intimate and committed relationship with the  
7 decedent, and who certifies by affidavit that their relationship met the following qualifications:

8 (i) Both partners were at least eighteen (18) years of age and were mentally competent to  
9 contract;

10 (ii) Neither partner was married to anyone else;

11 (iii) Partners were not related by blood to a degree which would prohibit marriage in the  
12 state of Rhode Island;

13 (iv) Partners resided together and had resided together for at least one year at the time  
14 of death; and

15 (v) Partners were financially interdependent as evidenced by at least two (2) of the  
16 following:

17 (A) Domestic partnership agreement or relationship contract;

18 (B) Joint mortgage or joint ownership of primary residence;

19 (C) Two (2) of: (I) Joint ownership of motor vehicle; (II) Joint checking account; (III)  
20 Joint credit account; (IV) Joint lease; and/or

21 (D) The domestic partner had been designated as a beneficiary for the decedent's will,  
22 retirement contract or life insurance.

23 (6) "Effective date of participation" means the date on which the provisions of this  
24 chapter have become applicable to a municipality accepting the provisions of the chapter in the  
25 manner stated in § 45-21-4.

26 (7) "Employee" means any regular and permanent employee or officer of any  
27 municipality, whose business time at a minimum of twenty (20) hours a week is devoted to the  
28 service of the municipality, including elective officials and officials and employees of city and  
29 town housing authorities. Notwithstanding the previous sentence, the term "employee", for the  
30 purposes of this chapter, does not include any person whose duties are of a casual or seasonal  
31 nature. The retirement board shall decide who are employees within the meaning of this chapter,  
32 but in no case shall it deem as an employee any individual who annually devotes less than twenty  
33 (20) business hours per week to the service of the municipality and who receives less than the  
34 equivalent of minimum wage compensation on an hourly basis for his or her services, except as

1 provided in section 45-2 1- 14.1. Casual employees mean those persons hired for an occasional  
2 period or a period of emergency to perform special jobs or functions not necessarily related to the  
3 work of regular employees. Any commissioner of a municipal housing authority, or any member  
4 of a part-time state board commission, committee or other authority is not deemed to be an  
5 employee within the meaning of this chapter.

6 (8) "Final compensation" for members who are eligible to retire on or prior to June 30,  
7 2012 shall means the average annual compensation, pay, or salary of a member for services  
8 rendered during the period of three (3) consecutive years within the total service of the member  
9 when the average was highest, and as the term average annual compensation is further defined in  
10 subdivision 36-8-1(5)(a)~~(4)~~. For members eligible to retire on or after July 1, 2012, "final  
11 compensation" means the average of the highest five (5) consecutive years of compensation  
12 within the total service when the final compensation was the highest. For members who become  
13 eligible to retire on or after July 1, 2012, if more than one half (1/2) of the member's total years  
14 of service consist of years of service during which the member devoted less than thirty (30)  
15 business hours per week to the service of the municipality, but the member's average  
16 compensation consists of three (3) or more years during which the member devoted more than  
17 thirty (30) business hours per week to the service of a municipality, such member's average  
18 compensation shall mean the average of the highest ten (10) consecutive years of compensation  
19 within the total service when the average compensation was the highest. Notwithstanding the  
20 preceding provisions, in no event shall a member's final compensation be lower than his or her  
21 final compensation determined as of June 30, 2012.

22 (9) "Fiscal year" means the period beginning on July 1 in any year and ending on June 30  
23 of the next succeeding year.

24 (10) "Full actuarial costs" or "full actuarial value" mean the lump sum payable by a  
25 member claiming service credit for certain employment for which payment is required, which is  
26 determined according to the age of the member and his or her annual rate of compensation at the  
27 time he or she applies for service credit, and which is expressed as a rate percent of the annual  
28 rate of compensation to be multiplied by the number of years for which he or she claims the  
29 service credit, as prescribed in a schedule adopted by the retirement board, from time to time, on  
30 the basis of computation by the actuary. Except as provided in sections 16-16-7.1, 36-5-3, 36-9-  
31 31, 36-10-10.4, and subdivision 45-21-53: (i) All service credit purchases requested after June 16,  
32 2009 and prior to July 1, 2012, shall be at full actuarial value; and (ii) All service credit purchases  
33 requested after June 30, 2012 shall be at full actuarial value which shall be determined using the  
34 system's assumed investment rate of return minus one percent (1%).

1 (11) "Governing body" means any and all bodies empowered to appropriate monies for,  
2 and administer the operation of, the units as defined in subdivision (1) of this section.

3 (12) "Member" means any person included in the membership of the retirement system  
4 as provided in § 45-21-8.

5 (13) "Municipality" means any town or city in the state of Rhode Island, any city or  
6 town housing authority, fire, water, sewer district, regional school district, public building  
7 authority as established by chapter 14 of title 37, or any other municipal financed agency to  
8 which the retirement board has approved admission in the retirement system.

9 (14) "Participating municipality" means any municipality which has accepted this  
10 chapter, as provided in § 45-21-4.

11 (15) "Prior service" means service as a member rendered before the effective date of  
12 participation as defined in this section, certified on his or her prior service certificate, and  
13 allowable as provided in § 45-21-15.

14 (16) "Regular interest" means interest ~~compounded annually as determined by the~~  
15 ~~retirement board based upon the experience of the system.~~ at the assumed investment rate of  
16 return, compounded annually, as may be prescribed from time to time by the retirement board.

17 (17) "Retirement allowance" or "annuity" means the amounts paid to any member of the  
18 municipal employees' retirement system of the state of Rhode Island, or a survivor of the  
19 member, as provided in this chapter. All retirement allowances or annuities shall be paid in equal  
20 monthly installments for life, unless otherwise specifically provided.

21 (18) "Retirement board" or "board" means the state retirement board created by chapter  
22 8 of title 36.

23 (19) "Retirement system" means the "municipal employees' retirement system of the  
24 state of Rhode Island" as defined in § 45-21-32.

25 (20) "Service" means service as an employee of a municipality of the state of Rhode  
26 Island as defined in subdivision (7).

27 (21) "Total service" means prior service as defined in subdivision (15) plus service  
28 rendered as a member on or after the effective date of participation.

29 (22) Any term not specifically defined in this chapter and specifically defined in chapters  
30 36-8 through 36-10 shall have the same definition as set forth in chapters 36-8 through 36-10.

31 **45-21-6. Settlement on withdrawal from system.** -- (a) Upon withdrawal from the  
32 system, the retirement board retains in the system from contributions made by the members from  
33 the municipality and by the municipality the following amounts:

34 (1) An amount equal to the actuarial value, determined in accordance with the actuarial

1 tables in use by the system, of the retirement and disability allowances in force, being paid to  
2 former employees of the municipality who were granted allowances as members of the system or  
3 to the beneficiaries of those members;

4 (2) An amount equal to the actuarial value of deferred annuities to members who have  
5 not retired but who have acquired a vested right to a retirement allowance who may desire to  
6 maintain that vested right; and

7 (3) An amount equal to the accumulated contributions of the members who have not  
8 acquired a vested right which shall be refunded to those members.

9 (b) Any remainder in the system after providing for the foregoing amounts shall be paid  
10 over to the municipality in such amount as the retirement board shall in its sole discretion  
11 determine to be prudent and legally permissible; provided, that if no remainder exists and a  
12 deficiency to pay those amounts has accumulated, the municipality is liable to the system for the  
13 amount of the deficiency as provided in this section.

14 **45-21-7. Liability of municipalities - Enforcement.** -- (a) Each participating  
15 municipality is liable to the retirement system for the cost of funding a retirement system for its  
16 employees who are members of the system, including all contributions collected from employees,  
17 including any contributions pursuant to chapter 36-10.3.

18 (b) The liability of a municipality, including the liability under any formalized,  
19 commissioner approved, cooperative service arrangement under this chapter is enforceable by the  
20 retirement board against the municipality through appropriate action in the superior court.

21 (c) The state is further empowered to withhold from any municipality that amount of the  
22 municipality's portion of any shared taxes which is sufficient to satisfy the liability, including any  
23 liability pursuant to chapter 36-10.3.

24 **45-21-8. Membership in system.** -- Membership in the retirement system does not begin  
25 before the effective date of participation in the system as provided in § 45-21-4, and consists of  
26 the following:

27 (a) Any employee of a participating municipality as defined in this chapter, who  
28 becomes an employee on and after the effective date of participation, shall, under contract of his  
29 or her employment, become a member of the retirement system; provided, that the employee is  
30 not receiving any pension or retirement allowance from any other pension or retirement system  
31 supported wholly or in part by a participating municipality, and is not a contributor to any other  
32 pension or retirement system of a participating municipality. Any employee who is elected to an  
33 office in the service of a municipality after the effective date and prior to July 1, 2012, has the  
34 option of becoming a member of the system, which option must be exercised within sixty (60)

1 days following the date the employee assumes the duties of his or her office, otherwise that  
2 person is not entitled to participate under the provisions of this section;

3 (b) Any employee or elected official of a participating municipality in service prior to  
4 the effective date of participation, who is not a member of any other pension or retirement system  
5 supported wholly or in part by a participating municipality, and who does not notify the  
6 retirement board in writing before the expiration of sixty (60) days from the effective date of  
7 participation that he or she does not wish to join the system, shall automatically become a  
8 member; and

9 (c) Any employee of a participating municipality in service prior to the effective date of  
10 participation, who is a member of any other pension or retirement system supported wholly or in  
11 part by a participating municipality on the effective date of participation of their municipality,  
12 who then or thereafter makes written application to join this system, and waives and renounces all  
13 accrued rights and benefits of any other pension or retirement system supported wholly or in part  
14 by a participating municipality, becomes a member of this retirement system and shall not be  
15 required to make contribution under any other pension or retirement system of a participating  
16 municipality, any thing to the contrary notwithstanding.

17 (d) Notwithstanding the provisions of this section, present firefighters employed by the  
18 town of Johnston shall establish a pension plan separate from the state of Rhode Island retirement  
19 system. If the town of Johnston is thirty (30) days or more late on employer or employee  
20 contributions to the pension plan, the auditor general is authorized to redirect any Johnston funds  
21 to cover the shortfall or to deduct that amount from any moneys due the town from the state for  
22 any purpose other than for education. Disability determinations of present firefighters shall be  
23 made by the state retirement board, subject to the provisions of § 45-21-19 at the town of  
24 Johnston's expense. All new firefighters hired by the town of Johnston shall become members of  
25 the state retirement system.

26 (e) Notwithstanding the provisions of this section, any City of Cranston employees, who  
27 are presently members of Teamsters Local Union No. 251, hired between the dates of July 1,  
28 2005 and June 30, 2010 inclusive and who are currently members of the retirement system  
29 established by this chapter, may opt out of said retirement system and choose to enroll in a  
30 defined contribution plan (i.e., a 403 (b) plan or equivalent thereof) established by the City of  
31 Cranston.

32 (f) Notwithstanding the provisions of this section, any City of Cranston employees, who  
33 will be members of Teamsters Local Union No. 251, hired after June 30, 2010 shall be enrolled in  
34 a defined contribution plan (i.e., a 403 (b) plan or equivalent thereof) established by the City of

1 Cranston and shall not be a member of the retirement system established by this chapter.

2 (g) Notwithstanding the provisions of this section, any City of Cranston employees  
3 defined in (e) and (f) of this section shall be precluded from purchase of service credit for time  
4 served on or after July 1, 2010 while participating in the defined contribution plan (i.e., a 403 (b)  
5 plan or equivalent thereof) established by the City of Cranston should the member cease  
6 employment with the City of Cranston or Teamsters Local Union No. 251 and re-enter the system  
7 with another participating employer who has accepted the provisions, as defined, in § 45-21-4.

8 **45-21-8.1. ~~Exclusion of elected city, or town council members.~~ Exclusion of elected**  
9 **city, town council or other elected members.** -- Notwithstanding any provision of this chapter  
10 or any provision of the general or public laws to the contrary, no city or town council member,  
11 school committee members or other local elected officials, other than elected officials who are  
12 compensated for devoting thirty-five (35) or more hours per week to their elected position,  
13 elected for the first time after ~~November 4~~ June 30, 2012, shall be allowed membership into the  
14 municipal employees' retirement system, as a result of that elective service.

15 **45-21-9. Prior service credit of members joining by election – Purchase of credit for**  
16 **prior service.** -- (a) No employee of a participating municipality whose membership in the  
17 retirement system is contingent on his or her own election to join under § 45-21-8(c), shall  
18 receive prior service credit unless the employee makes application for membership within one  
19 year from the effective date of participation of the municipality by which the employee is  
20 employed. Any employee who elects not to join this retirement system, as provided in § 45-21-  
21 8(b), may thereafter be admitted to membership, but no employee shall receive credit for prior  
22 service unless the employee applies for membership within one year from the effective date of  
23 participation of the municipality by which the employee is employed.

24 (b) Any member who becomes an employee after the effective date of participation by a  
25 municipality into the system, has the privilege of purchasing credit for prior service with the city  
26 or town of which the employee is now employed. This privilege does not become effective until a  
27 member has had at least one year of service following his or her latest reentry into membership  
28 with the system, and credit is granted only when the member makes a lump sum payment of six  
29 percent (6%) of the rate of compensation in effect on the date of reentry, plus regular interest,  
30 compounded annually from that date to the date of purchase. The maximum period of service that  
31 may be purchased under this section is ten (10) years. Upon granting prior service under the  
32 provisions of this section, the board shall bill the applicable city or town for its share of the total  
33 liability for the prior service. Effective July 1, 2012, any purchase requested under this paragraph  
34 shall be made by a member at full actuarial cost.

1           **45-21-12.1. Credit for service as a teacher or state employee.** -- Any member who has  
2 rendered service as a teacher, as defined under the provisions of chapters 16 and 17 of title 16, or  
3 as a state employee, as defined by the provisions of chapters 8 to 10 of title 36, is entitled to credit  
4 for that service for the various purposes of this system; provided, that the member was a  
5 contributing member for that period. All contributions made by the member for those periods of  
6 service shall be transferred in ~~to to~~ to this system and the retirement system shall calculate the  
7 full actuarial value of the accrued benefit with the former employer. If the full actuarial value of  
8 the accrued benefit with the former employer is greater than the total employee contributions  
9 transferred, the retirement system shall also transfer the difference between the full actuarial  
10 value of the accrued benefit with the former employer and the employee's contributions from the  
11 account of the former employer to the account of the current employing municipality. In any case  
12 in which a member has received a refund or refunds of contributions made to the system, the  
13 allowance of the previously stated credit for service is conditioned upon the repayment of the  
14 refund or refunds, including regular interest from the date of refund to the date of repayment. Any  
15 service as defined in this section for which no contributions were made, may be granted;  
16 provided, that the member pays to the retirement system a lump sum payment equal to the  
17 amount had he or she been a member during that period, plus interest as defined in this section.  
18 Effective July 1, 2012, any purchase requested under this paragraph shall be made by a member  
19 at full actuarial cost. The retirement board shall fix and determine rules and regulations that are  
20 needed to govern the provisions of this section.

21           **45-21-14.2. Leave of absence credits.** -- (a) Members with at least one year of  
22 membership credits who have been granted an official leave of absence without pay for illness,  
23 injury, educational or, any other reason, may receive credit for the leave by making contributions  
24 to the retirement system, in a lump sum, in an amount equal to the contribution the member  
25 would have made to the retirement system based upon the member's expected compensation but  
26 for the granting of leave without pay, plus regular interest compounded annually to date of  
27 payment; provided, that the member returns to service for at least one year immediately upon  
28 completion of that leave. Credit for leaves of absence under this section are limited, in the  
29 aggregate, during the total service of a member to a period of four (4) years maximum. Effective  
30 July 1, 2012, any purchase requested under this paragraph shall be made by a member at full  
31 actuarial cost.

32           (b) The retirement board fixes the time when and the conditions under which payments  
33 are made under this section.

34           (c) This section is exempt from the provisions of §§ 45-13-6 – 45-13-10.



1           **45-21-16. Retirement on service allowance.** -- Retirement of a member on a service  
2 retirement allowance shall be made by the retirement board as follows:

3           (1) (i) Any member who is eligible to retire on or before June 30, 2012, may retire upon  
4 the member's written application to the retirement board as of the first day of the calendar month  
5 in which the application was filed, provided the member was separated from service prior to the  
6 application, and provided, further, that if separation from service occurs during the month in  
7 which application is filed, the effective date is the first day following the separation from service,  
8 provided that the member at the time so specified for the member's retirement has attained the  
9 applicable minimum retirement age and has completed at least ten (10) years of total service or  
10 who, regardless of age, completed thirty (30) years of total service, and notwithstanding that  
11 during the period of notification the member has separated from service. The minimum ages for  
12 service retirement (except for employees completing thirty (30) years of service) is fifty-eight  
13 (58) years.

14           (ii) Effective July 1, 2012, the following shall apply to all members not eligible to retire  
15 prior to July 1, 2012:

16           (A) A member with contributory service on or after July 1, 2012, shall be eligible to retire  
17 upon the completion of at least five (5) years of contributory service and attainment of the  
18 member's Social Security retirement age.

19           (B) For members with five (5) or more years of contributory service as of June 30, 2012,  
20 with contributory service on and after July 1, 2012, who have a retirement age of Social Security  
21 Retirement Age, the retirement age will be adjusted downward in proportion to the amount of  
22 service the member has earned as of June 30, 2012, but in no event shall a member's retirement  
23 age under this subparagraph (B) be prior to the attainment of age fifty-nine (59) or prior to the  
24 member's retirement age determined under the laws in effect on June 30, 2012. The proportional  
25 formula shall work as follows:

26           (1) The formula shall determine the first age of retirement eligibility under the laws in  
27 effect on June 30, 2012 which shall then be subtracted from Social Security retirement age;

28           (2) The formula shall then take the member's total service credit as of June 30, 2012 as  
29 the numerator and the projected service at retirement age in effect on June 30, 2012 as the  
30 denominator;

31           (3) The fraction determined in (2) shall then be multiplied by the age difference  
32 determined in (1) to apply a reduction in years from Social Security retirement age.

33           (C) A member who has completed twenty (20) or more years of total service and who has  
34 attained an age within five (5) years of the eligible retirement age under subparagraphs (ii)(A) or

1 (ii)(B) above, may elect to retire provided that the retirement allowance shall be reduced  
2 actuarially for each month that the age of the member is less than the eligible retirement age  
3 under subparagraphs (ii)(A) or (ii)(B) above.

4 (D) Notwithstanding any other provisions of section 42-21-16(1)(ii), a member who has  
5 completed ten (10) or more years of contributory service as of June 30, 2012, may elect to retire  
6 at his or her eligible retirement date as determined under paragraph (i) above provided that a  
7 member making an election under this paragraph shall receive the member's retirement benefit  
8 determined and calculated based on the member's service and average compensation as of June  
9 30, 2012. This provision shall be interpreted and administered in a manner to protect a member's  
10 accrued benefit on June 30, 2012.

11 (2) Except as specifically provided in §§ 45-21-19 through 45-21-22, no member is  
12 eligible for pension benefits under this chapter unless:

13 (I) On or prior to June 30, 2012 the member has been a contributing member of the  
14 employees' retirement system for at least ten (10) years; or

15 (II) For members in active contributory service on or after July 1, 2012, the member  
16 shall have been a contributing member of the employees' retirement system for at least five (5)  
17 years.

18 (i) Provided, however, a person who has ten (10) years service credit on or before June  
19 16, 1991 is vested.

20 (ii) Furthermore, any past service credits purchased in accordance with § 45-21-62 are  
21 counted towards vesting.

22 (iii) Any person who becomes a member of the employees' retirement system pursuant to  
23 § 45-21-4 shall be considered a contributing member for the purpose of this chapter.

24 (iv) Notwithstanding any other provision of law, no more than five (5) years of service  
25 credit may be purchased by a member of the System. The five (5)-year limit does not apply to any  
26 purchases made prior to the effective date of this provision. A member who has purchased more  
27 than five (5) years of service credit maximum, before January 1, 1995, shall be permitted to apply  
28 the purchases towards the member's service retirement. However, no further purchase will be  
29 permitted. Repayment, in accordance with applicable law and regulation, of any contribution  
30 previously withdrawn from the System is not deemed a purchase of service credit.

31 (v) Notwithstanding any other provision of law, effective July 1, 2012, except for  
32 purchases under sections 16-16-7.1, 36-5-3, 36-9-31, 36-10-10.4, and 45-21-53:

33 (I) For service purchases for time periods prior to a member's initial date of hire; the  
34 purchase must be made within three (3) years of the member's initial date of hire; and

1           (II) For service purchases for time periods for official periods of leave as authorized by  
2 law, the purchase must be made within three (3) years of the time the official leave was  
3 concluded by the member.

4           Notwithstanding (I) and (II) above, service purchases from time periods prior to June 30,  
5 2012 may be made on or prior to June 30, 2015.

6           (3) No member of the municipal employees' retirement system is permitted to purchase  
7 service credits for casual, temporary, emergency or seasonal employment, for employment as a  
8 page in the general assembly, or for employment at any state college or university while the  
9 employee is a student or graduate assistant of the college or university.

10          (4) A member does not receive service credit in this retirement system for any year or  
11 portion of a year, which counts as service credit in any other retirement system in which the  
12 member is vested or from which the member is receiving a pension and/or any annual payment  
13 for life. This subsection does not apply to any payments received pursuant to the Federal Social  
14 Security Act or to payments from a military pension earned prior to participation in state or  
15 municipal employment, or to military service credits earned prior to participation in state or  
16 municipal employment.

17          (5) A member who seeks to purchase or receive service credit in this retirement system  
18 has the affirmative duty to disclose to the retirement board whether or not he or she is a vested  
19 member in any other retirement system and/or is receiving a pension retirement allowance or any  
20 annual payment for life. The retirement board has the right to investigate whether or not the  
21 member has utilized the same time of service for credit in any other retirement system. The  
22 member has an affirmative duty to cooperate with the retirement board including, by way of  
23 illustration and not by way of limitation, the duty to furnish or have furnished to the retirement  
24 board any relevant information which is protected by any privacy act.

25          (6) A member who fails to cooperate with the retirement board shall not have the time of  
26 service counted toward total service credit until a time that the member cooperates with the  
27 retirement board and until a time that the retirement board determines the validity of the service  
28 credit.

29          (7) A member who knowingly makes a false statement to the retirement board regarding  
30 service time or credit is not entitled to a retirement allowance and is entitled only to the return of  
31 his or her contributions without interest.

32          **45-21-17. Service retirement allowance.** -- (a) Upon retirement from service after  
33 January 1, 1969, a member shall receive a retirement allowance which is a life annuity terminable  
34 upon death of the annuitant and is an amount is equal to two percent (2%) of final compensation

1 multiplied by the number of years of total service, not to exceed thirty-seven and one-half (37  
2 1/2) years for services on and prior to June 30, 2012. For service on and after July 1, 2012, a  
3 member's retirement allowance shall be equal to one percent (1%) of the member's final  
4 compensation multiplied by the member's years of service on and after July 1, 2012. In no event  
5 shall a member's retirement allowance exceed seventy-five percent (75%) of the member's final  
6 compensation. ~~;~~ ~~provided,~~ Provided, however, that every person elected prior to July 1, 2012 who  
7 has served as a part time elected official of the city of Cranston for a period often (10) years, is  
8 entitled to receive, upon retirement from that part time service, and not being otherwise regularly  
9 employed by the city of Cranston in which that person has served, a service retirement allowance  
10 equivalent to fifty percent (50%) of the salary received at the time of retirement by that part time  
11 elected official; and, provided, further, that if that person retires after a period of service greater  
12 than ten (10) years, the person is entitled to receive an additional service retirement allowance  
13 equivalent to five percent (5%) of the salary received at the time of retirement for each whole  
14 year of service, in excess of ten (10) years up to a maximum additional allowance equivalent to  
15 fifty percent (50%) of the salary received.

16 (b) This section also applies to any former part time elected official of the city of  
17 Cranston who is presently receiving retirement benefits from the municipal retirement system.

18 (c) Every person elected prior to July 1, 2012 who serves or has served at least four (4)  
19 years as a part time elected official of the city of Cranston may include that person's years of  
20 service as a member of the general assembly, and any other credits acquired while serving as a  
21 legislator, when computing the person's period of service to the city of Cranston pursuant to the  
22 provisions of this section.

23 **45-21-17.2. Social security supplemental option.** -- (a) In lieu of the retirement on  
24 service allowance, a vested member who retires in accordance with § 45-21-16 may choose an  
25 optional form of retirement benefit known as the social security supplemental option.

26 (b) This option provides for the payment of a larger benefit before the attainment of age  
27 sixty-two (62) and a reduced benefit thereafter. The reduced amount is equal to the benefit before  
28 age sixty-two (62), including cost of living increases, reduced by the member's estimated social  
29 security benefit payable at age sixty-two (62). Benefits payable under this option before and after  
30 the attainment of age sixty-two (62) are actuarially determined to be equivalent to the lifetime  
31 service retirement allowance as determined in § 45-21-17.

32 (c) Election of this social security supplemental option is available only to members with  
33 ten (10) or more years of contributing service on or before June 30, 2012 ~~those~~ who elect the  
34 service retirement allowance set forth in § 45-21-17.

1           **45-21-18. Deferred allowance on service retirement before minimum age.** – The right  
2 to a service retirement allowance under the provisions of this chapter is vested in a member who  
3 withdraws from service prior to the attainment of the applicable minimum age of retirement as  
4 prescribed in this section, who has not received a refund; provided, that the member has  
5 completed at least ten (10) years of total service, [or for members in active service on or after July](#)  
6 [1, 2012, at least five \(5\) years of total service.](#) The member becomes entitled to a service  
7 retirement allowance upon the member's attainment of the applicable minimum retirement age or  
8 at the member's option at any date subsequent to attaining that age. The rate of service retirement  
9 allowance payable in the case of any member is that provided in § 45-21-17 for the period of total  
10 service earned and accrued at the date of withdrawal from service of the member.

11           **45-21-30. Optional benefits on service retirement.** -- (a) A beneficiary, or, if the  
12 beneficiary is an incompetent, then his or her spouse or domestic partner, or if he or she has no  
13 spouse or domestic partner, a guardian of the beneficiary's estate, may elect to receive a benefit in  
14 a retirement allowance, payable throughout life, or the beneficiary may then elect to receive the  
15 actuarial equivalent, at that time, of the beneficiary's retirement allowance in a lesser retirement  
16 allowance as determined by actuarial calculation, which shall be payable throughout life with the  
17 provision that:

18           (1) Option 1. A reduced retirement allowance payable during the beneficiary's life, with  
19 the provisions that after the beneficiary's death, it shall continue during the life of and be paid to  
20 the person that the beneficiary has nominated by written designation duly acknowledged and filed  
21 with the retirement board at the time of retirement; or

22           (2) Option 2. A reduced retirement allowance payable during the beneficiary's life, with  
23 the provision that after the beneficiary's death an allowance equal to one-half (1/2) of the  
24 beneficiary's reduced allowance shall continue during the life of and be paid to the person that the  
25 beneficiary has nominated by written designation duly acknowledged and filed with the board at  
26 the time of retirement.

27           (b) This section does not apply to any person who elects the social security supplemental  
28 option related in section 45-21-17.2.

29           (c) This section is exempt from the provisions of sections 45-13-6 - 45-13-10.

30           (d) [If prior to July 1, 2012, a member elected an optional form of benefit other than a life](#)  
31 [annuity in accordance with paragraph \(a\) above, the member may elect to change his or her form](#)  
32 [of benefit to a life annuity by filing an election with the retirement board on or before June 30,](#)  
33 [2013, provided that the member's beneficiary is still alive at the time the election is filed.](#)

34           **45-21-35. Legal adviser - General treasurer - Executive director - Assistant director.**

1    — There shall be a legal counsel to the board appointed by the general treasurer. The general  
2    treasurer is the ex-officio chairperson of the retirement board ~~and he or she is the custodian of the~~  
3    ~~funds~~ and the treasurer of the retirement board and he or she shall be responsible for appointing  
4    the custodian. There shall be an executive director appointed by the retirement board in charge of  
5    the administration of the retirement system and who shall serve as secretary to the retirement  
6    board. In addition, the retirement board shall appoint an assistant director to serve as director  
7    and/or secretary in the absence of the director.

8            **45-21-41. Members' contributions – Payroll deductions – Certification to board. –**

9    (a) Prior to July 1, 2012, each ~~Each~~ member shall contribute an amount equal to six percent (6%)  
10   of salary or compensation earned and accruing to the member; provided, that contributions by any  
11   member cease when the member has completed the maximum amount of service credit attainable.  
12   Special compensation for additional fees shall not be considered as compensation for contribution  
13   purposes. Effective July 1, 2012, each member shall contribute an amount equal to one percent  
14   (1%) of his or her compensation as his or her share of the cost.

15           (b) Each municipality shall deduct the previously stated rate from the compensation of  
16   each member on each and every payroll of the municipality, and the deduction made during the  
17   entire time a member is in service subject to termination as stated in the foregoing paragraph.

18           (c) The deductions provided for in this section shall be made notwithstanding that the  
19   minimum compensation provided for by law for any member is reduced by the compensation.  
20   Every member is deemed to consent and agree to the deductions made and provided for in this  
21   section, and shall receipt for his or her full salary or compensation; and payment of salary or  
22   compensation less those deductions are a full and complete discharge and acquittance of all  
23   claims and demands for the services rendered by the person during the period covered by the  
24   payment except as to the benefits provided under this chapter. Each participating municipality  
25   shall certify to the retirement board the amounts deducted from the compensation of members.  
26   Each of the amounts, when deducted, shall be credited to an individual account of the member  
27   from whose compensation the deduction was made.

28           **45-21-46. Forfeiture for fraudulent claims. --** Every person who knowingly or willfully  
29   makes or presents or in any way procures the making or presentation of any false or fraudulent  
30   affidavit or affirmation concerning any claim for retirement allowance or payment of retirement  
31   allowance, shall, in every case, forfeit a sum not exceeding ~~one ten~~ thousand dollars (\$10,000)  
32   ~~(\$1,000)~~, to be sued and recovered by and in the name of the retirement board, and when  
33   recovered paid over to and become a part of the funds of the retirement system.

34           **45-21-51.1. Optional annuity protection – Election of option by member. --** (a) Upon

1 death of a member having (1) at least ten (10) years of membership service on or before June 30,  
2 2012 or (2) for active contributing members on or after July 1, 2012, at least five (5) years of  
3 membership service, the spouse or domestic partner of the member has the option to elect to  
4 receive option one as provided in § 45-21-30 in lieu of a return of contributions, provided the  
5 spouse or domestic partner is the designated beneficiary of the member's retirement account. The  
6 election is based upon the amount of retirement allowance or actuarial equivalent that may accrue  
7 at the date of death of the member.

8 (b) The election under option one for a person other than the spouse or domestic partner  
9 of the member may be made by the member, while in service; provided, that the member has (i)  
10 at least ten (10) years of membership service on or before June 30, 2012 and before retirement or  
11 (ii) for active contributing members on or after July 1, 2012, at least five (5) years of membership  
12 service and before retirement, on a form prescribed by the retirement board. The election is based  
13 upon the amount of retirement allowances or actuarial equivalents that may accrue at the date of  
14 death of the member; provided that the election form is executed and filed with the retirement  
15 board prior to the date of death. The election may be revoked or modified by the member at any  
16 time prior to the date of retirement, on a form prescribed by the retirement board.

17 (c) Upon the death of a member, the option becomes effective thirty (30) days after the  
18 first day of the next calendar month following the date of death of the member if death occurs  
19 while in an employee status. Should death occur while in an inactive member status, the option  
20 under this section becomes payable on the first day of the next succeeding month that in which  
21 the designated beneficiary attains the age of sixty (60) years.

22 **45-21-52. Automatic increase in service retirement allowance.** -- (a) The local  
23 legislative bodies of the cities and towns may extend to their respective employees automatic  
24 adjustment increases in their service retirement allowances, by a resolution accepting any of the  
25 plans described in this section:

26 (1) *Plan A.* All employees and beneficiaries of those employees receiving a service  
27 retirement or disability retirement allowance under the provisions of this chapter on December 31  
28 of the year their city or town accepts this section, receive a cost of living adjustment equal to one  
29 and one-half percent (1 1/2%) per year of the original retirement allowance, not compounded, for  
30 each calendar year the retirement allowance has been in effect. This cost of living adjustment is  
31 added to the amount of the retirement allowance as of January 1 following acceptance of this  
32 provision, and an additional one and one-half percent (1 1/2%) is added to the original retirement  
33 allowance in each succeeding year during the month of January, and provided, further, that this  
34 additional cost of living increase is three percent (3%) for the year beginning January 1 of the



1 year the plan is accepted and each succeeding year.

2 (2) *Plan B.* All employees and beneficiaries of those employees receiving a retirement  
3 allowance under the provisions of this chapter on December 31 of the year their municipality  
4 accepts this section, receive a cost of living adjustment equal to three percent (3%) of their  
5 original retirement allowance. This adjustment is added to the amount of the retirement allowance  
6 as of January 1 following acceptance of this provision, and an additional three percent (3%) of the  
7 original retirement allowance, not compounded, is payable in each succeeding year in the month  
8 of January.

9 (3) *Plan C.* All employees and beneficiaries of those employees who retire on or after  
10 January 1 of the year following acceptance of this section, on the first day of January next  
11 following the date of the retirement, receive a cost of living adjustment in an amount equal to  
12 three percent (3%) of the original retirement allowance.

13 (b) In each succeeding year in the month of January, the retirement allowance is  
14 increased an additional three percent (3%) of the original retirement allowance, not compounded.

15 (c)(1) Notwithstanding any other paragraphs of this section, and subject to paragraph (c)  
16 (2) below, for all present and former employees, active and retired members, and beneficiaries  
17 receiving any retirement, disability or death allowance or benefit of any kind by reason of  
18 adoption of this section by their employer, the annual benefit adjustment provided in any calendar  
19 year under this section shall be equal to (A) multiplied by (B) where (A) is equal to the  
20 percentage determined by subtracting five and one-half percent (5.5%) (the “subtrahend”) from  
21 the Five-Year Average Investment Return of the retirement system determined as of the last day  
22 of the plan year preceding the calendar year in which the adjustment is granted, said percentage  
23 not to exceed four percent (4%) and not to be less than zero percent (0%), and (B) is equal to the  
24 lesser of the member’s retirement allowance or the first twenty-five thousand dollars (\$25,000) of  
25 retirement allowance, such twenty-five thousand dollars (\$25,000) amount to be indexed annually  
26 in the same percentage as determined under (c)(1)(A) above. The “Five-Year Average Investment  
27 Return” shall mean the average of the investment returns of the most recent five (5) plan years as  
28 determined by the retirement board. Subject to paragraph (c)(2) below, the benefit adjustment  
29 provided by this paragraph shall commence upon the third (3<sup>d</sup>) anniversary of the date of  
30 retirement or the date on which the retiree reaches his or her Social Security retirement age,  
31 whichever is later; or for municipal police and fire retiring under the provisions of chapter 45-  
32 21.2, the benefit adjustment provided by this paragraph shall commence on the later of the third  
33 (3<sup>d</sup>) anniversary of the date of retirement or the date on which the retiree reaches age fifty- five  
34 (55). In the event the retirement board adjusts the actuarially assumed rate of return for the



1 system, either upward or downward, the subtrahend shall be adjusted either upward or downward  
2 in the same amount.

3 (2) Except as provided in paragraph (c)(3) the benefit adjustments provided under this  
4 section for any plan year shall be suspended in their entirety for each municipal plan within the  
5 municipal employees retirement system unless the municipal plan is determined to be funded at a  
6 GASB Funded Ratio equal to or greater than eighty percent (80%) as of the end of the  
7 immediately preceding plan year in accordance with the retirement system's actuarial valuation

9 reinstated for all members for such plan year.

11 actuary shall calculate the funding percentage after taking into account the reinstatement of any  
12 current or future benefit adjustment provided under this section. "GASB Funded Ratio" shall  
13 mean the ratio of the actuarial value of assets to the actuarial accrued liability.

14 (3) Notwithstanding paragraph (c)(2), for each municipal plan that has a GASB Funded

24 continuing on an annual basis on that date.

25 (10) Any member of the Richmond police department may retire pursuant to this  
26 subdivision upon written application to the board stating at what time the member desires to  
27 retire; provided, that the member at the specified time for retirement has earned a service  
28 retirement allowance of fifty percent (50%) of final compensation for at least twenty-two (22)  
29 years' service pursuant to § 45-21.2-6.3.

30 (11) Notwithstanding any provision in this section to the contrary, for any service on or  
31 after July 1, 2012, final compensation shall be defined in accordance with section 45-21.2-2, and  
32 no benefit adjustments shall be provided except as set forth in subsection 45-21-52(c).

33 (b) Retirement of a member on a service retirement allowance eligible to retire on and

29 [purchases requested on or before June 30, 2012,](#) an amount based upon his or her compensation,  
30 which for the purposes of this section is deemed to be in an amount of not less than three hundred  
31 dollars (\$300) annually, for the last year of each three (3) year period at the time of purchase of  
32 the credit, and regular interest as defined in chapter 8 of title 36; [and \(2\) for purchases requested](#)  
33 [on or after July 1, 2012, the full actuarial cost of the time being purchased.](#)

34 **45-21.2-20. Persons eligible for optional benefits – Time of election – Modification or**

1 **revocation – Effective date.** -- (a) The optional provisions of § 45-21.2-6~~(e)~~(b) are applicable  
2 only to a member applying for a service retirement allowance, an accidental disability retirement  
3 allowance, an ordinary disability retirement allowance or any inactive member applying for  
4 retirement under vested rights. The election under option 1 or 2 is made at the time of retirement  
5 of the member as part of his or her application for a retirement allowance.

6 (b) The election is based upon the amount of retirement allowances that may accrue at the  
7 date of death of the member, and may be revoked or modified by the member at any time after  
8 retirement on a form prescribed by the retirement board; and, provided, further, that, during this  
9 time, the named beneficiary has not been divorced from the member.

10 (c) The option in the case of death of a retired member becomes effective on the day  
11 following the death of the member, and payment of benefits are made in accordance with the  
12 provisions of this section, subject to the limitations prescribed in § 45-21.2-6.

13 **45-21.2-21. Optional annuity protection – Death while employee or inactive member**

14 **status.** -- The election under option 1 may be made by the member while in service; provided,  
15 that the member has at least ten (10) years of membership service [for members terminating on or](#)  
16 [before June 30, 2012, or at least five \(5\) years of membership service for members terminating on](#)  
17 [or after July 1, 2012](#), and before retirement, on a form prescribed by the retirement board. The  
18 election is based upon the amount of retirement allowances or actuarial equivalents that may  
19 accrue at the date of death of the member; provided, that the election form is executed and filed  
20 with the retirement board prior to the date of death. The election may be revoked or modified by  
21 the member at any time prior to the date of retirement, on a form prescribed by the retirement  
22 board; provided, that, during this time, the named beneficiary has not been divorced from the  
23 member. Upon death of a member making this election, the option selected becomes effective  
24 thirty (30) days after the first day of the calendar month following the date of death of the  
25 member if death occurs while in an employee status. Should death occur while in an inactive  
26 member status, the option selected under this section becomes payable on the first of the month  
27 succeeding that in which the designated beneficiary attains the age of sixty (60) years.

28 **45-21.2-22. Optional twenty year retirement on service allowance.** -- (a) The local

29 legislative bodies of the cities and towns may, by ordinance adopted, permit the retirement of a  
30 member on a service retirement allowance [for members retiring on or before June 30, 2012](#) as  
31 follows:

32 (1) Any member may retire pursuant to this section upon his or her written application to  
33 the board stating at what time he or she desires to retire; provided, that the member, at the  
34 specified time for his or her retirement, has completed at least twenty (20) years of total service,

1 and, notwithstanding that the member may have separated from service;

2 (2) Upon retirement from service pursuant to subdivision (1), a member receives a  
3 retirement allowance which is a life annuity terminable at the death of the annuitant, and is equal  
4 to two and one-half percent (2 1/2%) of final compensation multiplied by the years of total  
5 service, but not to exceed seventy-five percent (75%) of final compensation;

6 (3) Upon the adoption of a service retirement allowance, pursuant to this subdivision,  
7 each member contributes an amount equal to one percent (1%) more than that contribution  
8 required under § 45-21.2-14;

9 (4) This section is exempt from the provisions of chapter 13 of this title.

10 (b) For members retiring on or after July 1, 2012, the member's retirement allowance  
11 shall equal the sum of (i) and (ii) where (i) is the member's benefit calculated under (a)(1)-(4)  
12 above or section 45-21.2-5 for service on and before June 30, 2012 and (ii) is the member's  
13 benefit determined under section 45-21.2-6 for service on and after July 1, 2012. For service on  
14 and after July 1, 2012, the provisions of (a)(3) above shall no longer apply.

15 **45-21.2-22.1. Burrillville police – Optional twenty-year retirement on service**  
16 **allowance.** -- (a) Notwithstanding § 45-21.2-22, the town council of the town of Burrillville, may  
17 by ordinance adopted, permit the retirement of a member on a service retirement allowance for  
18 members retiring on or before June 30, 2012, as follows:

19 (1) Any member may retire pursuant to this section upon his or her written application to  
20 the board stating at what time he or she desires to retire; provided, that the member, at the  
21 specified time of his or her retirement, has completed at least twenty (20) years of total service;

22 (2) Upon retirement from service, pursuant to subdivision (1), a member receives a  
23 retirement allowance that is a life annuity terminable at the death of the annuitant, and is equal to  
24 three percent (3%) of final compensation multiplied by the years of total service, but not to  
25 exceed sixty percent (60%) of final compensation;

26 (3) Upon retirement from service where member has in excess of twenty (20) years of  
27 service, a member receives a retirement allowance that is a life annuity terminable at the death of  
28 the annuitant, and is an amount equal to the sum of three percent (3%) of final compensation  
29 multiplied by the first twenty (20) years of service and one and one-half percent (1.5%) of final  
30 compensation multiplied by the years of service in excess of twenty (20) years. The annual  
31 retirement allowance in no event shall exceed seventy-five percent (75%) of final compensation;

32 (4) Upon the adoption of a service retirement allowance, pursuant to this section, each  
33 member shall contribute an amount equal to ten and two-tenths percent (10.2%) of the salary or  
34 compensation earned or accrued to the member;

1 (5) Notwithstanding anything to the contrary hereinabove, any member who retires with  
2 less than twenty (20) years of service shall be subject to § 45-21.2-6 for purposes of determining  
3 any service retirement allowance;

4 (6) This section is exempt from the provisions of chapter 13 of this title;

5 (7) Except as specifically set forth hereinabove, all other provisions of chapter 21.2 of  
6 this title shall be applicable to Burrillville police officers who make application to retire.

7 (b) For members retiring on or after July 1, 2012, the member's retirement allowance  
8 shall equal the sum of (i) and (ii) where (i) is the member's benefit calculated under (a)(1)  
9 through (a)(7) above for service on and before June 30, 2012 and (ii) is the member's benefit  
10 determined under section 45-21.2-6 for service on and after July 1, 2012. For service on and after  
11 July 1, 2012, the provisions of (a)(4) above shall no longer apply.

12 **45-21.2-25. Severability.--** The holding of any section or sections or parts of this chapter  
13 to be void, ineffective, or unconstitutional for any cause shall not be deemed to affect any other  
14 section or part hereof.

15 SECTION 13. Sections 42-28-5, 42-28-21, 42-28-22, 42-28-22.1, 42-28-22.2, 42-28-22.3  
16 and 42-28-23 of the General Laws in Chapter 42-28 entitled "State Police" are hereby amended to  
17 read as follows:

18 **42-28-5. Superintendent – Appointment, tenure, duties, and retirement. --** (a) The  
19 governor shall appoint the superintendent of state police, who shall serve at the pleasure of the  
20 governor and shall perform the duties prescribed by this chapter.

21 (b) Any superintendent who has served for at least ten (10) years and has reached the age  
22 of sixty (60) years, may resign his or her office, and thereafter shall receive annually during his or  
23 her life a sum equal to fifty percent (50%) of the salary he or she was receiving at the time of his  
24 or her resignation, or for any superintendant hired on or after July 1, 2012 a sum equal to fifty  
25 percent (50%) of the average compensation as defined in 36-8-1(5)(a) he or she was receiving at  
26 the time of his or her resignation.

27 (c) In no event shall the retirement allowance granted to a superintendent in accordance  
28 with subsection (b) plus any other retirement allowance received by the superintendent from any  
29 state or municipal retirement system exceed seventy-five percent (75%) of the average  
30 compensation as defined in 36-8-1(5)(a) he or she was receiving at the time of his or her  
31 resignation. This subsection (c) shall only apply to superintendents hired on or after July 1, 2012.

32 **42-28-8. Clerk of division. --** The superintendent may employ a clerk who shall be a  
33 competent stenographer, and the general assembly shall annually appropriate such sum as it may  
34 deem necessary for the payment of the salary of the clerk. The clerk shall be numbered among the

1 personnel of the division within the meaning of §§ 42-28-21 and 42-28-22. Any clerk hired on or  
2 after July 1, 2012 shall be considered a civilian employee in accordance with the provisions of  
3 42-28-22(g).

4 **42-28-21. Injury and death benefits.** -- (a) If any member of the division whose service  
5 is terminated on or after January 1, 1960 shall have in the course of performance of his or her  
6 duties suffered injury causing disability or causing death, that member or his or her surviving  
7 dependent relatives, whose dependence shall be determined from time to time by the  
8 superintendent subject to confirmation by the governor, shall be entitled to an annual pension of  
9 seventy-five percent (75%) of the annual salary paid to that member at the time of his or her  
10 termination of service by reason of injury or death. In the event that the member thus disabled or  
11 killed in the performance of his or her official duties is the superintendent, then confirmation and  
12 determination provided by this section shall be made by the governor. The provisions of chapters  
13 29 – 38, inclusive, of title 28, shall not apply to members of the division.

14 (b) Upon the death of a member due to any cause other than that incurred while in the  
15 course of performance of his or her duties, occurring while in service or after retirement, if that  
16 member shall have rendered at least ten (10) years of service as a member of the Rhode Island  
17 state police, his or her surviving widow or domestic partner shall be entitled to a pension equal to  
18 two percent (2%) of his or her last annual salary as determined by the provision of § 42-28-22 as  
19 amended herein for each year of service as a member of the state police, subject to a minimum  
20 pension of twenty-five percent (25%) of salary, and subject to the following conditions:

21 (1) The widow or widower or domestic partner shall have been married to or a domestic  
22 partner of the member at least one year on the date of death of the member or on the date of  
23 retirement, whichever first occurs, and in any event while the member was in active service;

24 (2) ~~the~~ The widow or widower or domestic partner shall be at least forty (40) years of  
25 age, otherwise payment of the annuity shall be deferred until she attains such age;

26 (3) ~~the~~ The annuity shall terminate in any event when he or she remarries or enters into a  
27 domestic partnership or dies.

28 (c) If a widow or widower or domestic partner shall have minor children in his or her  
29 care, payment of the annuity shall commence immediately regardless of whether the widow or  
30 widower or domestic partner shall have attained age forty (40) years or not. In such a case, the  
31 payment to the widow or widower or domestic partner shall be increased one-third (1/3) on  
32 account of each minor child, provided that the maximum payment shall be fifty percent (50%) of  
33 annual salary.

34 (d) Allowances on account of minor children shall terminate upon their attainment of age

1 eighteen (18) and if unemancipated and a full-time student to age twenty-two (22) years, death, or  
2 marriage, whichever first occurs. In the event a widow or widower or domestic partner remarries  
3 or enters into a domestic partnership or dies, payment on account of minor children shall be  
4 increased to twice the amounts previously payable on account of the children, subject to a  
5 combined payment to all children equal to fifty percent (50%) of the final salary of the member.

6 (e) For purposes of this chapter, "domestic partner" shall be defined as a person who,  
7 prior to the decedent's death, was in an exclusive, intimate and committed relationship with the  
8 decedent, and who certifies by affidavit that their relationship met the following qualifications:

9 (1) Both partners were at least eighteen (18) years of age and were mentally competent to  
10 contract;

11 (2) Neither partner was married to anyone else;

12 (3) Partners were not related by blood to a degree which would prohibit marriage in the  
13 state of Rhode Island;

14 (4) Partners resided together and had resided together for at least one year at the time of  
15 death; and

16 (5) Partners were financially interdependent as evidenced by at least two (2) of the  
17 following:

18 (i) Domestic partnership agreement or relationship contract;

19 (ii) Joint mortgage or joint ownership of primary residence;

20 (iii) Two (2) of: (A) joint ownership of motor vehicle; (B) joint checking account; (C)  
21 joint credit account; (D) joint lease; and/or

22 (iv) The domestic partner had been designated as a beneficiary for the decedent's will,  
23 retirement contract or life insurance.

24 (f) Effective July 1, 2012, any reference in this section to "salary" or "annual salary"  
25 shall be changed to "average compensation" as defined in 36-8-1(5)(a).

26 **42-28-22. Retirement of members.** -- (a) Whenever any member of the state police  
27 hired prior to July 1, 2007 has served for twenty (20) years, he or she may retire therefrom or he  
28 or she may be retired by the superintendent with the approval of the governor, and in either event  
29 a sum equal to one-half (1/2) of the whole salary for the position from which he or she retired  
30 determined on the date he or she receives his or her first retirement payment shall be paid him or  
31 her during life.

32 (b) For purposes of this section, the term "whole salary" means:

33 (1) For each member who retired prior to July 1, 1966, "whole salary" means the base  
34 salary for the position from which he or she retired as the base salary for that position was

1 determined on July 31, 1972;

2 (2) For each member who retired between July 1, 1966 and June 30, 1973, "whole salary"  
3 means the base salary for the position from which he or she retired as the base salary,  
4 implemented by the longevity increment, for that position was determined on July 31, 1972 or on  
5 the date of his or her retirement, whichever is greater;

6 (3) For each member who retired or who retires after July 1, 1973 "whole salary" means  
7 the base salary, implemented by the longevity increment, holiday pay, and clothing allowance, for  
8 the position from which he or she retired or retires.

9 (c)(1) Any member who retired prior to July 1, 1977 shall receive a benefits payment  
10 adjustment equal to three percent (3%) of his or her original retirement, as determined in  
11 subsection (b) of this section, in addition to his or her original retirement allowance. In each  
12 succeeding year thereafter during the month of January, the retirement allowance shall be  
13 increased an additional three percent (3%) of the original retirement allowance, not compounded,  
14 to be continued until January 1, 1991. For the purposes of the computation, credit shall be given  
15 for a full calendar year regardless of the effective date of the service retirement allowance. For  
16 purposes of this subsection, the benefits payment adjustment shall be computed from January 1,  
17 1971 or the date of retirement, whichever is later in time.

18 (2) Any member of the state police who retires pursuant to the provisions of this chapter  
19 on or after January 1, 1977, shall on the first day of January, next following the third anniversary  
20 date of the retirement receive a benefits payment adjustment, in addition to his or her retirement  
21 allowance, in an amount equal to three percent (3%) of the original retirement allowance. In each  
22 succeeding year thereafter during the month of January, the retirement allowance shall be  
23 increased an additional three percent (3%) of the original retirement allowance, not compounded,  
24 to be continued until January 1, 1991. For the purposes of the computation, credit shall be given  
25 for a full calendar year regardless of the effective date of the service retirement allowance.

26 (3) Any retired member of the state police who is receiving a benefit payment adjustment  
27 pursuant to subdivisions (1) and (2) of this section shall beginning January 1, 1991 and ending  
28 June 30, 2012, receive a benefits payment adjustment equal to fifteen hundred dollars (\$1,500). ~~In~~  
29 ~~each succeeding year thereafter during the month of January, the retirement allowance shall be~~  
30 ~~increased by fifteen hundred dollars (\$1,500) to be continued during the lifetime of the member.~~

31 (d) The benefits payment adjustment as provided in this section shall apply to and be in  
32 addition to the retirement benefits under the provisions of § 42-28-5, and to the injury and death  
33 benefits under the provisions of § 42-28-21, ~~and to the death and disability payments as provided~~  
34 ~~in § 42-28-36.~~



1 (e)(1) Any member who retires after July 1, 1972 [and is eligible to retire prior to July 1,](#)  
2 [2012](#) and who has served beyond twenty (20) years shall be allowed an additional amount equal  
3 to three percent (3%) for each completed year served after twenty (20) years, but in no event shall  
4 the original retirement allowance exceed sixty-five percent (65%) of his or her whole salary as  
5 defined in subsection (b) hereof or sixty-five percent (65%) of his or her salary as defined in  
6 subsection (b) hereof in his or her twenty-fifth (25th) year whichever is less.

7 (2) Each member who retired prior to July 1, 1975, shall be entitled to all retirement  
8 benefits as set forth above or shall be paid benefits as set forth in subdivision (b)(1) with "whole  
9 salary" meaning the base salary for the position from which he or she retired as the base salary for  
10 the position was determined on July 1, 1975, whichever is greater.

11 (f)(1) Any member who retires, has served as a member for twenty (20) years or more,  
12 and who served for a period of six (6) months or more of active duty in the armed service of the  
13 United States or in the merchant marine service of the United States as defined in § 2 of chapter  
14 1721 of the Public Laws, 1946, may purchase credit for such service up to a maximum of two (2)  
15 years; provided that any member who has served at least six (6) months or more in any one year  
16 shall be allowed to purchase one year for such service and any member who has served a fraction  
17 of less than six (6) months in his or her total service shall be allowed to purchase six (6) months'  
18 credit for such service.

19 (2) The cost to purchase these credits shall be ten percent (10%) of the member's first  
20 year salary as a state policeman multiplied by the number of years and/or fraction thereof of such  
21 armed service up to a maximum of two (2) years. The purchase price shall be paid into the  
22 general fund. [For members hired on or after July 1, 1989, the purchase price shall be paid into a](#)  
23 [restricted revenue account entitled "state police retirement benefits" and shall be held in trust.](#)

24 (3) There will be no interest charge provided the member makes such purchase during his  
25 or her twentieth (20th) year or within five (5) years from May 18, 1981, whichever is later, but  
26 will be charged regular rate of interest as defined in § 36-8-1 as amended to date of purchase from  
27 the date of his or her twentieth (20th) year of state service or five (5) years from May 18, 1981,  
28 whichever is later.

29 (4) In no event shall the original retirement allowance exceed sixty-five percent (65%) of  
30 his or her whole salary as defined in subsection (b) hereof or sixty-five percent (65%) of his or  
31 her salary as defined in subsection (b) hereof in his or her twenty-fifth (25th) year, whichever is  
32 less.

33 (g) The provisions of this section shall not apply to civilian employees in the Rhode  
34 Island state police; and, further, from and after April 28, 1937, chapters 8 – 10, inclusive, of title



1 36 shall not be construed to apply to the members of the Rhode Island state police, except as  
2 provided by §§ 36-8-3, 36-10-1.1, 42-28-22.1, and 42-28-22.2, and section 36-8-1(5) and (8)(a)  
3 effective July 1, 2012.

4 (h) Any ~~other provision of the section notwithstanding any~~ member of the state police  
5 other than the superintendent of state police, who is hired prior to July 1, 2007 and who has  
6 served for twenty-five (25) years or who has attained the age of sixty-two (62) years, whichever  
7 shall first occur, shall retire therefrom.

8 (i)(1) Any ~~other provision of the section notwithstanding any~~ member of the state police,  
9 other than the superintendent, who is hired on or after July 1, 2007 and who has served for  
10 twenty-five (25) years, may retire therefrom or he or she may be retired by the superintendent  
11 with the approval of the governor, and shall be entitled to a retirement allowance of fifty percent  
12 (50%) of his or her "whole salary" as defined in subsection (b) hereof.

13 (2) Any member of the state police who is hired on or after July 1, 2007 may serve up to  
14 a maximum of thirty (30) years, and shall be allowed an additional amount equal to three percent  
15 (3.0%) for each completed year served after twenty-five (25) years, but in no event shall the  
16 original retirement allowance exceed sixty-five percent (65%) of his or her "whole salary" as  
17 defined in subsection (b) hereof.

18 (j) Effective July 1, 2012, any other provision of this section notwithstanding:

19 (j)(1) Any member of the state police, other than the superintendent of state police, who is  
20 not eligible to retire on or prior to June 30, 2012, may retire at any time subsequent to the date the  
21 member's retirement allowance equals or exceeds fifty percent (50%) of average compensation as  
22 defined in section 36-8-1(5)(a), provided that a member shall retire upon the first to occur of:

23 (i) The date the member's retirement allowance equals sixty-five percent (65%); or

24 (ii) The later of the attainment of age sixty-two (62) or completion of five (5) years of  
25 service; provided however, any current member as of June 30, 2012 who has not accrued fifty  
26 percent (50%) upon attaining the age of sixty-two (62) shall retire upon accruing fifty percent  
27 (50%); and upon retirement a member shall receive a retirement allowance which shall equal:

28 (A) For members hired prior to July 1, 2007 the sum of (i), (ii) and (iii) where

29 (i) Is calculated as the member's years of total service before July 1, 2012 multiplied by  
30 two and one half percent (2.5%) of average compensation for a member's first twenty (20) total  
31 years,

32 (ii) Is calculated as the member's years of total service before July 1, 2012 in excess of  
33 twenty (20) years not to exceed twenty-five (25) years multiplied by three percent (3%) of  
34 average compensation, and

1 (iii) Is the member's years of total service on or after July 1, 2012 multiplied by two  
2 percent (2%) of average compensation as defined in § 36-8-1(5)(a).

3 (B) For members hired on or after July 1, 2007, the member's retirement allowance shall  
4 be calculated as the member's years of total contributory service multiplied by two percent (2%)  
5 of average compensation.

6 (C) Any member of the state police who is eligible to retire on or prior to June 30, 2012  
7 shall retire with a retirement allowance calculated in accordance with paragraph (a) and (e) above  
8 except that whole salary shall be defined as final compensation where compensation for purposes  
9 of this section and section 42-28-22.1 includes only base salary, longevity and holiday pay.

10 (D) Notwithstanding the preceding provisions, in no event shall a member's final  
11 compensation be lower than his or her final compensation determined as of June 30, 2012.

12 (2) In no event shall a member's original retirement allowance under any provisions of  
13 this section exceed sixty-five percent (65%) of his or her average compensation.

14 (3) For each member who retires on or after July 1, 2012, except as provided in paragraph  
15 (j)(1)(C) above, compensation and average compensation shall be defined in accordance with §  
16 36-8-1(5)(a) and (8), provided that for a member whose regular work week exceeds one hundred  
17 forty-seven (147) hours over a twenty-four (24) day period at any time during the four (4) year  
18 period immediately prior to his/her retirement that member shall have up to four hundred (400)  
19 hours of his/her pay for regularly scheduled work earned during this period shall be included as  
20 "compensation" and/or "average compensation" for purposes of this section and section 42-28-  
21 22.1.

22 (4)(i) Notwithstanding the prior paragraphs of this section, and subject to paragraph (4)  
23 (ii) below, for all present and former members, active and retired members, and beneficiaries  
24 receiving any retirement, disability or death allowance or benefit of any kind, whether for or on  
25 behalf of a non-contributory member or contributory member, the annual benefit adjustment  
26 provided in any calendar year under this section shall be equal to (A) multiplied by (B) where (A)  
27 is equal to the percentage determined by subtracting five and one-half percent (5.5%) (the  
28 "subtrahend") from the Five-Year Average Investment Return of the retirement system  
29 determined as of the last day of the plan year preceding the calendar year in which the adjustment  
30 is granted, said percentage not to exceed four percent (4%) and not to be less than zero percent  
31 (0%), and (B) is equal to the lesser of the member's retirement allowance or the first twenty-five  
32 thousand dollars (\$25,000) of retirement allowance, such twenty-five thousand dollars (\$25,000)  
33 amount to be indexed annually in the same percentage as determined under (4)(i)(A) above. The  
34 "Five-Year Average Investment Return" shall mean the average of the investment returns for the

1 most recent five plan years as determined by the retirement board. Subject to paragraph (4)(ii)  
2 below, the benefit adjustment provided by this paragraph shall commence upon the third (3rd)  
3 anniversary of the date of retirement or the date on which the retiree reaches age fifty-five (55),  
4 whichever is later. In the event the retirement board adjusts the actuarially assumed rate of return  
5 for the system, either upward or downward, the subtrahend shall be adjusted either upward or  
6 downward in the same amount.

7 (ii) Except as provided in paragraph (4)(iii), the benefit adjustments under this section for  
8 any plan year shall be suspended in their entirety unless the GASB Funded Ratio of the  
9 Employees' Retirement System of Rhode Island, the Judicial Retirement Benefits Trust and the  
10 State Police Retirement Benefits Trust, calculated by the system's actuary on an aggregate basis,  
11 exceeds eighty percent (80%) in which event the benefit adjustment will be reinstated for all  
12 members for such plan year.

13 In determining whether a funding level under this paragraph (4)(ii) has been achieved, the  
14 actuary shall calculate the funding percentage after taking into account the reinstatement of any  
15 current or future benefit adjustment provided under this section. "GASB Funded Ratio" shall  
16 mean the ratio of the actuarial value of assets to the actuarial accrued liability.

17 (iii) Notwithstanding paragraph (4)(ii), in each fifth plan year commencing after June 30,  
18 2012 commencing with the plan year ending June 30, 2017, and subsequently at intervals of five

26 be in addition to the retirement benefits under the provisions of section 42-28-5 and to the injury  
27 and death benefits under the provisions of section 42-28-21.

28 (5) Any member with contributory service on or after July 1, 2012, who has completed at  
29 least five (5) years of contributory service but who has not retired in accordance with (j)(1)  
30 above, shall be eligible to retire upon the attainment of member's Security retirement age as  
31 defined in 36-8-1(19).

32 (6) In no event shall a member's retirement allowance be less than the member's  
33 retirement allowance calculated as of June 30, 2012 based on the member's years of total service  
34 and whole salary as of June 30, 2012.

1           ⊕ (k) In calculating the retirement benefit for any member, the term base salary as used  
2 in subdivision (b)(3) or average compensation as used in paragraph (j) shall not be affected by a  
3 deferral of salary plan or a reduced salary plan implemented to avoid shutdowns or layoffs or to  
4 effect cost savings. Basic salary shall remain for retirement calculation that which it would have  
5 been but for the salary deferral or salary reduction due to a plan implemented to avoid shutdowns

5 **42-28-22.3. Separate plan and trust for retirement program of state police.** -- (a) The  
6 retirement program established by § 42-28-22.1 shall constitute a separate retirement program  
7 known as the "State Police Retirement Program" which shall be deemed to be a separate plan for  
8 purposes of § 401(a) of the Internal Revenue Code of 1986 [26 U.S.C. § 401(a)], as amended.  
9 The provisions of § 36-8-20(a) – ~~(h)~~(i) shall be applicable to such program, shall be administered  
10 and interpreted in a manner consistent with maintaining the tax qualification of such program,  
11 and shall supercede any conflicting provision of law.

12 (b) Any trust established for the purpose of providing retirement benefits under the state  
13 police retirement program, including the trust described in § 42-28-22.1, shall be maintained  
14 pursuant to a written document which expressly provides that it shall be impossible at any time

14 spouse or domestic partner shall receive annually thereafter, during his or her lifetime and so long  
15 as he or she remains unmarried or not in a domestic partnership, one-third ( 1/3) of the annual

27 ~~(e)~~(e) Whenever a justice of any of the courts who was engaged as a judge on or after  
28 January 1, 2009, shall die without having become eligible to retire either under § 8-3-7 or 8-3-8  
29 and has served seven (7) years or more in office, his or her surviving spouse or domestic partner  
30 shall receive annually thereafter, during his or her lifetime and so long as he or she remains  
31 unmarried or not in a domestic partnership, one-third (1/3) of the annual salary that the justice  
32 was receiving at the time of his or her death.

33 ~~(e)~~(f) Whenever a justice of the courts who was engaged as a judge on or after January 1,  
34 2009, shall die without having become eligible to retire either under § 8-3-7 or 8-3-8 and has not

4 (2) below, for all present and former justices, active and retired justices, and beneficiaries  
5 receiving any retirement, disability or death allowance or benefit of any kind, whether provided  
6 for or on behalf of justices engaged on or prior to December 31, 1989 as a non-contributory  
7 justice or engaged after December 31, 1989 as a contributory justice, the annual benefit  
8 adjustment provided in any calendar year under this section shall be equal to (A) multiplied by  
9 (B) where (A) is equal to the percentage determined by subtracting five and one-half percent

15 defined in section 36-8-1(8) an amount equal to the percent of compensation in effect on June 30,  
16 2012. Proceeds deposited shall be held in trust for the purpose of paying retirement benefits to  
17 participating judges or their beneficiaries. The retirement board shall establish rules and

20 any reason other than retirement, shall be paid on demand a refund consisting of the accumulated

17 SECTION 16. Section 8-8-10.1 of the General Laws in Chapter 8-8 entitled "District  
18 Court" is hereby amended to read as follows:

20 have deducted from total salary beginning December 31, 1989 and ending June 30, 2012 an  
21 amount equal to a rate percent of compensation as specified in § 36-10-1 relating to member

26 retirement benefits". Proceeds deposited in this account shall be held in trust for the purpose of

29 (b) A member of the judiciary who withdraws from service or ceases to be a member for  
30 any reason other than retirement shall be paid on demand a refund consisting of the accumulated

32 retirement benefits account. Any member receiving a refund shall thereby forfeit and relinquish  
33 all accrued rights as a member of the system together with credits for total service previously

32 (b) A judge of the administrative adjudication court reassigned by this chapter to the  
33 traffic tribunal who withdraws from service or ceases to be a member for any reason other than  
34 death or retirement, shall be paid on demand a refund consisting of the accumulated contributions

1 standing to his or her credit in his or her individual account in the administrative adjudication  
2 retirement benefits account. Any member receiving a refund shall thereby forfeit and relinquish

8 restoration. Upon the repayment of the refund as herein provided, such member shall again  
9 receive credit for the amount of total service which he or she had previously forfeited by the  
10 acceptance of the refund.

11 ~~(b)~~(c) Whenever any judge of the administrative adjudication court dies from any cause  
12 before retirement and has no surviving spouse or domestic partner or minor child(ren), a payment  
13 shall be made of the accumulated contributions standing to his or her credit in his or her  
14 individual account in the administrative adjudication court judges' retirement account. The  
15 payment of the accumulated contributions of the judge shall be made to such person as the judge  
16 shall have nominated by written designation duly executed and filed with the retirement board, or  
17 if the judge has no filed nomination, or if the person so nominated has died, then to the estate of  
18 the deceased judge.

19 **8-8.2-12. Additional benefits payable to retired judges and their surviving spouses**  
20 **or domestic partners.** -- (a) All judges of the administrative adjudication court and all judges of  
21 the administrative adjudication court who have been reassigned to the traffic tribunal, or their  
22 surviving spouses or domestic partners, who retire after January 1, 1970 and who receive a  
23 retirement allowance pursuant to the provisions of this title, shall, on the first day of January, next  
24 following the third anniversary of the retirement, receive a cost of living retirement adjustment in  
25 addition to his or her retirement allowance in an amount equal to three percent (3%) of the  
26 original retirement allowance. In each succeeding year thereafter during the month of January, the

3 retirement allowance, indexed annually, and shall commence upon the third (3rd) anniversary of  
4 the date of retirement or when the retiree reaches age sixty-five (65), whichever is later. The  
5 thirty-five thousand dollar (\$35,000) limit shall increase annually by the percentage increase in  
6 the Consumer Price Index for all Urban Consumer (CPI-U) as published by the United States

8 percent (3%), whichever is less. The first thirty-five thousand dollars (\$35,000), as indexed, of  
9 retirement allowance shall be multiplied by the percentage of increase in the Consumer Price

11 Statistics determined as of September 30 of the prior calendar year or three percent (3%),  
12 whichever is less on the month following the anniversary date of each succeeding year. For  
13 judges eligible to retire as of September 30, 2009 or eligible upon passage of this article, and for  
14 their beneficiaries, the provisions of this subsection (c) shall not apply.

15 (d)(1) Notwithstanding the prior paragraphs of this section, and subject to paragraph (d)  
16 (2) below, for all present and former justices, active and retired justices, and beneficiaries  
17 receiving any retirement, disability or death allowance or benefit of any kind, whether provided  
18 for or on behalf of justices engaged on or prior to December 31, 1989 as a non-contributory  
19 justice or engaged after December 31, 1989 as a contributory justice, the annual benefit  
20 adjustment provided in any calendar year under this section shall be equal to (A) multiplied by  
21 (B) where (A) is equal to the percentage determined by subtracting five and one-half percent  
22 (5.5%) (the “subtrahend”) from the Five-Year Average Investment Return of the retirement  
23 system determined as of the last day of the plan year preceding the calendar year in which the  
24 adjustment is granted, said percentage not to exceed four percent (4%) and not to be less than  
25 zero percent (0%), and (B) is equal to the lesser of the justice’s retirement allowance or the first  
26 twenty-five thousand dollars (\$25,000) of retirement allowance, such twenty-five thousand  
27 dollars (\$25,000) amount to be indexed annually in the same percentage as determined under  
28 (d)(1)(A) above. The “Five-Year Average Investment Return” shall mean the average of the  
29 investment return of the most recent five plan years as determined by the retirement board.  
30 Subject to paragraph (d)(2) below, the benefit adjustment provided by this paragraph shall  
31 commence upon the third (3rd) anniversary of the date of retirement or the date on which the

19 adjustment not granted on or prior to June 30, 2012.

20           SECTION 19. Sections 28-30-17, 28-30-18 and 28-30-18.1 of the General Laws in  
21 Chapter 28-30 entitled "Workers' Compensation Court" are hereby amended to read as follows:

22           **28-30-17. Allowance to surviving spouses, domestic partners of deceased judges. –**

23           (a) Whenever any judge of the workers' compensation court who was engaged as a judge prior to  
24 January 1, 2009 dies after retirement or during active service while eligible for retirement or  
25 during active service after having served fifteen (15) years or more in office, his or her surviving  
26 spouse or domestic partner shall receive annually thereafter during his or her lifetime and so long  
27 as he or she remains unmarried or not in a domestic partnership, an amount equal to one-half (  
28 1/2) of the annual payment that the judge was receiving by way of salary or retirement pay at the  
29 time of his or her death.

30           (b) For those engaged as a judge on or after January 1, 2009, and prior to July 1, 2009,  
31 the judge may elect to receive retirement pay that is reduced by an additional ten percent (10%)  
32 of the average of the highest three (3) consecutive years annual compensation (i.e., ninety percent  
33 (90%) reduced to eighty percent (80%) or seventy percent (70%) reduced to sixty percent (60%))  
34 and where such option is exercised by giving the general treasurer notice in writing thereof within



1 ninety (90) days after the date of his or her retirement his or her surviving spouse or domestic

11 (i) Option 1. Upon the justice's death, the justice's lesser retirement allowance shall be  
12 continued throughout the life of and paid to such person having an insurable interest in the  
13 justice's life, as the judge shall nominate by written designation duly acknowledged and filed with  
14 the retirement board at the time of his or her retirement.

15 (ii) Option 2. Upon the justice's death, one-half (1/2) of the judge's lesser retirement  
16 allowance shall be continued throughout the life of and paid to such person, having an insurable  
17 interest in the judge's life, as the judge shall nominate by written designation duly acknowledged  
18 and filed with the retirement board at the time of the beneficiary's retirement.

19 (2) For purposes of any election under this section the judge may designate more than  
20 one person to receive benefits after his or her death, provided that the designation shall specify  
21 the portion of the actuarial equivalent of the judge's retirement allowance to be paid to each  
22 person, and provided further that the aggregate actuarial value of the portions shall not exceed the  
23 actuarial equivalent of the judge's retirement benefit determined in the case of an election under  
24 this section as of the date of the judge's retirement.

25 (3) A judge selecting more than one person to receive benefits under this section may  
26 only select beneficiaries from among his or her children, adopted children, step-children, and/or  
27 spouse or domestic partner.

28 ~~(e)~~(d) Whenever a judge of the workers' compensation court dies without having become  
29 eligible to retire either under § 28-30-15 or 28-30-16 and has served seven (7) years or more in  
30 office, his or her surviving spouse or domestic partner shall receive annually thereafter during his  
31 or her lifetime and so long as he or she remains unmarried or not in a domestic partnership one-  
32 third ( 1/3) of the annual salary that the judge was receiving at the time of his or her death.

33 ~~(d)~~(e) Whenever any judge of the workers' compensation court who was engaged as a  
34 judge on or after January 1, 2009 dies during active service while eligible for retirement or during



1 active service after having served fifteen (15) years or more in office, his or her surviving spouse  
2 or domestic partner shall receive annually thereafter during his or her lifetime and so long as he  
3 or she remains unmarried or not in a domestic partnership, an amount equal to one-half (1/2) of  
4 the annual payment that the judge was receiving by way of salary or retirement pay at the time of  
5 his or her death.

6 ~~(e)~~(f) Whenever a judge of the workers' compensation court dies without having become  
7 eligible to retire either under § 28-30-15 or 28-30-16 and has not served seven (7) years in office,  
8 his or her surviving spouse or domestic partner shall subsequently receive annually during his or  
9 her lifetime and so long as he or she remains unmarried or not in a domestic partnership, one  
10 fourth ( 1/4) of the annual salary that the judge was receiving at the time of his or her death.

11 ~~(f)~~(g) In the event the deceased judge has no surviving spouse or domestic partner or the  
12 surviving spouse or domestic partner predeceases their minor children, the benefits conferred by  
13 this section shall be received in equal shares by the minor children, if any, until each attains the  
14 age of twenty-one (21) years.

15 **28-30-18 Additional benefits payable to retired judges and their surviving spouses**

16 **or domestic partners.** -- (a) All judges of the workers' compensation court, or their surviving  
17 spouses or domestic partners, who retire after January 1, 1970 and who receive a retirement

13 (d) of Section 28-30-18 shall become effective July 1, 2012 and shall apply to any benefit  
14 adjustment not granted on or prior to June 30, 2012.

15 **28-30-18.1. Retirement contribution.** -- (a) Workers' compensation judges engaged  
16 after December 31, 1989, shall have deducted from total salary beginning December 31, 1989 and  
17 ending on June 30, 2012, an amount equal to a rate percent of compensation as specified in § 36-  
18 10-1 relating to member contributions to the state retirement system. Effective July 1, 2012, all  
19 active workers' compensation judges whether engaged before or after December 31, 1989, shall  
20 have deducted from compensation as defined in § 36-8-1(8) an amount equal to twelve percent  
21 (12%) of compensation. The receipts collected under this provision shall be deposited in a  
22 restricted revenue account entitled "workers' compensation judges' retirement benefits". Proceeds  
23 deposited in this account shall be held in trust for the purpose of paying retirement benefits to  
24 participating judges or their beneficiaries. The retirement board shall establish rules and  
25 regulations to govern the provisions of this section.

26 (b) A judge of the court who withdraws from service or ceases to be a judge for any  
27 reason other than retirement shall be paid on demand a refund consisting of the accumulated  
28 contributions standing to his or her credit in his or her individual account in the workers'  
29 compensation judges' retirement benefits account. Any judge receiving a refund shall forfeit and  
30 relinquish all accrued rights as a member of the system together with credits for total service  
31 previously granted to the judge; provided, that if any judge who has received a refund  
32 subsequently reenters the service and again becomes a member of the system, he or she shall have  
33 the privilege of restoring all money previously received or disbursed to his or her credit as refund  
34 of contributions, together with regular interest for the time period from the date of refund to the

1 [date of restoration](#). Upon the repayment of the refund, the judge shall again receive credit for the  
2 amount of total service that he or she had previously forfeited by the acceptance of the refund.

3 (c) Whenever any judge of the workers' compensation court dies from any cause before  
4 retirement and has no surviving spouse, [domestic partner](#) or minor child(ren), a payment shall be  
5 made of the accumulated contributions standing to his or her credit in his or her individual  
6 account in the workers' compensation judges' retirement account. The payment of the  
7 accumulated contributions of the judge shall be made to such person as the judge shall have  
8 nominated by written designation duly executed and filed with the retirement board, or if the  
9 judge has filed no nomination, or if the person so nominated has died, then to the estate of the  
10 deceased judge.

11 SECTION 20. Chapter 28-30 of the General Laws entitled "Workers' Compensation  
12 Court" is hereby amended by adding the following section:

13 **28-30-25. Severability.--** [The holding of any section or sections or parts of this chapter to](#)  
14 [be void, ineffective, or unconstitutional for any cause shall not be deemed to affect any other](#)

16 SECTION 21. Section 23-4-5 of the General Laws in Chapter 23-4 entitled "Office of  
17 State Medical Examiners" is hereby amended to read as follows:

18 **23-4-5. Chief medical examiner – Assistants and other staff.** -- (a) The office shall be  
19 under the immediate supervision of a chief, who shall be known as the "chief medical examiner"  
20 and who shall be a physician licensed under the provisions of chapter 37 of title 5, and a qualified  
21 pathologist certified by the American Board of Pathology and who has had forensic training or  
22 experience. He or she shall be appointed by the director of health as shall the deputy chief  
23 medical examiner with the advice of the medical examiner's commission. The chief medical  
24 examiner shall be in the unclassified service and the deputy chief medical examiner shall be in the  
25 classified service.

26 (b) The chief medical examiner shall appoint, with the approval of the director of health,  
27 assistant medical examiners and shall hire other staff as necessary to carry out the provisions of  
28 this chapter.

29 (c) Persons employed full time at the time of enactment of this chapter within the  
30 division of medical examiners in the department of the attorney general shall be transferred to the  
31 office of state medical examiners with their former rights and privileges of employment. ~~and~~

3 SECTION 22. Title 45 of the General Laws entitled "TOWNS AND CITIES" is hereby  
4 amended by adding thereto the following chapter:

5 CHAPTER 64

6 RETIREMENT SECURITY ACT FOR LOCALLY ADMINISTERED PENSION FUNDS

7 **45-64-1. Short title.** -- This chapter shall be known as and may be cited as the “Pathway  
8 to Retirement Security for Locally Administered Pension Funds Act.”

9 **45-64-2. Purpose.** -- The purpose of this chapter is to provide retirement security to  
10 current and retired municipal employees by codifying standards to promote the sustainability and  
11 longevity of pension plans established and administered by municipalities.

12 **45-64-3. Legislative Findings.** -- It is the intention of the general assembly to begin the  
13 process of ensuring the sustainability of locally administered pension plans and to advance and  
14 maintain the long-term stability of such plans. The general assembly finds and declares that:

15 (1) Rhode Island law authorizes and empowers municipalities to administer their own  
16 municipal pension plans; currently, there are thirty-six (36) such plans administered by twenty-  
17 four (24) municipalities.

18 (2) According to a report by the Office of the Auditor General entitled *Pension and*  
19 *OPEB Plans Administered by Rhode Island Municipalities* (September 2011): “Many municipal  
20 pension plans are severely underfunded which presents the risk that sufficient funds will not be  
21 available to meet promised benefits to retirees. It also undermines the overall fiscal health of the  
22 plan’s sponsor.”

23 (3) It is in the best interests of individual employees, taxpayers, municipalities and the  
24 state itself to maintain viable and sustainable municipal public pension plans. These interests  
25 include:

26 Preserving a level of pension benefits that is, over the long term, reasonable for current  
27 and retired municipal employees and affordable for taxpayers;

28 Avoiding significant and unanticipated retirement benefit reductions, which could cause  
29 an increase in poverty among retired municipal employees and a resulting strain on state social  
30 services;

31 Maintaining investments in infrastructure and education on the state and local levels in  
32 lieu of diverting critical resources to satisfy pension obligations;

33 Preventing the financial downgrade of municipalities by rating agencies as a result of  
34 unfunded pension obligations, which would make it more difficult to access the capital markets

1 and increase the costs of borrowing;

2 Encouraging rating agencies, in recognition of the state's proactive approach toward  
3 financial discipline, to take positive credit actions on Rhode Island municipal bonds; and

4 Creating a more stable and well-managed environment in Rhode Island to attract new  
5 businesses and maintain and expand existing businesses, which will diminish the uncertainty and  
6 fiscal instability that accompany uncontrolled pension obligations.

7 (4) The first step in ensuring the viability and sustainability of local pension plans is to  
8 get an accurate analysis of the current condition and fiscal health of the individual plans.

9 **45-64-4. Definitions. --** As used in this chapter the following terms shall have the  
10 following meanings:

11 (1) "Actuarial experience study" means a report provided by an actuary that includes a  
12 recent discussion of plan experience, recommendations for actuarial assumptions and methods,  
13 and information about the actuarial impact of these recommendations on the liabilities and other  
14 key actuarial measures.

15 (2) "Annual actuarial valuation study" means a valuation of a locally administered plan  
16 completed by an actuary, and a certification based on that valuation indicating whether such plan  
17 is or is not in critical status, on an annual basis.

18 (3) "Critical status" means that, as determined by its actuary, as of the beginning of the  
19 plan year, a plan's funded percentage for such plan year is less than sixty percent (60%).

20 (4) "Locally administered plan" or "plan" means any defined benefit pension plan  
21 established by a municipality for its employees, other than: (a) A plan that is part of the  
22 Employees' Retirement System of Rhode Island as defined in chapter 36-8 or the Municipal  
23 Employees' Retirement System of Rhode Island as defined in chapter 45-21; or (b) A plan  
24 established by a municipality that has filed for bankruptcy protection pursuant to chapter 9 of title  
25 11 of the United States Code, a plan established by a municipality for which a receiver has been  
26 appointed pursuant to chapter 45-9 or a plan established by a municipality for which a fiscal  
27 overseer has been appointed pursuant to chapter 45-9.

28 (5) "Municipality" means any town or city in the State of Rhode Island, any city or town  
29 housing authority, fire, water, sewer district, regional school district or public building authority  
30 as established by chapter 14 of title 37.

31 **45-64-5. Actuarial valuation methodology. --** Actuarial methods used by the actuary in  
32 preparing an actuarial experience study or annual actuarial valuation shall be in compliance with  
33 accepted actuarial standards and applicable public pension accounting laws, rules and regulations.  
34 The actuary shall not, year to year, change actuarial methods for the sole purpose of achieving a

1 more favorable funding or fiscal result. Any actuarial study shall be made by the actuary in good  
2 faith and in accordance with accepted actuarial standards.

3 **45-64-6. Certification and notice requirements.** -- (1) Every municipality that  
4 maintains a locally administered plan shall submit its initial annual actuarial valuation study to  
5 the study commission created herein under section 45-64-8 on or before April 1, 2012, and for  
6 each plan year ending on or after December 31, 2012, within six (6) months of completing such  
7 plan year. The initial actuarial experience study shall be submitted to the study commission on or  
8 before April 1, 2012, and subsequent actuarial experience studies must be submitted to the study  
9 commission no less frequently than once every three (3) years.

10 (2) In any case in which an actuary certifies that a locally administered plan is in critical  
11 status for a plan year, the municipality administering such a plan shall, not later than thirty (30)  
12 business days following the certification, provide notification of the critical status to the  
13 participants and beneficiaries of the plan and to the general assembly, the governor, the general  
14 treasurer, the director of revenue, and the auditor general. Within one hundred eighty (180) days  
15 of sending the critical status notice, the municipality's legislative governing body shall submit to  
16 the study commission a reasonable alternative funding improvement plan to emerge from critical  
17 status.

18 (3) The state shall reimburse every municipality for fifty percent (50%) of the cost of  
19 undertaking its annual actuarial valuation study.

20 **45-64-7. Failure to comply.** -- (1) With respect to any municipality that fails to comply  
21 with the requirements of this chapter within the prescribed time, the general treasurer is  
22 authorized to withhold moneys due to the municipality from the state for any purpose other than  
23 education, including, but not limited to, municipal aid and other aid provided under sections 45-  
24 13-5.1, 45-13-12, 44-34.1-2, 44-13-13, 44-18-18.1, 44-18-36.1(b) and 42-63.1-3.

25 **45-64-8. Study commission.** -- A study commission for locally administered plans shall  
26 be established to review existing legislation and pension plan administrative practices and to  
27 make recommendations for the improved security and funding of locally administered plans and  
28 other post-retirement benefit obligations of cities and towns. The commission shall consist of  
29 fourteen (14) members: the director of the department of revenue, or his or her designee; who  
30 shall be the chair, the auditor general, one member each representing the department of  
31 administration, the general treasurer, the League of Cities and Towns and the Rhode Island Public  
32 Expenditures Council, and three (3) members appointed by the governor representing municipal  
33 police, fire and non-public safety employees. In addition, the Speaker of the House and President  
34 of the State Senate shall each appoint one member to the commission and then shall jointly select

1 and appoint one elected mayor from a city or town with a population greater than 50,000, one  
2 elected mayor from a city or town with a population less than 50,000 and one appointed town  
3 administrator.

4 **45-64-9. Severability; Indispensable Party. --** The holding of any section or sections or  
5 parts hereof to be void, ineffective, or unconstitutional for any cause shall not be deemed to affect  
6 any other section or part hereof. The state shall be an indispensable party in any action contesting  
7 the validity of this chapter.

8 SECTION 23. This act shall take effect upon passage.
