1 RESOLVED, That the special legislative commission created by resolution No. 139
2 passed by the House of Representatives at its January session, A.D. 2021, and approved March
3 25, 2021, entitled "HOUSE RESOLUTION CREATING A SPECIAL LEGISLATIVE
4 COMMISSION TO STUDY THE ENTIRE AREA OF LAND USE, PRESERVATION,
5 DEVELOPMENT, HOUSING, ENVIRONMENT, AND REGULATION" and as extended by
6 resolution No. 194 passed by the House of Representatives at its January session, A.D. 2022, and
7 approved March 24, 2022, entitled "HOUSE RESOLUTION EXTENDING THE REPORTING
8 AND EXPIRATION DATES OF THE SPECIAL LEGISLATIVE COMMISSION TO STUDY
9 THE ENTIRE AREA OF LAND USE, PRESERVATION, DEVELOPMENT, HOUSING,
10 ENVIRONMENT, AND REGULATION" is hereby authorized to continue its study and make a
11 report to the House of Representatives on or before June 8, 2025, and said commission shall

15 to be submitted to the Speaker of the House by July 1, 2023; and be it further

16 RESOLVED, That the time for reporting authorized by resolution No. 139 passed by the
17 House of Representatives at its January session, A.D. 2021, and approved March 25, 2021, and as
18 extended by resolution No. 194 passed by the House of Representatives at its January session,

1 A.D. 2022, and approved March 24, 2022, be and the same is hereby rescinded.
