MAKING THE TRANSFER OF FUNDS FROM THE BUDGET FOR FISCAL YEAR 2025
CONTAINED IN THE BUDGET SUBMITTED BY THE GOVERNOR (2024-H7225) TO THE
TOWNS OF TIVERTON, BURRILLVILLE AND MIDDLETOWN

1 WHEREAS, The Town of Tiverton's allocation for education funding was reduced by
2 approximately one million, one hundred thousand dollars (\$1,100,000) in the 2025 fiscal year
3 budget pursuant to the provisions of Article 8 in the Governor's budget; and

4 WHEREAS, The Town of Burrillville's allocation for education funding was reduced by
5 approximately four hundred sixty-six thousand, four hundred and forty-seven dollars (\$466,447)
6 in the 2025 fiscal year budget pursuant to the provisions of Article 8; and

7 WHEREAS, The Town of Middletown's allocation for education funding was reduced by
8 approximately six hundred eighteen thousand, seven hundred twenty-eight dollars (\$618,728) in
9 the 2025 fiscal year budget pursuant to the provisions of Article 8; now, therefore be it

10 RESOLVED, That there is hereby transferred from the funds allocated to public charter
11 schools the sum of one million two hundred thousand dollars (\$1,200,000) to be reallocated as six
12 hundred thousand dollars (\$600,000) for education aid to the town of Tiverton, the sum of three
13 hundred thousand dollars (\$300,000) for education aid to the town of Burrillville and the sum of
14 three hundred thousand dollars (\$300,000) for education aid to the town of Middletown pursuant
15 to the distribution of funds pursuant to the state funding formula set forth in chapter 7 of title 16.

1 This resolution would authorize the transfer of funds to the Town of Tiverton, the Town

4 Tiverton and the sum of three hundred thousand dollars (\$300,000) each for Burrillville and
5 Middletown.
