RELATING TO INSURANCE -- ACCIDENT AND SICKNESS INSURANCE POLICIES

It is enacted by the General Assembly as follows:

- 1 SECTION 1. Chapter 27-18 of the General Laws entitled "Accident and Sickness Insurance
- 2 Policies" is hereby amended by adding thereto the following section:
- 3 <u>27-18-95. Acute mental health crisis mobile response and stabilization services.</u>
- 4 (a) Mobile response and stabilization services are services delivered to provide rapid
- 5 response to, assessment of, and early intervention for individuals experiencing an acute mental
- 6 <u>health crisis. Symptoms might include, but are not limited to:</u>
- 7 <u>(1) Aggression;</u>
- 8 <u>(2) Self-injury;</u>
- 9 <u>(3) Trauma;</u>
- 10 (4) Acute depression/anxiety;
- 11 (5) Challenges at school;
- 12 (6) Suicidal or homicidal thoughts/behaviors; and
- 13 (7) Extreme parent/child conflict.
- 14 (b) Coverage is required under this section for mobile response and stabilization services
- 15 provided to any individual enrolled as a plan beneficiary as with any other behavioral health
- 16 <u>services covered in any other settings or modalities, regardless of any difference in billing codes.</u>
- 17 SECTION 2. Chapter 27-19 of the General Laws entitled "Nonprofit Hospital Service
- 18 Corporations" is hereby amended by adding thereto the following section:
- 19 <u>27-19-87. Acute mental health crisis mobile response and stabilization services.</u>

2	response to, assessment of, and early intervention for individuals experiencing an acute mental
3	health crisis. Symptoms might include, but are not limited to:

14	SECTION 3. Chapter 27-20 of the General Laws entitled "Nonprofit Medical Service
15	Corporations" is hereby amended by adding thereto the following section:
16	27-20-83. Acute mental health crisis mobile response and stabilization services.
17	(a) Mobile response and stabilization services are services delivered to provide rapid
18	response to, assessment of, and early intervention for individuals experiencing an acute mental
19	health crisis. Symptoms might include, but are not limited to:
20	(1) Aggression;
21	(2) Self-injury;
22	<u>(3) Trauma:</u>
23	(4) Acute depression/anxiety:
24	(5) Challenges at school;
25	(6) Suicidal or homicidal thoughts/behaviors; and
26	(7) Extreme parent/child conflict.
27	(b) Coverage is required under this section for mobile response and stabilization services
28	provided to any individual enrolled as a plan beneficiary as with any other behavioral health
29	services covered in any other settings or modalities, regardless of any difference in billing codes.
30	SECTION 4. Chapter 27-41 of the General Laws entitled "Health Maintenance
31	Organizations" is hereby amended by adding thereto the following section:
32	27-41-100. Acute mental health crisis mobile response and stabilization services.
33	(a) Mobile response and stabilization services are services delivered to provide rapid

- 1 <u>health crisis. Symptoms might include, but are not limited to:</u>
- 2 (1) Aggression; 3 (2) Self-injury; 4 (3) Trauma; 5 (4) Acute depression/anxiety; 6 (5) Challenges at school; 7 (6) Suicidal or homicidal thoughts/behaviors; and 8 (7) Extreme parent/child conflict. 9 (b) Coverage is required under this section for mobile response and stabilization services 10 provided to any individual enrolled as a plan beneficiary as with any other behavioral health 11 services covered in any other settings or modalities, regardless of any difference in billing codes.
- 12 SECTION 5. This act shall take effect on January 1, 2025.
