She worked most of her professional career as the managing partner of the 10 Coast Guard House Restaurant before she accepted the position as the Director of the 11 Narragansett Chamber of Commerce; and 12 WHEREAS, To the good fortune of the citizens of South Kingstown, Deborah Kelso was 13 elected to two terms on the South Kingstown Town Council where she served with abiding 14 integrity and shined a light on the important issues the Town was facing; and 15 WHEREAS, Mrs. Kelso was heavily involved in civic affairs for her entire life and was 16 always giving back to the community. She was a member of the Narragansett Lions Club for 17 many years, and was an elected member of the Rhode Island Democratic Committee. She was a tireless advocate in support of social justice causes and believed in true equality for everyone; and 18 19 WHEREAS, Deborah Kelso leaves behind her children, Carrie Kelly and her husband,
