It is enacted by the General Assembly as follows:

1 SECTION 1. As previously authorized by a vote of the electors of the town at the financial

town meeting held on May 2, 2022 and Rhode Island General Laws § 45-12-2, the Town of New

3 Shoreham was empowered to issue bonds to an amount not exceeding ten million four hundred

4 thousand dollars (\$10,400,000), from time to time to finance additions, renovations, improvements,

5 alterations and repairs to schools and school facilities in the Town.

6 SECTION 2. In accordance with section 16-7-44 of the general laws, the principal and

7 interest on such bonds shall be eligible for state housing aid reimbursement.

SECTION 3. This act serves as the enabling act required by Rhode Island General Laws §

9 16-7-44 and shall take effect upon passage.
