It is enacted by the General Assembly as follows:

| 1 | SECTION 1. Title 40 of the General Laws entitled "HUMAN SERVICES" is hereby |

| 4 | RHODE ISLAND MEALS ON WHEELS INC. FUND |
| 5 | 40-23-1. Rhode Island Meals on Wheels Inc. Fund established. |
| 6 | (a) There is hereby established a separate fund within the general fund to be called the |
| 7 | Rhode Island Meals on Wheels Inc. Fund, which shall be administered by the general treasurer in |
| 8 | accordance with the same laws and fiscal procedures as the general fund of the state. The fund shall |
| 9 | consist of sums collected as a result of the taxpayer check-off as provided for in chapter 30 of title |
| 10 | 44. The general treasurer is authorized to accept any grant, devise, bequest, donation, gift, or |
| 11 | assignment of money, bonds, or other valuable securities for deposit in and credit of the Rhode |
| 12 | Island Meals on Wheels Inc. Fund. |
| 13 | (b) The monies received under this chapter and § 44-30-2.13 shall be made available by |
| 14 | the treasurer annually by September 30 to the Rhode Island Meals on Wheels Inc. Fund. |
| 15 | (c) Upon distribution, the monies shall be used exclusively for those individuals and/or |
| 16 | families who are eligible. |
| 17 | (d) The director of the department of health is hereby authorized to promulgate any rules |
| 18 | or regulations and prescribe forms necessary to facilitate the provisions of this chapter. |
| 19 | SECTION 2. Chapter 44-30 of the General Laws entitled "Personal Income Tax" is hereby |

| 2 | 44-30-2.13. Refund deduction for contribution to the Meals on Wheels Inc. Fund. |
| 3 | (a) There shall be provided as a deduction from any refund from the Rhode Island personal |
| 4 | income tax otherwise due to a taxpayer for a taxable year a contribution to the Meals on Wheels |
| 5 | Inc. Fund established in chapter 23 of title 40. The provision for the contribution shall appear on |
| 6 | the state personal income tax return as follows: |
| 7 | Meals on Wheels Inc. Fund. Check if you wish to contribute () (write in amount of your |
| 8 | tax REFUND for this program). |
| 9 | (b) The tax administrator shall annually forward by August 1 all contributions made to the |
| 10 | Meals on Wheels Inc. Fund to the general treasurer to be deposited in the fund and the treasurer |
| 11 | shall annually distribute the proceeds of said fund as provided in chapter 23 of title 40. |
| 12 | (c) The provisions of this section shall commence for returns filed for the tax year ending |
| 13 | <u>December 31, 2025.</u> |
| 14 | SECTION 3. This act shall take effect upon passage. |
