1 WHEREAS, The citizens of Rhode Island will come together on April 1, 2025, to 2 participate in 401Gives, the state's largest single day of giving, with the goal of raising over \$4.01 million to support Rhode Island's nonprofit community; and 3 WHEREAS, 401Gives provides a powerful platform for nonprofits to share their stories 4 while offering every Rhode Islander the opportunity to contribute to the well-being of their 5 neighbors by supporting causes that strengthen our communities; and 6 7 WHEREAS, Rhode Island's nonprofit sector is an essential driver of the state's economy and social fabric, employing 18% of the workforce, providing critical services that keep families 8 9 safe, protect the environment, care for seniors, educate children, shelter animals, and support arts 10 and culture; and 11 WHEREAS, During times of crisis, including natural disasters and public health 12 emergencies, Rhode Island's nonprofits are on the front lines, responding to the urgent needs of 13 individuals and families with unwavering commitment and compassion; and 14 WHEREAS, 401Gives shines a spotlight on the transformative work of over 600 local 15 nonprofit organizations, ensuring that their vital contributions to the state are recognized and 16 financially supported; and 17 WHEREAS, 401Gives is powered by the Alliance for Nonprofit Impact at United Way of 18 Rhode Island, with the generous support of sponsors such as Papitto Opportunity Connection, Blue Cross Blue Shield of Rhode Island, the Rhode Island Foundation, Rhode Island Energy, and 19 many others who have committed matching funds to amplify giving and philanthropic 20
