RELATING TO FINANCIAL INSTITUTIONS -- LICENSED ACTIVITIES -- LENDERS AND  
LOAN BROKERS -- CHECK CASHING

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 19-14-1 of the General Laws in Chapter 19-14 entitled "Licensed  
2 Activities" is hereby amended to read as follows:

3 **19-14-1. Definitions.**

4 Unless otherwise specified, the following terms shall have the following meanings  
5 throughout chapters 14, 14.1, 14.2, 14.3, 14.4, 14.6, 14.8, 14.10, and 14.11 of this title:

6 (1) "Bona fide employee" shall mean an employee of a licensee who works under the  
7 oversight and supervision of the licensee.

8 (2) "Check" means any check, draft, money order, personal money order, or other  
9 instrument for the transmission or payment of money. For the purposes of check cashing, travelers  
10 checks or foreign denomination instruments shall not be considered checks. "Check cashing"  
11 means providing currency for checks.

12 (3) "Check casher" means a person or entity who or that, for compensation, engages, in  
13 whole or in part, in the business of cashing checks.

14 (4) "Currency transmission" means engaging in the business of any of the following:

15 (i) Sale or issuance of payment instruments or stored value primarily for personal, family,  
16 or household purposes; or

17 (ii) Receiving money or monetary value for transmission or holding funds incidental to  
18 transmission within the United States or to locations abroad by any and all means, including

1 payment instrument, stored value, wire, facsimile, or electronic transfer, primarily for personal,  
2 family, or household purposes. This includes maintaining control of virtual currency or transactions  
3 in virtual currency on behalf of others.

4 (5) ~~“Deferred deposit transaction” means any transaction, such as those commonly known~~  
5 ~~as “payday loans,” “payday advances,” or “deferred presentment loans,” in which a cash advance~~  
6 ~~is made to a customer in exchange for the customer’s personal check or in exchange for the~~  
7 ~~customer’s authorization to debit the customer’s deposit account and where the parties agree either~~  
8 ~~that the check will not be cashed or deposited, or that the customer’s deposit account will not be~~  
9 ~~debited until a designated future date.~~

10 (6) [Deleted by P.L. 2019, ch. 226, § 1 and P.L. 2019, ch. 246, § 1.]

11 (7) “Deliver” means to deliver a check to the first person who, in payment for the check,  
12 makes, or purports to make, a remittance of, or against, the face amount of the check, whether or  
13 not the deliverer also charges a fee in addition to the face amount and whether or not the deliverer  
14 signs the check.

15 (8) “Insurance premium finance agreement” means an agreement by which an insured, or  
16 prospective insured, promises to pay to an insurance premium finance company the amount  
17 advanced, or to be advanced, under the agreement to an insurer or to an insurance producer, in  
18 payment of a premium, or premiums, on an insurance contract, or contracts, together with interest  
19 and a service charge, as authorized and limited by this title.

20 (9) “Insurance premium finance company” means a person or entity engaged in the  
21 business of making insurance premium finance agreements or acquiring insurance premium finance  
22 agreements from other insurance premium finance companies.

23 (10)(i) “Lender” means any person who makes or funds a loan within this state with the  
24 person’s own funds, regardless of whether the person is the nominal mortgagee or creditor on the  
25 instrument evidencing the loan;

26 (ii) A loan is made or funded within this state if any of the following conditions exist:

27 (A) The loan is secured by real property located in this state;

28 (B) An application for a loan is taken by an employee, agent, or representative of the lender  
29 within this state;

30 (C) The loan closes within this state;

31 (D) A retail installment contract as defined herein is created;

32 (E) The loan solicitation is done by an individual with a physical presence in this state; or

33 (F) The lender maintains an office in this state;

34 (iii) The term “lender” shall also include any person engaged in a transaction whereby the

1 person makes or funds a loan within this state using the proceeds of an advance under a line of  
2 credit over which proceeds the person has dominion and control and for the repayment of which  
3 the person is unconditionally liable. This transaction is not a table-funding transaction. A person is  
4 deemed to have dominion and control over the proceeds of an advance under a line of credit used  
5 to fund a loan regardless of whether:

6 (A) The person may, contemporaneously with, or shortly following, the funding of the  
7 loan, assign or deliver to the line of credit lender one or more loans funded by the proceeds of an  
8 advance to the person under the line of credit;

9 (B) The proceeds of an advance are delivered directly to the settlement agent by the line-  
10 of-credit lender, unless the settlement agent is the agent of the line-of-credit lender;

11 (C) One or more loans funded by the proceeds of an advance under the line of credit is  
12 purchased by the line-of-credit lender; or

13 (D) Under the circumstances, as set forth in regulations adopted by the director, or the  
14 director's designee, pursuant to this chapter.

15 (11) "Licensee" means any person licensed under this chapter.

16 (12) "Loan" means any advance of money or credit including, but not limited to:

17 (i) Loans secured by mortgages;

18 (ii) Insurance premium finance agreements;

19 (iii) The purchase or acquisition of retail installment contracts or advances to the holders  
20 of those contracts;

21 (iv) Educational loans; or

22 (v) Any other advance of money; ~~or~~

23 ~~(vi) Any transaction, such as those commonly known as "payday loans," "payday~~  
24 ~~advances," or "deferred presentment loans," in which a cash advance is made to a customer in~~  
25 ~~exchange for the customer's personal check, or in exchange for the customer's authorization to~~  
26 ~~debit the customer's deposit account, and where the parties agree either, that the check will not be~~  
27 ~~cashed or deposited, or that the customer's deposit account will not be debited, until a designated~~  
28 ~~future date.~~

29 (13) "Loan broker" means any person or entity who or that, for compensation or gain, or  
30 in the expectation of compensation or gain, either directly or indirectly, solicits, processes,  
31 negotiates, places, or sells a loan within this state for others in the primary market, or offers to do  
32 so. A loan broker shall also mean any person who is the nominal mortgagee or creditor in a table-  
33 funding transaction. A loan is brokered within this state if any of the following conditions exist:

34 (i) The loan is secured by real property located in this state;

1 (ii) An application for a loan is taken or received by an employee, agent, or representative  
2 of the loan broker within this state;

3 (iii) The loan closes within this state;

4 (iv) The loan solicitation is done by an individual with a physical presence in this state; or

5 (v) The loan broker maintains an office in this state.

6 (14) "Loan-closing services" means providing title services, including title searches, title  
7 examinations, abstract preparation, insurability determinations, and the issuance of title  
8 commitments and title insurance policies, conducting loan closings, and preparation of loan-closing  
9 documents when performed by, or under the supervision of, a licensed attorney, licensed title  
10 agency, or licensed title insurance company.

11 (15) "Loan solicitation" shall mean an effectuation, procurement, delivery and offer, or  
12 advertisement of a loan. Loan solicitation also includes providing or accepting loan applications  
13 and assisting persons in completing loan applications and/or advising, conferring, or informing  
14 anyone regarding the benefits, terms and/or conditions of a loan product or service. Loan  
15 solicitation does not include loan processing or loan underwriting as defined in this section. Loan  
16 solicitation does not include telemarketing that is defined, for purposes of this section, to mean  
17 contacting a person by telephone with the intention of collecting such person's name, address, and  
18 telephone number for the sole purpose of allowing a mortgage loan originator to fulfill a loan  
19 inquiry.

20 (16) "Loan underwriting" shall mean a loan process that involves the analysis of risk with  
21 respect to the decision whether to make a loan to a loan applicant based on credit, employment,  
22 assets, and other factors, including evaluating a loan applicant against a lender's various lending  
23 criteria for creditworthiness, making a determination for the lender as to whether the applicant  
24 meets the lender's pre-established credit standards, and/or making a recommendation regarding  
25 loan approval.

26 (17) "Monetary value" means a medium of exchange, whether or not redeemable in fiat  
27 currency.

28 (18) "Mortgage loan" means a loan secured in whole, or in part, by real property located  
29 in this state.

30 (19) "Mortgage loan originator" has the same meaning set forth in § 19-14.10-3.

31 (20) "Nationwide Multistate Licensing System" means a system involving more than one  
32 state, the District of Columbia, or the Commonwealth of Puerto Rico and that is established to  
33 facilitate the sharing of regulatory information and the licensing, application, reporting, and  
34 payment processes, by electronic or other means, for mortgage lenders and loan brokers and other

1 licensees required to be licensed under this chapter.

2 (21) "Natural person employee" shall mean any natural person performing services as a  
3 bona fide employee for a person or entity licensed under § 19-14-1 et seq., in return for a salary,  
4 wage, or other consideration, where such salary, wage, or consideration is reported by the licensee  
5 on a federal form W-2 payroll record. The term does not include any natural person or business  
6 entity performing services for a person licensed under the provisions of Rhode Island general laws  
7 in return for a salary, wage, or other consideration, where such salary, wage, or consideration is  
8 reported by the licensee on a federal form 1099.

9 (22) "Negative equity" means the difference between the value of an asset and the  
10 outstanding portion of the loan taken out to pay for the asset, when the latter exceeds the former  
11 amount.

12 (23) "Negotiates" shall mean, with respect to a loan, to confer directly with, or offer advice  
13 directly to, a loan applicant or prospective loan applicant for a loan product or service concerning  
14 any of the substantive benefits, terms, or conditions of the loan product or service.

15 (24) "Nonprofit organization" means a corporation qualifying as a 26 U.S.C. § 501(c)(3)  
16 nonprofit organization, in the operation of which no member, director, officer, partner, employee,  
17 agent, or other affiliated person profits financially other than receiving reasonable salaries if  
18 applicable.

19 (25) "Operating subsidiary" shall mean a majority-owned subsidiary of a financial  
20 institution or banking institution that engages only in activities permitted by the parent financial  
21 institution or banking institution.

22 (26) "Oversight and supervision of the licensee" shall mean that the licensee provides  
23 training to the employee, sets the employee's hours of work, provides the employee with the  
24 equipment required to perform the employee's duties, and supervises the services provided by the  
25 employee to the licensee.

26 (27) "Personal money order" means any instrument for the transmission or payment of  
27 money in relation to which the purchaser or remitter appoints, or purports to appoint, the seller as  
28 his or her agent for the receipt, transmission, or handling of money, whether the instrument is signed  
29 by the seller, or by the purchaser, or remitter, or some other person.

30 (28) "Primary market" means the market in which loans are made to borrowers by lenders,  
31 whether or not through a loan broker or other conduit.

32 (29) "Principal owner" means any person or entity who or that owns, controls, votes, or  
33 has a beneficial interest in, directly or indirectly, ten percent (10%) or more of the outstanding  
34 capital stock and/or equity interest of a licensee.

1 (30) "Processes" shall mean, with respect to a loan, any of a series of acts or functions,  
2 including the preparation of a loan application and supporting documents, performed by a person  
3 that leads to, or results in, the acceptance, approval, denial, and/or withdrawal of a loan application,  
4 including, without limitation, the rendering of services, including loan underwriting, obtaining  
5 verifications, credit reports or appraisals, communicating with the applicant and/or the lender or  
6 loan broker, and/or other loan processing and origination services, for consideration by a lender or  
7 loan broker. Loan processing does not include the following:

8 (i) Providing loan closing services;

9 (ii) Rendering of credit reports by an authorized credit reporting agency; and

10 (iii) Rendering of appraisal services.

11 (31) "Provisional employee" means a natural person who, pursuant to a written agreement  
12 between the natural person and a wholly owned subsidiary of a financial holding company, as  
13 defined in the Bank Holding Company Act of 1956 (12 U.S.C. § 1841 et seq.), as amended, a bank-  
14 holding company, savings-bank-holding company, or thrift-holding company, is an exclusive agent  
15 for the subsidiary with respect to mortgage loan originations and the subsidiary: (a) Holds a valid  
16 loan broker's license; and (b) Enters into a written agreement with the director, or the director's  
17 designee, to include:

18 (i) An "undertaking of accountability," in a form prescribed by the director, or the director's  
19 designee, for all of the subsidiary's exclusive agents to include full-and-direct financial and  
20 regulatory responsibility for the mortgage loan originator activities of each exclusive agent as if  
21 said exclusive agent were an employee of the subsidiary;

22 (ii) A business plan, to be approved by the director, or the director's designee, for the  
23 education of the exclusive agents, the handling of consumer complaints related to the exclusive  
24 agents, and the supervision of the mortgage loan origination activities of the exclusive agents; and

25 (iii) A restriction of the exclusive agents' mortgage loan originators' activities to loans to  
26 be made only by the subsidiary's affiliated bank.

27 (32) "Remote location" means a location meeting the requirements of § 19-14-25(b) at  
28 which an employee of a licensee may provide services for the licensee notwithstanding that the  
29 location differs from the place of business named in the license or a branch certificate issued to the  
30 licensee.

31 (33) "Retail installment contract" means any security agreement negotiated or executed in  
32 this state, or under the laws of this state, including, but not limited to, any agreement in the nature  
33 of a mortgage, conditional sale contract, or any other agreement whether or not evidenced by any  
34 written instrument to pay the retail purchase price of goods, or any part thereof, in installments over

1 any period of time and pursuant to which any security interest is retained or taken by the retail seller  
2 for the payment of the purchase price, or any part thereof, of the retail installment contract.

3 (34) "Sell" means to sell, to issue, or to deliver a check.

4 (35) "Servicing" means receiving a scheduled, periodic payment from a borrower, pursuant  
5 to the terms of a loan, including amounts for escrow accounts, and making the payments to the  
6 owner of the loan or other third party of principal and interest and other payments with respect to  
7 the amounts received from the borrower as may be required pursuant to the terms of the servicing  
8 loan documents or servicing contract. In the case of a home equity conversion mortgage or a reverse  
9 mortgage, servicing includes making payment to the borrower.

10 (36) "Simple interest" means interest computed on the principal balance outstanding  
11 immediately prior to a payment for one plus the actual number of days between payments made on  
12 a loan over the life of a loan.

13 (37) "Small loan" means a loan of less than five thousand dollars (\$5,000), not secured by  
14 real estate, made pursuant to the provisions of chapter 14.2 of this title.

15 (38) "Small-loan lender" means a lender engaged in the business of making small loans  
16 within this state.

17 (39) "Stored value" means monetary value representing a claim against the issuer that is  
18 stored on an electronic or digital medium and is evidenced by an electronic or digital record, and  
19 that is intended and accepted for use as a means of redemption for money or monetary value or  
20 payment for goods or services. The term does not include stored value that is redeemable by the  
21 issuer exclusively in goods or services; stored value that is redeemable exclusively in goods or  
22 services limited to transactions involving a defined merchant or location or set of locations, such  
23 as a specific retailer or retail chain, college campus, or program points, miles, or other units issued  
24 in connection with a customer affinity or rewards program, even if there is a secondary market for  
25 the stored value.

26 (40) "Table-funding transaction" means a transaction in which there is a contemporaneous  
27 advance of funds by a lender and an assignment by the mortgagee or creditor of the loan to the  
28 lender.

29 (41) "Tangible net worth" means the aggregate assets of a licensee excluding all intangible  
30 assets, less liabilities, as determined in accordance with United States generally accepted  
31 accounting principles.

32 (42) "Third-party loan servicer" means a person or entity who or that, directly or indirectly,  
33 engages in the business of servicing a loan secured by residential real estate located in Rhode Island,  
34 for a personal, family, or household purpose, owed or due, or asserted to be owed or due, another,

1 or a person or entity that owns the servicing rights to a loan secured by residential real estate located  
2 in Rhode Island whether or not that owner services the loan themselves or contracts with another  
3 person or entity for the servicing.

4 (43) "Virtual currency":

5 (i) Means a digital representation of value that:

6 (A) Is used as a medium of exchange, unit of account, or store of value; and

7 (B) Is not legal tender, whether or not denominated in legal tender; and

8 (ii) Does not include:

9 (A) A transaction in which a merchant grants, as part of an affinity or rewards program,  
10 value that cannot be taken from or exchanged with the merchant for legal tender, bank credit, or  
11 virtual currency;

12 (B) A digital representation of value issued by or on behalf of a publisher and used solely  
13 within an online game, game platform, or family of games sold by the same publisher or offered  
14 on the same game platform;

15 (C) Native digital token used in a proprietary blockchain service platform; or

16 (D) A gift certificate; store gift card; general-use prepaid card; or loyalty, award, or  
17 promotional gift card, as these terms are defined in federal Regulation E, 12 C.F.R. § 1005.20(a),  
18 without giving effect to any exception as specified in 31 C.F.R. § 1010.100(kkk) or any card, code  
19 or device, or other device that can add funds to those products.

20 (44) "Writing" means hard-copy writing or electronic writing that meets the requirements  
21 of § 42-127.1-2(7).

22 SECTION 2. Section 19-14.1-10 of the General Laws in Chapter 19-14.1 entitled "Lenders  
23 and Loan Brokers" is hereby amended to read as follows:

24 **19-14.1-10. Special exemptions.**

25 (a) The licensing provisions of chapter 14 of this title shall not apply to:

26 (1) Nonprofit charitable, educational, or religious corporations or associations;

27 (2) Any person who makes less than six (6) loans in this state in any consecutive twelve-  
28 month (12) period; there is no similar exemption from licensing for loan brokers for brokering loans  
29 or acting as a loan broker;

30 (3) Any person acting as an agent for a licensee for the purpose of conducting closings at  
31 a location other than that stipulated in the license;

32 (4) Regulated institutions and banks or credit unions organized under the laws of the United  
33 States, or subject to written notice with a designated Rhode Island agent for service of process in  
34 the form prescribed by the director, or the director's designee, of any other state within the United



1 States if the laws of the other state in which such bank or credit union is organized authorizes under  
2 conditions not substantially more restrictive than those imposed by the laws of this state, as  
3 determined by the director, or the director's designee, a financial institution or credit union to  
4 engage in the business of originating or brokering loans in the other state; no bank or credit union  
5 duly organized under the laws of any other state within the United States may receive deposits, pay  
6 checks, or lend money from any location within this state unless such bank or credit union has  
7 received approval from the director, or the director's designee, for the establishment of an interstate  
8 branch office pursuant to chapter 7 of title 19;

9 (5) Any natural person employee who is employed by a licensee when acting on the  
10 licensee's behalf; provided that this exemption shall not apply to a mortgage loan originator  
11 required to be licensed under § 19-14-2 or § 19-14.10-4; or

12 (6) A licensed attorney when performing loan closing services for a licensee or for an entity  
13 identified in subdivision (4) above.

14 (b) The provisions of this chapter and chapter 14 of this title shall not apply to:

15 (1) Loans to corporations, joint ventures, partnerships, limited liability companies or other  
16 business entities;

17 (2) Loans over twenty-five thousand dollars (\$25,000) in amount to individuals for  
18 business or commercial, as opposed to personal, family or household purposes;

19 (3) Loans principally secured by accounts receivable and/or business inventory;

20 (4) Loans made by a life insurance company wholly secured by the cash surrender value  
21 of a life insurance policy;

22 (5) Education-purpose loans made by the Rhode Island health and educational building  
23 corporation as vested in chapter 38.1 of title 45 of the Rhode Island student loan authority as vested  
24 in chapter 62 of title 16;

25 (6) The acquisition of retail or loan installment contracts by an entity whose sole business  
26 in this state is acquiring them from federal banks receivers or liquidators;

27 (7) Notes evidencing the indebtedness of a retail buyer to a retail seller of goods, services  
28 or insurance for a part or all of the purchase price;

29 (8) Any municipal, state or federal agency that makes, brokers, or funds loans or acts as a  
30 lender or a loan broker. This exemption includes exclusive agents or exclusive contractors of the  
31 agency specifically designated by the agency to perform those functions on behalf of the agency  
32 and which has notified the director, in writing, of the exclusive agency or contract; or

33 (9) Notes evidencing the indebtedness of a retail buyer to a retail motor vehicle dealer that  
34 include as part of the amount financed, disclosed in accordance with 12 C.F.R. § 226.18 as

1 amended, an amount representing negative equity related to the motor vehicle being traded in as  
2 part of the purchase price of the motor vehicle being purchased.

3 ~~(e) No license to make or fund loans, or to act as a lender or small loan lender shall be~~  
4 ~~required of any person who engages in deferred deposit transactions (commonly known as “pay-~~  
5 ~~day advance”) while holding a valid license to cash checks pursuant to chapter 14 of this title.~~

6 SECTION 3. Section 19-14.2-1 of the General Laws in Chapter 19-14.2 entitled "Small  
7 Loan Lenders" is hereby amended to read as follows:

8 **19-14.2-1. Maximum rate on small loans not authorized by chapter.**

9 (a) No person, except as authorized by this chapter, shall directly or indirectly charge,  
10 contract for, or receive any interest, discount, or consideration greater than provided by this chapter  
11 upon the loan, use, or sale of credit of the amount or value of five thousand dollars (\$5,000) or less.

12 (b) The prohibition in subsection (a) shall apply to any person who, by any device,  
13 subterfuge, or pretense shall charge, contract for, or receive greater interest, consideration, or  
14 charges than is authorized by this chapter for the loan, use, or forbearance of money, goods, or  
15 things in action, or for the loan, use, or sale of credit.

16 (c) No loan of the amount or value of five thousand dollars (\$5,000) or less for which a  
17 greater rate of interest, consideration, or charges than is permitted by this chapter has been charged,  
18 contracted for, or received, wherever made, shall be enforced in this state, and every person in any  
19 way participating therein in this state shall be subject to the provisions of this chapter, provided  
20 that this section shall not apply to loans legally made in any other state, commonwealth, or district  
21 which then has in effect a regulatory small loan law similar in principal to this chapter.

22 (d) No person may engage in any device, subterfuge, or pretense to evade the requirements  
23 of this chapter, including making loans disguised as personal property sales and leaseback  
24 transactions, or disguising loan proceeds as cash rebates for the pretextual installment sale of goods  
25 or services, or assisting a debtor to obtain a loan with a greater rate of interest, consideration, or  
26 charges than is permitted by this chapter through any method including mail, telephone, Internet,  
27 or any electronic means regardless of whether the person has a physical location in the state.

28 SECTION 4. Sections 19-14.4-4 and 19-14.4-5 of the General Laws in Chapter 19-14.4  
29 entitled "Check Cashing" are hereby amended to read as follows:

30 **19-14.4-4. Fees for services.**

31 No licensee shall:

32 (1) Charge check-cashing fees in excess of three percent (3%) of the face amount of the  
33 check, or five dollars (\$5.00), whichever is greater, if the check is the payment of any kind of state  
34 public assistance or federal social security benefit;

1 (2) Charge check-cashing fees for personal checks in excess of ten percent (10%) of the  
2 face amount of the personal check or five dollars (\$5.00), whichever is greater; or

3 (3) Charge check-cashing fees in excess of five percent (5%) of the face amount of the  
4 check or five dollars (\$5.00), whichever is greater, for all other checks; ~~or~~

5 ~~(4) Charge deferred deposit transaction fees in excess of ten percent (10%) of the amount~~  
6 ~~of funds advanced.~~

7 **19-14.4-5. Posting of charges — Endorsement — Receipt.**

8 (a) In every location licensed pursuant to this chapter, there shall be at all times posted, in  
9 a conspicuous place within the licensed premises, a complete and unambiguous schedule of all fees  
10 for cashing checks, ~~deferred deposit transactions~~ expressed as both a dollar amount and an annual  
11 percentage rate; and the initial issuance of any identification card.

12 (b) Before a licensee shall deposit, with any regulated institution or other insured-deposit-  
13 taking institution organized under the laws of the United States, a check cashed by the licensee, the  
14 check must be endorsed with the name under which the licensee is doing business and must include  
15 the words "licensed check cashing services".

16 (c) The licensee shall provide a receipt for each transaction for the benefit of a customer.

17 (d) Each check cashier shall also post a list of valid identification that is acceptable in lieu  
18 of identification provided by the check cashier. The information required by this section shall be  
19 clear, legible, and in letters not less than one-half (½) inch in height. The information shall be  
20 posted in a conspicuous location in the unobstructed view of the public within the check cashier's  
21 premises. Failure to post information as required by this section, or the imposition of fees or  
22 identification requirements contrary to the information posted, shall constitute a deceptive trade  
23 practice under chapter 13.1 of title 6.

24 SECTION 5. Section 19-14.4-5.1 of the General Laws in Chapter 19-14.4 entitled "Check  
25 Cashing" is hereby repealed.

26 **~~19-14.4-5.1. Customer checks — Deferred deposits.~~**

27 ~~(a) A check cashier may defer the deposit of a personal check written by a customer for a~~
