It is enacted by the General Assembly as follows:

1	SECTION 1. Section 45-24-54 of the General Laws in Chapter 45-24 entitled "Zoning
2	Ordinances" is hereby amended to read as follows:

### 45-24-54. Administration — Administration and enforcement of zoning ordinance.

4 (a) A zoning ordinance adopted pursuant to this chapter must provide for the administration and enforcement of its provisions pursuant to this chapter. The zoning ordinance must designate 5 6 the local official or agency and specify minimum qualifications for the person or persons charged 7 with its administration and enforcement, including: (1) the issuing of any required permits or 8 certificates; (2) collection of required fees; (3) keeping of records showing the compliance of uses 9 of land; (4) authorizing commencement of uses or development under the provisions of the zoning 10 ordinance; (5) inspection of suspected violations; (6) issuance of violation notices with required 11 correction action; (7) collection of fines for violations; and (8) upon written request, issue a zoning 12 certificate or provide information to the requesting party as to the determination by the official or 13 agency; and (9) performing any other duties and taking any actions that may be assigned in the 14 ordinance. In order to provide guidance or clarification, the zoning enforcement officer or agency 15 shall, upon written request, issue a zoning certificate or provide information to the requesting party as to the determination by the official or agency A zoning certificate shall be issued within fifteen 16 17 (15) twenty (20) days of the written request. In the event that no written response is provided within 18 that time, the requesting party has the right to appeal to the zoning board of review for the determination pursuant to § 45-24-63. 19

- 2 <u>certificate pursuant to § 45-24-63.</u>
- 3 SECTION 2. This act shall take effect upon passage.
