RELATING TO MILITARY AFFAIRS AND DEFENSE -- MILITARY CHILD ACT

It is enacted by the General Assembly as follows:

1 SECTION 1. Title 30 of the General Laws entitled "MILITARY AFFAIRS AND
2 DEFENSE" is hereby amended by adding thereto the following chapter:

3 CHAPTER 30.4

4 THE MILITARY CHILD ACT

5 **30-30.4-1. Short title.**

6 This chapter shall be known and may be cited as the "Military Child Act."

7 **30-30.4-2. Definitions.**

8 As used in this chapter:

9 (1) "Military-connected student" means a student who is the dependent of either a person
10 in the active military service of the United States or in a full-time status during active service with
11 a force of the Rhode Island national guard.

12 **30-30.4-3. Advance enrollment.**

13 A military-connected student whose parent or guardian is being relocated to this state under
14 military orders and is transferred to or is pending transfer to a military installation within the state,
15 shall be deemed to be a resident pupil of a school system of a city or town for the purposes of
16 enrollment. The Rhode Island board of education shall permit military-connected students to enroll
17 preliminarily by remote registration without charge and shall not require the parents or guardians
18 of the military-connected student or the student to physically appear at a location within the district
19 to register the student, if the parents or guardians present evidence of military orders that a parent

1 or guardian shall be stationed in this state during the current or following school year. The parents
2 or guardians may use an address within the school district where the military-connected student is
3 to be enrolled of a temporary on-base billeting facility, a purchased or leased home or apartment,
4 or federal government or public-private venture off-base military housing. Proof of required
5 residency shall not be required at the time of the remote registration, but shall be required within
6 ten (10) days of the student's attendance in the school system of the city or town where the student
7 resides.

8 SECTION 2. This act shall take effect upon passage.

RELATING TO MILITARY AFFAIRS AND DEFENSE -- MILITARY CHILD ACT

1 This act would define "military-connected student" and permit military-connected students
2 to enroll by remote registration upon presentation of military orders confirming that the parent or
3 guardian shall be stationed in this state during the current or following school year.

4 This act would take effect upon passage.
