SENATE RESOLUTION

PROCLAIMING JUNE 4, 2026, TO BE "COX IMPACT DAY" IN THE STATE OF RHODE ISLAND

1           WHEREAS, Cox Communications is committed to creating meaningful moments of  
2 human connection through technology. As the largest private broadband company in America,  
3 Cox operates fiber-powered networks in more than 30 States, providing connections and  
4 advanced cloud and managed IT services for nearly seven million homes and businesses  
5 nationwide. They are dedicated to empowering others to build a better future and celebrate  
6 diverse products, people, suppliers, communities, and the characteristics that make each one  
7 unique; and

8           WHEREAS, Cox Communications is the largest division of Cox Enterprises, a family-  
9 owned business founded in 1898 by Governor James M. Cox; and

10           WHEREAS, Since 2001, Cox employees and business partners have invested in Cox  
11 Charities, a charitable giving initiative of Cox Communications. Cox Charities has invested more  
12 than \$11 million in grants and in-kind support to organizations providing S.T.E.A.M. [Science,  
13 Technology, Engineering, Arts and Math] enrichment programs to youth throughout the  
14 Northeast; and

15           WHEREAS, Cox believes in community action through giving and loves the position  
16 they hold as a contributing member of the community. This compels Cox to provide support with  
17 monetary, media and premium gift contributions that provide goodwill to organizations and  
18 causes in need and strengthens the social, economic and educational infrastructure of our  
19 community; and
