AN ACT

RELATING TO ANIMALS AND ANIMAL HUSBANDRY -- REGULATION OF VICIOUS DOGS

SECTION 1. Legislative Findings. The general assembly finds and declares as follows:

It is enacted by the General Assembly as follows:

2	(1) In recent years the state of Rhode Island has experienced a tragic series of incidents in			
3	which citizens have been attacked and seriously injured by pitbull dogs; and,			
4	(2) Concurrent with these attacks upon human beings, the community has also			
5	experienced an increasing number of animal killings and serious injuries resulting from pitbull			
6	attacks; and			
7	(3) Pitbull breeds were developed for the purpose of fighting dogs and other animals; and			
8	(4) To increase its effectiveness as a fighter, certain pitbull traits have been selected and			
9	maximized by controlled breeding, including:			
10	(i) A set of powerful jaws with an exceptional ability to grip, lock and tear when the dog			
11	bites;			
12	(ii) A unique insensitivity to pain that causes pitbulls to be exceedingly tenacious in the			
13	attack; and			
14	(iii) An unusually aggressive temperament towards human beings and animals; and			
15	(4) An extraordinary directness in their method of attack that does not include the			
16	common warning signs such as barking or growling displayed by other breeds.			
17	(5) For the above reasons, pitbull dogs present a danger to the health and welfare of the			
I Q	citizens of Phode Island, different in degree and kind, from the dangers presented by other breeds			

2	(6) It is the intent of the general assembly to utilize its authority and police powers to			
3	protect the health, safety and welfare of its citizens through implementation of uniform			
4	regulations and guidelines for the possession, handling, and control of pitbull dogs. The intent of			
5	this act is not to outlaw the ownership of pitbull dogs but rather to stimulate responsible			
6	ownership through confinement, registration and liability insurance. The unique history, nature,			
7	and characteristics of pitbull dogs has been determined to require the special regulations and			
8	provisions contained within this act which the general assembly finds to be reasonable as			
9	necessary.			
10	SECTION 2. Chapter 4-13.1 of the General Laws entitled "Regulation of Vicious Dogs"			
11	is hereby amended by adding thereto the following sections:			
12	4-13.1-16. Definition and identification of a pitbull dog (a) The term "pitbull dog"			
13	as used within this chapter shall refer to any dog which exhibits those distinguishing			
14	characteristics which:			
15	(1) Substantially conform to the standards established by the American Kennel Club for			
16	American Staffordshire Terriers or Staffordshire Bull Terriers; or			
17	(2) Substantially conform to the standards established by the United Kennel Club for			
18	American Pitbull Terriers.			
19	(b) The current standards of the American Kennel Club and the United Kennel Club			
20	referred to in subsection (a) shall remain on file with the animal control officer for each			
21	municipality.			
22	(c) Technical deficiencies in a dog's conformance to the standards described in			
23	subsection (b) shall not be construed to indicate that the subject dog is not a "pitbull dog" under			
24	this chapter.			
25	(d) Testimony by a veterinarian, zoologist, animal behaviorist, or animal control officer			
26	that a particular dog exhibits distinguishing physical characteristics of a pitbull shall establish a			
27	rebuttable presumption that the dog is a pitbull.			
28	(e) "Keeper" means any person who possesses, keeps, exercises control over, maintains,			
29	harbors, transports, or sells a pitbull, whether or not that person is the owner.			
30	(f) "Owner" means any person who owns, possesses, keeps, exercises control over,			
31	maintains, harbors, transports or sells a pitbull.			
32	4-13.1-17. Confinement of pitbull dogs (a) Because of the pitbull dog's inbred			
33	propensity to attack other animals, and because of the danger posed to humans and animals alike			
84	by a pitbull dog when running loose or while running together in a pack, pitbull dogs must at all

1	times except as otherwise provided in this section be securely confined indoors, or confined in a			
2	securely and totally enclosed and locked pen, with either a top or with all four (4) sides at lea			
3	six feet (6') high, and with a conspicuous sign displaying the words "Dangerous Dog."			
4	(b) At any time that a pitbull dog is not confined as required in subsection (a) above,			
5	dog shall be muzzled in such a manner as to prevent it from biting or injuring any person			
6	animal, and kept on a leash with the owner, keeper or handler in attendance. The owner or ke			
7	must be eighteen (18) years of age or older. No pitbull dog may be walked within one hund			
8	feet (100') of any public or private school ground nor enter onto such school grounds.			
9	(c) An exception to the confinement requirements, of subsections (a) and (b) is hereby			
10	provided for any pitbull dog in attendance at, and participating in, any lawful dog show, contest,			
11	or exhibition sponsored by a dog club, association, and society of similar organization, or when			
12	the dog is actually engaged in the sport of hunting in an authorized area and supervised by a			
13	competent person eighteen (18) years of age or older.			
14	(d) Municipal animal shelters may temporarily harbor and transport any pitbull for			
15	purposes of enforcing the provisions of this chapter.			
16	4-13.1-18. Evidence of financial responsibility required to be maintained by owners			
17	of pitbull dogs In order to protect the public and to afford relief from the severe harm and			
18	injury which is likely to result from a pitbull dog attack, every owner of a pitbull dog shall			
19	maintain and be able to provide evidence of the owner's financial ability to respond in damages			
20	up to and including the amount of fifty thousand dollars (\$50,000) for bodily injury to or death of			
21	any person or damage to property which may result from the ownership, keeping or maintaining			
22	of such dog. Proof of financial responsibility shall be given by filing with the animal control			
23	office a certificate of insurance from an insurance company authorized to do business in the			
24	state, stating that the owner is and will be insured against liability for such damages; or by posting			
25	with the animal control officer a surety bond conditioned upon the payment of such damages			
26	during the period of such registration; or by posting a personal bond secured by a mortgage in			
27	real property or security interest in personal property; or a sworn statement of the owner of			
28	his/her financial ability to respond to damages up to and including the amount of fifty thousand			
29	dollars (\$50,000).			

4-13.1-19. Regulation of pitbull dogs. -- Every owner of a pitbull dog in the state of Rhode Island shall register the dog with the animal control officer in the municipality in which the dog will be kept, housed or located. The registration shall include the following: name, address, and telephone number of the dog's owner; the address where the dog is harbored, if different from the owner's address; a complete identification of the dog including the dog's sex,

1	color, and any other distinguishing characteristics; a color photograph of the dog; a description of			
2	the method of compliance with the confinement requirements; proof of the liability insurance or			
3	other evidence of financial responsibility required pursuant to this chapter; and a registration fee			
4	4-13.1-20. Enforcement It shall be the duty and responsibility of all animal control			
5	officers in the state of Rhode Island to enforce the provisions of this chapter.			
6	4-13.1-21. Time for compliance (a) All persons subject to this chapter shall have			
7	ninety (90) days from the effective date of this chapter to comply with all confinement a			
8	registration and requirements of this chapter. The provisions of chapter 4-13.1-18 entitle			
9	"Evidence of financial responsibility required to be maintained by owners of pitbull dogs," sha			
10	be effective within one hundred and twenty (120) days from the effective date of this chapter.			
11	(b) Failure to register a pitbull dog as required by this chapter within the ninety (90) day			
12	grace period shall be prima facie evidence of non-compliance with this chapter.			
13	(c) Violations of subsection (a) and or subsection (b) may result in the issuance of a circ			
14	violation notice and removal of the pitbull dog by the animal control officer until such time			
15	compliance to this chapter is completed.			
16	4-13.1-22. Pitbull signs in veterinary offices, kennels, commercial breeders,			
17	commercial animal establishments, pet shops, and dog grooming businesses (a) Signs			
18	Required. Every veterinary office, kennel, commercial breeder, commercial animal establishment,			
19	pet shop and dog grooming business must post a sign stating in English, the following:			
20	"BOTH PURE AND MIXED BREED PITBULL DOGS ARE CLASSIFIED AS			
21	DANGEROUS. FAILURE TO REGISTER, MUZZLE, CONFINE, AND INSURE A PITBULL			
22	IS A VIOLATION OF THE LAWS SUBJECT TO PENALTY. Chapter 4-13.1 of the Rhode			
23	Island General Laws.			
24	"IF YOU OR YOUR FAMILY IS AT RISK BECAUSE SOMEONE LIVING NEAR			
25	YOU FAILS TO CONFINE, MUZZLE OR INSURE A PITBULL DOG, CONTACT THE			
26	ANIMAL CONTROL OFFICER" (HERE INSERT CURRENT PHONE NUMBER FOR THE			
27	LOCAL ANIMAL CONTROL OFFICER).			
28	The sign must be prominently displayed to the public and clearly legible.			
29	(b) Penalties. Failure to post a sign as required by this section shall be a civil violation			
30	subject to a one hundred fifty dollar (\$150) civil penalty. Every day a sign is not posted shall be a			
31	separate violation.
