1 WHEREAS, The goal of the Choosing Wisely Campaign is to promote conversations 2 between physicians and patients about unnecessary care and thereby reduce wasteful spending of 3 health care dollars on unnecessary tests, treatments, and procedures in the health care system; and 4 WHEREAS, Choosing Wisely is a national effort led by the American Board of Internal 5 Medicine Foundation garnering the participation of over 80 medical specialty societies who have published more than 550 recommendations of overused tests, treatments, and procedures that 6 7 clinicians and patients should discuss; and WHEREAS, An informed and educated patient can feel empowered to ask questions 8 9 about his or her health, including alternatives for pain medication, surgeries, and other medical 10 care; and WHEREAS, The medical community recognizes the importance of having an open 11 12 dialogue with their patients on the benefit and risks of medicines, tests and procedures; and 13 WHEREAS, The Choosing Wisely Rhode Island Campaign, sponsored by the Rhode 14 Island Business Group on Health and the Rhode Island Foundation, has brought together a broad coalition of stakeholders, including physicians/clinicians, patients, community advocates, and 15 government and business leaders who are working together to benefit present and future 16 17 generations of Rhode Islanders; now, therefore be it RESOLVED, That this Senate of the State of Rhode Island and Providence Plantations 18
