Previous to his enlistment, he 9 10 had worked as a skilled iron worker; and 11 WHEREAS, Upon discharge from the Navy, Mr. Zackarian drove a tour bus, fondly 12 named "Amanda", for numerous music legends in Nashville, including the late Country music 13 legend Don Williams, the late Dan Seals, and the late Merle Haggard, to name just a few; and 14 WHEREAS, Mr. Zackarian later worked as a technician for the Prevost Bus Company in Hendersonville, Tennessee, before returning to Rhode Island in 2013; and 15 16 WHEREAS, Always the consummate music lover, Mr. Zackarian took on the challenge 17 of reintroducing Country music back into the state. In his late sixties, he formed a super star band 18 made up of many well-known Rhode Island musicians, and for several years, performed many shows at the Mishnock Barn; and 19 20 WHEREAS, Eddie Zack, Jr., will forever be remembered for his passion for music and
