It is enacted by the General Assembly as follows:

1 SECTION 1. Chapter 44-3 of the General Laws entitled "Property Subject to Taxation" is 2 hereby amended by adding thereto the following section: 3 44-3-3.2. Real estate holdings of nonprofit entities. 4 Commencing December 31, 2020, any nonprofit entity, which is exempt from payment of 5 the real property tax in any city or town shall provide information to the local tax assessor every five (5) years with respect to any real property owned or possessed by the nonprofit entity as 6 7 follows: 8 (1) The address and assessor's plat and lot number; 9 (2) Photographs, including any buildings or structures located on the property; and (3) A description of the usage and/or percentage of use of any building or structure. 10 SECTION 2. This act shall take effect upon passage. 11
