HOUSE RESOLUTION

PROCLAIMING THE WEEK OF MARCH 9TH THROUGH 15TH OF 2020 TO BE "BRAIN INJURY AWARENESS WEEK" IN THE STATE OF RHODE ISLAND

1	WHEREAS, The Brain Injury Association of Rhode Island has projected that more than
2	14,000 residents of Rhode Island will sustain a traumatic brain injury this year; and
3	WHEREAS, The Brain Injury Association of Rhode Island has identified brain injury as
4	the leading cause of death and disability among children and young adults in this country; and
5	WHEREAS, Brain injury is an extremely costly public health issue; and
6	WHEREAS, Advances in medical technology have enabled many persons with severe
7	brain injury to survive these injuries; and
8	WHEREAS, Persons with brain injury may need specialized rehabilitation programs and
9	other services to meet specific needs to live life to maximum potential; and
10	WHEREAS, Most forms of insurance, both public and private, that are available to
11	persons with brain injuries may not cover the rehabilitative and long-term care needs of these
12	individuals; and
13	WHEREAS, People with brain injury and their families too often must choose between
14	financial hardship or discontinuing critical treatment and services due to the substantial long-term
15	costs; and
16	WHEREAS, Without specialized community services, people with brain injury may
17	become inappropriately institutionalized; and
18	WHEREAS, Providing treatment methods and services to people with brain injury must
19	be a priority for the State of Rhode Island; and

1 WHEREAS, In partnership with the Centers for Disease Control and Prevention (CDC), 2 the Health Resources and Services Administration (HRSA), the Defense Veterans Brain Injury 3 Center (DVBIC), and the Brain Injury Association of America, the Brain Injury Association of 4 Rhode Island strives to increase awareness of both acquired and traumatic brain injuries, thus 5 making prevention and safety measures part of the American culture, and decreasing the number 6 of brain injuries; now, therefore be it

RESOLVED, That this House of Representatives of the State of Rhode Island and
Providence Plantations hereby proclaims the week of March 9th through 15th of 2020, to be "Brain
Injury Awareness Week" in the State of Rhode Island; and be it further
