It is enacted by the General Assembly as follows:

SECTION 1. Section 40-11-6.1 of the General Laws in Chapter 40-11 entitled "Abused and Neglected Children" is hereby amended to read as follows:

40-11-6.1. Penalty for failure to report or perform required act.

4 (a) Any person, official, physician, except the persons identified in subsection (b) of this 5 section, or institution required by this chapter to report known or suspected child abuse or neglect or to perform any other act who knowingly fails to do so or who knowingly prevents any person 6 7 acting reasonably from doing so shall be guilty of a misdemeanor, and upon conviction thereof, shall be subject to a fine of not more than five hundred dollars (\$500) or imprisonment for not more 8 9 than one year or both. In addition, any person, official, physician, or institution who knowingly 10 fails to perform any act required by this chapter or who knowingly prevents another person from 11 performing a required act shall be civilly liable for the damages proximately caused by that failure. 12 (b) Any coach, teacher, or school administrator required by this chapter to report known or 13 suspected child abuse or neglect, sexual assault or battery involving a child, or who knowingly fails 14 to perform any other act required by law for the protection or safety of a child, or who knowingly 15 prevents any person acting reasonably from doing so, shall be guilty of a felony, and upon conviction therefore, shall be subject to a fine not less than five thousand dollars (\$5,000), nor more 16 17 than ten thousand dollars (\$10,000), or to imprisonment for not more than five (5) years, or both.

EXPLANATION

BY THE LEGISLATIVE COUNCIL

OF

AN ACT

RELATING TO HUMAN SERVICES -- ABUSED AND NEGLECTED CHILDREN

1	This act would require that any coach, teacher, or school administrator required to report
2	known or suspected child abuse or neglect, sexual assault or battery involving a child or to perform
3	any other act who knowingly fails to do so would be guilty of a felony, and upon conviction
4	therefore, would be subject to a fine not less the five thousand dollars (\$5,000), nor more than ten
5	thousand dollars (\$10,000), or to imprisonment for not more than five (5) years, or both.
6	This act would take effect upon passage.
