Mr. Speaker:

I hereby move to amend 2008 -- H 8041 SUBSTITUTE A, entitled "AN ACT RELATING TO PUBLIC PROPERTY AND WORKS -- LABOR AND PAYMENT OF DEBTS BY CONTRACTORS", as follows:

By deleting all of the language following the enactment clause and inserting in place thereof the following:

"SECTION 1. Chapter 37-13 of the General Laws entitled "Labor and Payment of Debts by Contractors" is hereby amended by adding thereto the following section:

37-13-3,.1. Public works contract apprenticeship requirements. — (a) Notwithstanding any laws to the contrary, all general contractors and subcontractors who perform work on any awarded public works contract valued at least one hundred thousand dollars (\$100,000) shall employ apprentices within their work force required for the performance of the awarded contract that comply with the apprentice to journeyman ratio for each trade approved by the apprenticeship council of the department of labor and training. All general contractors and their subcontractors must properly classify their workers as employees, rather than independent contractors in accordance with state and federal law, for purposes of unemployment taxes, social security taxes, income taxes, withholding taxes, temporary disability insurance, workers' compensation insurance and the like.

FLOOR AMENDMENT TO 2008 -- H 8014 SUBSTITUTE A

#### AN ACT RELATING TO INSURANCE

Mr. Speaker:

I hereby move to amend 2008 -- H 8014 SUBSTITUTE A, entitled "AN ACT RELATING TO INSURANCE", as follows:

By deleting all language after the enactment clause and inserting in place thereof the following:

"SECTION 1. Chapter 27-18 of the General Laws entitled "Accident and Sickness Insurance Policies" is hereby amended by adding thereto the following section:

27-18-69. Licensed ambulance service. – (a) No individual or group health insurance contract, plan or policy delivered, issued for delivery, or renewed in this state on or after January 1, 2009 shall provide for a co-payment for ground ambulance services in excess of fifty dollars (\$50.00).

(b) As used in this section, the term "ground ambulance services" shall mean those services provided by an ambulance service licensed to operate in Rhode Island in accordance with section 23-4.1-6. The term excludes air and water ambulance services and ambulance services provided outside of Rhode Island.

(c) This section shall not apply to insurance coverage providing benefits for: (1) hospital confinement indemnity; (2) disability income; (3) accident only; (4) long-term care; (5) Medicare supplement; (6) limited benefit health; (7) specified disease indemnity; (8) sickness or bodily injury or death by accident or both; and (9) other limited benefit policies.

# APPENDIX VETO MESSAGE FROM THE GOVERNOR

TO THE HONORABLE, THE SPEAKER OF THE HOUSE OF REPRESENTATIVES:

In accordance with the provisions of Section 14, Article IX of the Constitution of the State of Rhode Island and Section 43-1-4 of the Rhode Island General Laws, I transmit, with my disapproval, 2008-H 7040, As Amended, "An Act Relating to State Affairs and Government."

This act would permit Rhode Island's two gambling facilities, Twin River and Newport Grand to operate video lottery terminals (VLT's) on a twenty-four hour basis on weekends and state and federal holidays. The revenue generated from the additional hours of operation would be deposited into the State treasury, with a small share of the money going to the host communities of Lincoln and Newport.

As I have said repeatedly since debate over this legislation started last year, the host communities should have some say when it comes to deciding the hours of operation for these two facilities. Twin River and Newport Grand are very large entities, attracting thousands of people on a daily basis, and while the State generates significant revenue from their operation, Lincoln and Newport are forced to bear the burdens of having such large facilities opened in their communities.

It is generally the prerogative of cities and towns to set the hours of operations for restaurants, bars, grocery and convenient stores and other businesses. Under the scheme passed by the General Assembly, the people of Lincoln and Newport are at the mercy of large-scale gambling facilities, with no recourse.

For these reasons, I disapprove of this legislation and respectfully urge your support of this veto.
