AN ACT RELATING TO STATE AFFAIRS AND GOVERNMENT -- RESTRICTING RADIO FREQUENCY IDENTIFICATION DEVICES

Mr. Speaker:

I hereby move to amend 2008 -- H 8027, entitled "AN ACT RELATING TO STATE AFFAIRS AND GOVERNMENT -- RESTRICTING RADIO FREQUENCY IDENTIFICATION DEVICES", as follows:

- 1. On page 1, by deleting all of the language on lines 8 and 9, and by substituting in place thereof the following language: "movement or identity of any student on school grounds, at school functions, or while being transported to or from school grounds or school functions."
- 2. On page 2, line 3, by deleting the word "patients" and substituting in place thereof the word "students".
- 3. On page 2, line 5, by deleting the word "complaint" and substituting in place thereof the word "compliant".
- 4. On page 2, line 9, by deleting the word "individual" and substituting in place thereof the word "student".
- 5. On page 2, by deleting all of the language on lines 10 and 11, and by substituting in place thereof the following language:
- "(d) Nothing contained in this chapter shall be construed to apply to or prohibit the use of global positioning system devices.
- <u>42-149-4.</u> Use of radio frequency identification devices for toll payment. The personally identifiable information of persons who use radio frequency identification devices to facilitate the payment of tolls shall not be considered public information. Personally identifying information may be released to law enforcement agencies only for: (a) toll enforcement purposes; or (b) for other purposes if accompanied by a court order."
