- I hereby move to amend 2009 -- H 5112 SUBSTITUTE A, entitled "AN ACT RELATING TO CENTERS FOR MEDICARE AND MEDICAID SERVICES WAIVER AND EXPENDITURE AUTHORITY", as follows:
  - 1. On page 6, by inserting the following language between lines 4 and 5:
- "(c) To ensure all services allowable for Medicare reimbursement for beneficiaries who are dually eligible, selective contractors must be willing and able to accept Medicare."
- 2. On page 6, line 23, by deleting the word "excluding" and inserting in place thereof the phrase "in addition to".
- 3. One page 6, line 24 by inserting the words "and mental disabilities" immediately following the word "disabilities".
