"The levy of a supplemental tax authorized under this section for the fiscal year ending June 30, 2009 shall be subject to, and conditioned upon the town of North Providence making one hundred percent (100%) of the actuarially required contribution to all town pension funds for the fiscal year ending June 30, 2009, and each fiscal year thereafter. Notwithstanding the requirement hereunder to make the actuarially required contribution, for fiscal years beginning with the fiscal year ending in 2010, the town may petition the auditor general for permission to

make less than one hundred percent (100%) of the actuarially required contribution. If the town fails to make these actuarially required contributions, the authorization to levy said tax under this section shall be rescinded, and any supplemental tax levied hereunder shall be unenforceable."
