Welcome to all of the family and friends who have joined us today ... and who have been so supportive through the rigors of campaigns and the demands of public service. Thank you for your encouragement ... and your patience.

I am very pleased to welcome eight new members to the chamber, and to welcome back all my colleagues who were reelected.

I am very fortunate to serve alongside tremendous partners in leadership who have demonstrated time and again their commitment to this institution and to Rhode Island, and have proven that, by working together, we can address the challenges facing our state.

Dominick Ruggerio is a steady and fair-minded leader. He has worked for years to help his colleagues achieve their goals to improve the state. He leads with an open door, and an open mind. I value his partnership and his friendship.

- Encourage urban revitalization and bolster the construction industry through a targeted historic tax credit:
- Further economic development through the arts;
- Address budgetary challenges in a manner which preserves essential services upon which Rhode Islanders rely while improving our state's competitiveness; and
- Improve the affordability, quality and transparency of our health care system.

Our goals are significant. So too are the challenges we will face.

Continued vigilance is required to ensure protection of the environment and our most precious of natural resources, Narragansett Bay.

As we celebrate enactment of the new open records act, we will continue to work towards further improvements in government transparency.

Today, the citizens and families of Newtown, Connecticut are in our thoughts and prayers. Public safety in our schools will be a priority as we work with the Attorney General, the State Police and our federal partners to address the many concerns that this tragedy has caused the country to focus on.

These remain difficult times in our state, as they are across the country, and indeed across the globe. Many Rhode Islanders are experiencing financial hardships. While there are many important issues we will address over the course of the session, we as a Senate must remain focused on the paramount issue of economic development.

Working together, with strength and compassion, courage and determination, we can move Rhode Island towards a brighter tomorrow.

Today, as you undertake these challenges, you follow in the steps of many leaders that came before you. Some of those leaders are no strangers to this chamber, such as Senator Thomas Goodwin, Senator Gene McCaffrey, Senator Jack Reed, **and others whose memory we honor by our service:** Governor J. Joseph Garrahy, Senator Robert J. McKenna, Justice Florence Murray, and Chief Justice Joseph Weisberger.

Serving in the Senate is an honor. It will be a challenge, and it is a trust that the people of Rhode Island have placed in you.
