3. On page 2, line 24, by deleting the language "<u>March 7, 2013</u>" and by inserting in place thereof the following language: "upon approval of the final plan for administrative structure".

4. On page 2, line 30, by deleting the language "as of".

5. On page 2, line 30, by deleting the language: "March 7, 2013" and by inserting in place thereof the

following language: "upon approval of the final plan for administrative structure".
