Dear Speaker Mattiello and President Paiva Weed:

On behalf of Governor Raimondo, I formally request permission to use the House Chamber on Tuesday, February 2, 2016, at 7:00 p.m. for the Governor to present her FY 2017 budget recommendation and her State of the State address. Consistent with discussions that we have had with you -- and notwithstanding the provisions of Section 35-3-7(a) of the Rhode Island General Laws -- Governor Raimondo intends to submit her FY 2017 budget recommendation (i.e., her plan of estimated revenues and proposed expenditures) on Tuesday, February 2, 2016.

The Governor is committed to continuing the strong partnership with you and with the other members of the General Assembly. That partnership resulted in important progress last year, including (1) making work pay for Rhode Island families by raising the minimum wage and expanding the Earned Income Tax Credit; (2) improving our business climate by enhancing predictability for businesses, eliminating the commercial sales tax on energy, and cutting taxes on small businesses; (3) creating important new economic development tools to attract new companies to invest here, and to encourage our existing businesses to grow; and (4) helping Rhode Islanders build the skills they need to get ahead, including by establishing the new Promise Rhode Island scholarship program to make college more affordable for more families.

We remain committed to working together so we can do even more this year to put people back to work, revitalize our economy, and ensure that everyone can "make it in Rhode Island." Thank you in advance for your consideration; please let me know if you have any questions.
