# Communication from Speaker K. Joseph Shekarchi:

I have reviewed the videotape of the March 17, 2023, hearing of the House Committee on State Government and Elections. During the course of that hearing, Representative Rebecca Kislak testified in support of a bill she sponsored, H-5763 AN ACT RELATING TO STATE AFFAIRS AND GOVERNMENT--EQUITY IMPACT STATEMENT ACT.

While asking questions as a member of the committee, Representative Robert Quattrocchi made several references about the applicability of the legislation to "Satanists" and "pedophiles" and directly asked Representative Kislak, "Are you a pedophile?"

Representative Quattrocchi's statements to Representative Kislak during the March 17<sup>th</sup>, hearing are not in keeping with the decorum or the integrity of this body. The use of suggestive and offensive language and the disparagement of an esteemed colleague will not be tolerated in this chamber.

I hereby direct that Representative Robert Quattrocchi be removed as a member of the House Committee on State Government and Elections, effective immediately.
