"Prohibit an ADU that otherwise complies with this chapter and applicable dimensional regulations from having up to two (2) bedrooms;"

2. On page 12, line 8, after the language "§ 42-128-8.1", by inserting the following language: ", unless such ADU is part of an inclusionary zoning or comprehensive permit application"
