RELATING TO ELECTIONS -- MAIL BALLOTS

Introduced By: Senators Quezada, Ujifusa, Tikoian, and Cano

Date Introduced: March 29, 2023

Referred To: Senate Judiciary

It is enacted by the General Assembly as follows:

1 SECTION 1. Sections 17-20-2.1, 17-20-3, 17-20-8, 17-20-10, 17-20-13 and 17-20-21 of
2 the General Laws in Chapter 17-20 entitled "Mail Ballots" are hereby amended to read as follows:

3 **17-20-2.1. Requirements for validity of mail ballot and mail ballot applications.**

4 (a) Any legally qualified elector of this state whose name appears upon the official voting
5 list of the city, town, or district of the city or town where the elector is qualified, and who desires
6 to avail himself or herself of the right granted to him or her by the Constitution and declared in this
7 chapter, may obtain from the local board in the city or town a form prepared by the secretary of
8 state as prescribed in this section, setting forth the elector's application for a mail ballot or may
9 apply online in accordance with § 17-20-2.3.

10 (b) Whenever any person is unable to sign his or her name because of ~~physical incapacity~~
11 ~~or otherwise, that person shall make his or her mark "X"~~ blindness, disability, or inability to read
12 or write, the voter or their assistant shall mark a box to indicate the voter cannot sign due to
13 blindness, disability, or inability to read or write, and include the full name, residence address, and
14 signature, of the person who provided assistance to the voter on a form provided by the secretary
15 of state. The representation relating to the voter's inability to sign shall be made under the pains
16 and penalties of perjury.

17 (c) To receive a ballot in the mail, an elector must submit an application in person or by
18 mail, so that it is received by the local board, or received electronically through the portal
19 established by § 17-20-2.3, not later than four o'clock (4:00) p.m. on the twenty-first (21st) day

1 before the day of any election referred to in § 17-20-1.

2 (d) In addition to those requirements set forth elsewhere in this chapter, a mail ballot, in
3 order to be valid, must have been cast in conformance with the following procedures:

4 (1) All mail ballots issued pursuant to § 17-20-2(1) shall be mailed to the elector at the
5 Rhode Island address provided by the elector on the application. In order to be valid, the voter must
6 affix his or her signature on all certifying envelopes containing a voted ballot.

7 (2) All applications for mail ballots pursuant to § 17-20-2(2) must state under oath the
8 name and location of the hospital, convalescent home, nursing home, or similar institution where
9 the elector is confined. All mail ballots issued pursuant to § 17-20-2(2) shall be delivered to the
10 elector at the hospital, convalescent home, nursing home, or similar institution where the elector is
11 confined.

12 (3) All mail ballots issued pursuant to § 17-20-2(3) shall be mailed to the address provided
13 by the elector on the application or sent to the board of canvassers in the city or town where the
14 elector maintains his or her voting residence. In order to be valid, the voter must affix his or her
15 signature on the certifying envelope containing voted ballots. Any voter qualified to receive a mail
16 ballot pursuant to § 17-20-2(3) shall also be entitled to cast a ballot pursuant to the provisions of
17 United States Public Law 99-410, the Uniformed and Overseas Citizens Absentee Voting Act
18 (UOCAVA).

19 (4) All mail ballots issued pursuant to § 17-20-2(4) may be mailed to the elector at the
20 address within the United States provided by the elector on the application or sent to the board of
21 canvassers in the city or town where the elector maintains his or her voting residence. In order to
22 be valid, the voter must affix his or her signature on all certifying envelopes containing a voted
23 ballot. In order to be valid, all ballots sent to the elector at the board of canvassers, must be voted
24 in conformance with the provisions of § 17-20-14.2.

25 (e) Any person knowingly and willfully making a false application or certification, or
26 knowingly and willfully aiding and abetting in the making of a false application or certification,
27 shall be guilty of a felony and shall be subject to the penalties provided for in § 17-26-1.

28 (f) In no way shall a mail ballot application be disqualified if the voter's circumstances
29 change between the time of making the application and voting his or her mail ballot as long as the
30 voter remains qualified to receive a mail ballot under the provisions of § 17-20-2. The local board
31 of canvassers shall provide the state board of elections with written notification of any change in
32 circumstances to a mail ballot voter.

33 **17-20-3. Definitions.**

34 (a) Wherever used in this chapter, every word importing only the masculine gender is

1 construed to extend to, and include, females as well as males.

2 (b) Whenever used in this chapter, “bipartisan pairs of supervisors” for primaries means a
3 supervisor representing the endorsed candidates and a supervisor representing a majority of
4 unendorsed candidates, and for nonpartisan elections and primaries means non-partisan pairs of
5 supervisors.

6 (c) Wherever used in this chapter, “employed outside of the United States” includes any
7 person who is:

8 (1) Employed by any agency, department, or division of the United States government and
9 who, by reason of that employment, resides outside of the continental United States;

10 (2) Employed outside the territorial limits of the United States; or

11 (3) A spouse or dependent residing with persons so employed.

12 (d) Wherever used in this chapter, “services intimately connected with military operations”
13 includes members of religious groups or welfare agencies assisting members of the armed forces
14 who are officially attached to and serving with the armed forces and their spouses and dependents,
15 and the spouses and dependents of members of the armed forces and of the merchant marine;
16 provided, that the spouses and dependents are residing outside of the state with the members of the
17 armed forces, merchant marine, or members of the religious or welfare agencies.

18 (e) Whenever a signature is required by a voter in this chapter, “signature” also means the
19 voter’s mark “X” if the person is unable to sign his or her name because of ~~physical incapacity or~~
20 ~~otherwise~~ blindness, disability, or inability to read or write, or by affixing the voter's signature by
21 a person providing assistance to the voter in accordance with the requirements of this chapter.

22 (f) Whenever used in this chapter, “bipartisan” means not of the same recognized political
23 party.

24 (g) Whenever used in this chapter, “emergency” voting pursuant to § 17-20-2.2(g) shall be
25 construed to mean “early” voting.

26 **17-20-8. Application for ballot.**

27 (a) Whenever any person is unable to sign his or her name because of ~~physical incapacity~~
28 ~~or otherwise, that person shall make his or her mark “X”~~ blindness, disability, or inability to read
29 or write, the voter or their assistant shall mark a box to indicate the voter cannot sign due to
30 blindness, disability, or inability to read or write, and include the full name, residence address, and
31 signature of the person who provided assistance to the voter on a form provided by the secretary of
32 state. The representation relating to the voters inability to sign shall be made under the pains and
33 penalties of perjury.

34 (b) Notwithstanding any other provision of this chapter as to time and manner thereof, it

1 shall be the duty of the applicant to cause the mail ballot application or the emergency mail ballot
2 application, as the case may be, to be processed by the local board so that the applicant may receive
3 the ballot, cast it, and cause delivery thereof to be made to the state board not later than eight
4 o'clock (8:00) p.m. on the date of election.

5 (c) The local board shall maintain a separate list of names and addresses of all applicants
6 and a copy of the list shall be made available for inspection to any person upon request.

7 (d) Any person knowingly and willfully making a false application or certification or
8 knowingly and willfully aiding and abetting in the making of a false application or certification
9 shall be guilty of a felony.

10 (e) Voters shall be able to apply for a mail ballot electronically through the voter
11 registration portal established by § 17-20-2.3.

12 **17-20-10. Certification of applications — Issuance of ballots — Marking of lists —**
13 **Mailing address.**

14 (a) Upon receipt of the application, the local board shall immediately examine it and
15 determine whether it complies with each of the requirements set forth by this chapter and compare
16 the signature on the ballot application with the signature contained on the original registration card
17 or on the central voter registration system, except as may be otherwise provided by law, to satisfy
18 itself that the applicant is a qualified voter. Upon determining that it does meet each requirement
19 of this chapter and that the signature appears to be the same, the local board shall mark the
20 application "accepted" and record in the space provided on the ballot application the senatorial,
21 representative, and voting district in which the applicant should vote.

22 (b) The local board shall also record the city or town code and district information in the
23 mailing label section of the mail ballot application. The local board shall also print or type the name
24 of the elector and the complete mailing address in that section. If the local board does not accept
25 the application, the local board shall return the application to the elector, together with a form
26 prescribed by the secretary of state, specifying the reason or reasons for the return of the application.

27 (c) Not later than 4:00 p.m. on the eighteenth (18th) day before the day of any election
28 referred to in this chapter or within seven (7) days of receipt by the local board, whichever occurs
29 first, the local board shall certify the applications to the secretary of state through the central voter
30 registration system as this procedure is prescribed by the secretary of state. Upon the certification
31 of a mail ballot application to the secretary of state, the local board shall enter on the voting list the
32 fact that a mail ballot application for the voter has been certified and shall cause the delivery of the
33 certified mail ballot applications together with the signed certified listing thereof in sealed packages
34 to the state board of elections.

1 (d)(1) Upon the ballots becoming available, the secretary of state shall immediately issue
2 and mail, by first-class mail, postage prepaid, a mail ballot to each eligible voter who has been
3 certified. With respect to voters who have applied for these mail ballots under the provisions of §
4 17-20-2(1), the secretary of state shall include with the mail ballots a stamped, return envelope
5 addressed to the board of elections.

6 (2) The secretary of state shall include on the mail ballot envelope a numerical or
7 alphabetical code designating the city or town where the voter resides. The secretary of state shall
8 immediately thereafter indicate on the voter's record that the secretary of state has sent mail ballots;
9 provided that this mark shall serve solely to indicate that a mail ballot has been issued and shall not
10 be construed as voting in the election.

11 (e) Prior to each election, the secretary of state shall also furnish to the chairperson of the
12 state committee of each political party a list of the names and residence addresses of all persons to
13 whom mail ballots have been issued. The secretary of state shall also furnish to a candidate for
14 political office, upon request, a list of the names and residence addresses of all persons to whom
15 mail ballots have been issued within his or her district.

16 (f) If a ballot is returned to the secretary of state by the postal service as undeliverable, the
17 secretary of state shall consult with the appropriate local board to determine the accuracy of the
18 mailing address, and the secretary of state shall be required to remail the ballot to the voter using
19 the corrected address provided by the local board. If the local board is unable to provide a different
20 address than that to which the ballot was originally mailed, the ballot shall be reissued by the
21 secretary of state to the board of canvassers in the city or town where the voter resides utilizing the
22 numerical or alphabetical code established in subsection (d) of this section. The board shall then
23 attempt to notify the voter at his or her place of residence that the ballot has been returned as
24 undeliverable. The ballot must be voted in accordance with the provisions of this chapter.

25 (g) The acceptance of a mail ballot application by the board of canvassers and the issuance
26 of a mail ballot by the secretary of state shall not create any presumption as to the accuracy of the
27 information provided by the applicant or as to the applicant's compliance with the provisions of
28 this chapter. Any inaccuracy in the provided information or irregularity in the application may be
29 raised as a challenge to the ballot before the board of elections at the time of certification. If the
30 challenge raised at that time is meritorious, the ballot shall be voided.

31 (h) Within two (2) business days of receipt by the local board, the board shall certify
32 emergency mail ballot applications and shall cause the delivery of the emergency mail ballot
33 applications, and certification sheet in sealed packages to the state board of elections.

34 **17-20-13. Form of application.**

1 The application to be subscribed by the voters before receiving a mail ballot shall, in
2 addition to those directions that may be printed, stamped, or written on it by authority of the
3 secretary of state, be in substantially the following form:

32 () 2. I am confined in a hospital, convalescent home, nursing home, rest home, or similar
33 institution within the State of Rhode Island. Provide the name and address of the facility where you
34 are residing in BOX B above.

1 () 3. I am employed or in service intimately connected with military operations or because
2 I am a spouse or dependent of such person, or I am a United States citizen and will be outside the
3 United States. Complete BOX B above or the ballot will be mailed to the local board of canvassers.

4 () 4. I choose to vote by mail. If the ballot is not being mailed to your voter registration
5 address (BOX A above) please provide the address within the United States where you are
6 temporarily residing in BOX B above. If you request that your ballot be sent to your local board of
7 canvassers please indicate so in BOX B above.

8 BOX D OATH OF VOTER

9 I declare that all of the information I have provided on this form is true and correct to the
10 best of my knowledge. I further state that I am not a qualified voter of any other city or town or
11 state and have not claimed and do not intend to claim the right to vote in any other city or town or
12 state. If unable to sign name because of ~~physical incapacity or otherwise~~, blindness, disability, or
13 inability to read or write, the applicant shall ~~make his or her~~ mark "X" the box to indicate the voter
14 cannot sign due to blindness, disability, or inability to read or write, and include the full name,
15 residence address, and signature of the person who provided assistance to the voter.

18 **17-20-21. Certifying envelopes.**

19 The secretary of state shall cause to be prepared and printed and shall furnish with each
20 mail ballot an envelope for sealing up and certifying the ballot when returned. The envelope shall
21 be printed in substantially the following form:

22 "After marking ballot or ballots, fold and enclose in this envelope and seal it. Certify to
23 statement hereon. Enclose in envelope addressed to board of elections, which must receive the
24 envelope not later than the time prescribed by § 17-18-11 for the closing of polling places on the
25 day of election."

EXPLANATION
BY THE LEGISLATIVE COUNCIL
OF
A N A C T
RELATING TO ELECTIONS -- MAIL BALLOTS

1 This act would eliminate the requirement of signing with an "X" for voters who cannot
2 sign their name due to blindness, disability, or inability to read or write, and would require that a
3 box is checked on the application or ballot certification envelope and any person providing
4 assistance to the voter in signing the ballot must provide their signature and information.

5 This act would take effect upon passage.
