It is enacted by the General Assembly as follows:

1 2 SECTION 1. Section 28-14-12 of the General Laws in Chapter 28-14 entitled "Payment of 3 Wages" is hereby amended to read as follows: 28-14-12. Employment records. 4 5 (a) Every employer shall keep a true and accurate record of hours worked and wages paid each pay period to each employee in any form that may be prescribed by the director. The employer 6 7 shall keep the records on file for at least three (3) years after the entry of the record. At the start of employment, an employer shall provide each of its employees, a written notice, in English, 8 9 containing the following information: 10 (1) The rate or rates of pay and basis thereof, including whether the employee is to be paid by the hour, shift, day, week, salary, piece, commission, or other method, and the specific 11 12 application of any additional rates; 13 (2) Allowances, if any, claimed, pursuant to permitted meals and lodging; 14 (3) Employer's policy on sick, vacation, personal leave, holidays and hours; (4) The employee's employment status and whether the employee is exempt from minimum 15 wage and/or overtime; 16 17 (5) A list of deductions that may be made from the employee's pay; (6) The number of days in the pay period, the regularly scheduled payday, and the payday 18 19 on which the employee will receive the first payment of wages earned;

- 1 (7) The legal name of the employer and the operating name of the employer, if different
- 2 <u>from its legal name;</u>
- 3 (8) The physical address of the employer's main office or principal place of business, and
- 4 <u>its mailing address if different; and</u>
- 5 (9) The telephone number of the employer.
- 6 (b) The employer shall keep a copy of the notice provided pursuant to the provisions of
- 7 <u>subsection (a) of this section, signed by each employee, thereby acknowledging their receipt of the</u>
- 8 <u>notice.</u>

SECTION 2. This act shall take effect on January 1, 2026.

EXPLANATION

BY THE LEGISLATIVE COUNCIL
