1 WHEREAS, It is with deep sadness that we have learned of the passing of Graham B. 2 Kehoe. Born in Providence, RI on September 23, 1992, he was the beloved son of his adopted 3 parents Kevin C. Kehoe and Rhonda Brown-Kehoe and much adored brother Connor; and WHEREAS, With his "elf-like" grin, Graham had an ability to make everyone around 4 5 him feel loved. He was a nonstop, curious child who mastered tasks that were deemed "impossible" for someone his age. Graham began to read and write before kindergarten and 6 7 would remember songs and stories after hearing them only once; and 8 WHEREAS, In February 2002, seizures prohibited Graham from walking. A wheelchair 9 became necessary and Graham somehow made this ordeal a pleasant one for those around him. 10 He had the wheelchair in his favorite color, hot purple and the children at school were on a list for 11 a turn to be the driver of the "purple mean machine"; and 12 WHEREAS, Despite Graham's disease, he remained consistently happy with a smile and 13 giggle that was infectious. He developed a penchant for blondes among his favorite caregivers at 14 Hasbro Children's Hospital and when asked about his love of blondes, a grin would appear 15 followed by a hug; and 16 WHEREAS, Graham's September, 2002 hospital stay, where he celebrated his 10<sup>th</sup> 17 birthday, could be noticed from the intersection of Dudley and Eddy Streets with a neon sign of a

huge smiling face and hello. Graham stated this would be his last visit to "my hospital," the last

of treatments and hospital stays. His exceptional love of nature and never wanting to see any

His parents made a promise to honor his wishes of not returning to the hospital, thus a 48-hour vigil began letting him peacefully pass to what he always called heaven "my house, my home"; now, therefore be it
