It is enacted by the General Assembly as follows:

1	SECTION 1. Title 2 of the General Laws entitled "AGRICULTURE AND FORESTRY"
2	is hereby amended by adding thereto the following chapter:

7	2-25-2. Legislative findings The general assembly hereby finds and declares:
8	(1) A viable agricultural and seafood sector in Rhode Island represents part of a secure
9	regional food supply, which in turn lends itself to energy and economic efficiencies;
10	(2) The federal government and regional entities have established and continue to
11	establish programs and processes to support local agricultural production and increased
12	consumption of locally produced food, and Rhode Island functions in whole or in part in the
13	context of federal and regional programs;
14	(3) The general public is increasingly interested in locally produced food;
15	(4) The benefits of local food systems to local communities include open land, jobs,
16	nutritious and safe foods, and youth education opportunities;
17	(5) Farms and commercial fishing are an integral part of Rhode Island's overall economy;
18	(6) Encouraging the continued growth of Rhode Island's agricultural and seafood sectors

1	is integral to reducing food insecurity in Rhode Island;
2	(7) Relationship-based food systems such as farm-to-school programs, community
3	supported agriculture (CSA) programs, farmers' markets, and pick-your-own operations are
4	increasingly popular and offer areas of opportunity for new farmers; and
5	(8) The state of Rhode Island has historically established programs to provide for and
6	regulate the agriculture and commercial fishing sectors.
7	2-25-3. Legislative Intent The general assembly intends:
8	(1) To support and develop more robust and self-sustaining agricultural and seafood
9	sectors that also promotes emerging agricultural industries;
10	(2) That policies and programs of the state will support and promote the Rhode Island
11	agriculture and seafood industries as a vital component of the state's economy and essential

13	(3) That current policies and programs pertaining to the viability of Rhode Island's
14	agricultural and seafood industries be reviewed and confirmed or changed in order to assure the
15	long-term economic prosperity of the industries; and
16	(4) That Rhode Island will promote processing and consumption of agricultural and
17	seafood products from within Rhode Island.

15	carry out the purposes of the program established in section 2-25-5.
16	2-25-7. Use of Funds (a) A non-profit entity or small or beginning farmer may apply
17	to the department of environmental management for a grant to be used to fulfill the purposes of
18	the program as stated in subdivisions 2-25-5(3) and 2-25-5(4). Any grant disbursed under this
19	program shall not exceed twenty thousand dollars (\$20,000) per year. Applications for grants
20	authorized under this section shall:
21	(1) Provide a brief summary of the nonprofit entity or small or beginning farmer's
22	mission, goals, history, programs, and major accomplishments, success stories and qualifications;
23	(2) Briefly describe the proposed project or program, the capacity to carry out the
24	program and who will benefit from the program;
25	(3) Describe the expected outcomes and the indicators of those outcomes;
26	(4) Outline the timeline to be used in the implementation of the program or project; and
27	(5) Provide a program or project budget.
28	(b) The funds shall also be used by the department to provide administrative and
29	technical support of the program, and to leverage program funds with other potential federal, state
30	or nonprofit funding sources, and shall serve to develop, implement and enforce when appropriate
31	food safety related standards and programs related to local agriculture and seafood in
32	coordination with the Rhode Island department of health and appropriate federal agencies.
33	2-25-8. Accountability and oversight (a) On an annual basis, the department shall
34	prepare a report that details the performance of the local agriculture and seafood small grants and

1	technical assistance program, and the disbursements made during the prior year from the local
2	agriculture and seafood small grants and technical assistance fund and other sources, and how the
3	department plans to allocate and use funds provided through the local agriculture and seafood
4	small grants and technical assistance fund during the next year. The report shall include any
5	additional, relevant information relating to the administration of the program, and the status of
6	any state-based agricultural assessments and local food production assessments.
7	(b) The department shall annually schedule and conduct one or more public meetings to
8	solicit input from the general public on whether the program is meeting its intended purposes, and
9	to solicit recommendations for modifying the program.
10	(c) The department shall annually submit the report, including an addendum summarizing
11	the feedback provided at the public meeting(s) referenced section in 2-25-9, to the general
12	assembly.
13	2-25-9. Powers and Duties The department of environmental management may adopt
14	any rules necessary for the administration of this section.

33	strong sustainable food economy and healthful nutrition practices.
