It is enacted by the General Assembly as follows:

SECTION 1. Title 42 of the General Laws entitled "STATE AFFAIRS AND 1 2 GOVERNMENT" is hereby amended by adding thereto the following chapter: 3 CHAPTER 18.2 RHODE ISLAND PREVENTION, HEALTH PROMOTION AND PUBLIC HEALTH 4 5 **COUNCIL** 6 <u>42-18.2-1. Establishment of Council.</u> – There is hereby established a Rhode Island 7 prevention, health promotion, and public health council (hereafter referred to as "the council"). 8 The department of health shall grant to the council reasonable access to appropriate staff. 9 42-18.2-2. Composition of the Council. – (a) The council shall have twenty-one (21) 10 members as follows: (1) The director of the department of health, who shall serve as chairperson 11 of the board; (2) The director of the department of labor and training; (3) The secretary of health 12 and human services; (4) The director of the department of environmental management; (5) The commissioner of elementary and secondary education; (6) The director of the department of 13 14 administration; (7) The director of the division of agriculture; (8) The director of the economic development corporation; (9) The director of the department of transportation; (10) The president 15 of the University of Rhode Island; (11) The associate dean of the public health program of Brown 16 University; (12) The dean of the college of pharmacy; (13) The president of the Rhode Island 17

medical society; (14) The president of the Rhode Island dental society; (15) The president of the

| 9 | (c) Members from state government shall serve in an ex officio capacity as long as they |
| 10 | are eligible. |
| 11 | (d) The council may establish subcommittees and advisory bodies as deemed necessary |
| 12 | by the members. |
| 13 | 42-18.2-3. Meetings of the council. – The council shall meet at the call of the chair, no |
| 14 | less than quarterly. |
| 15 | 42-18.2-4. Purpose and Duties. – The council shall: |
| 16 | (1) Provide coordination and leadership at the state level, and among all state departments |
| 17 | and agencies, with respect to prevention, wellness and health promotion practices, the public |
| 18 | health system, and integrative health care in Rhode Island; |
| 19 | (2) Develop a statewide prevention, health promotion, public health, and integrative |
| 20 | health care strategy that incorporates the most effective and achievable means of improving the |
| 21 | health status of Rhode Islanders and reducing the incidence of preventable illness and disability |
| 22 | across the state; |
| 23 | (3) Provide recommendations to the governor and the general assembly concerning the |
| 24 | most pressing health issues confronting the state and changes in state policy to achieve wellness, |
| 25 | health promotion, and public health goals, including the reduction of tobacco use, sedentary |
| 26 | behavior, and poor nutrition; |
| 27 | (4) Consider and propose evidence-based models, policies, and innovative approaches for |
| 28 | the promotion of transformative models of prevention, integrative health, and public health on |
| 29 | individual and community levels across the state; |
| 30 | (5) Submit annual reports required under section 6 of this chapter; |
| 31 | (6) Carry out other activities determined appropriate by the governor or as requested by |
| 32 | the general assembly; and |
| 33 | (7) Make available to the public all information about activities of the council. |
| 34 | 42-18.2-5. Rhode Island Preventative Strategy. – Not later than one year after the date |

| 2 | make public a Rhode Island prevention, health promotion and public health strategy, and shall |

| 4 | (1) Set specific goals and objectives for improving the health of Rhode Island through |
| 5 | prevention, health promotion, and public health programs, consistent with ongoing goal setting |
| 6 | efforts conducted by specific agencies; |
| 7 | (2) Establish specific and measurable actions and timelines to carry out the strategy, and |
| 8 | determine accountability for meeting those timelines, within and across state departments and |
| 9 | agencies; and |
| 10 | (3) Make recommendations to improve staff efforts relating to prevention, health |
| 11 | promotion, public health, and integrative health care practices to ensure state efforts are |
| 12 | consistent with available standards and evidence. |
| 13 | 42-18.2-6. Annual Report. – (a) Not later than January 1, 2014, and annually thereafter, |
| 14 | the council shall submit to the governor and the general assembly, a report that: |
| 15 | (1) Describes the activities and efforts on prevention, health promotion, and public health |
| 16 | and activities to develop and/or revise the state prevention strategy conducted by the council |
| 17 | during the period for which the report is prepared; |
| 18 | (2) Describes the progress in meeting specific prevention, health promotion, and public |
| 19 | health goals defined in the strategy and further describes corrective actions recommended by the |
| 20 | council and taken by relevant agencies and organizations to meet these goals; |
| 21 | (3) Contains a list of state priorities on health promotion and disease prevention to |
| 22 | address lifestyle behavior modification (smoking cessation, proper nutrition, appropriate exercise, |
| 23 | mental health, behavioral health, substance use disorder, and domestic violence screenings) and |
| 24 | the prevention measures for the five (5) leading disease killers in Rhode Island; and |
| 25 | (4) Contains specific science-based initiatives to achieve the measurable goals of the |
| 26 | prevention strategy regarding nutrition, exercise, and smoking cessation, and targeting the five (5) |
| 27 | leading disease killers in Rhode Island. |
| 28 | (b) The director of health shall address a joint session of the general assembly during the |
| 29 | month of January or February of each year, at the invitation of the speaker of the house, to present |
| 30 | the key findings and recommendations of the annual report. |
| 31 | 42-18.2-7. Applicability of other laws. – The council, as well as any subcommittees or |
| 32 | advisory bodies it may establish, shall be subject to the provisions of chapter 38-2, access to |
| 33 | public records act, and chapter 42-46, open meetings act. |
| 34 | 42-18.2-8. Severability. – If any provision of this chapter or the application of this |
