It is enacted by the General Assembly as follows:

1 SECTION 1. Sections 21-28-4.01, 21-28-4.11 and 21-28-4.14 of the General Laws in

Chapter 21-28 entitled "Uniform Controlled Substances Act" are hereby amended to read as

4 <u>21-28-4.01. Prohibited acts A -- Penalties. --</u> (a) (1) Except as authorized by this

chapter, it shall be unlawful for any person to manufacture, deliver, or possess with intent to

manufacture or deliver a controlled substance.

7 (2) Any person who is not a drug addicted person, as defined in section 21-28-1.02(18),

8 who violates this subsection with respect to a controlled substance classified in schedule I or II,

except the substance classified as marijuana, is guilty of a crime and upon conviction may be

imprisoned to a term up to life, or fined not more than five hundred thousand dollars (\$500,000)

nor less than ten thousand dollars (\$10,000), or both.

12 (3) Where the deliverance as prohibited in this subsection shall be the proximate cause of

death to the person to whom the controlled substance is delivered, it shall not be a defense that

the person delivering the substance was at the time of delivery, a drug addicted person as defined

in section 21-28-1.02(18).

16 (4) Any person, except as provided for in subdivision (2) of this subsection, who violates

17 this subsection with respect to:

18 (i) A controlled substance classified in schedule I or II, is guilty of a crime and upon

conviction may be imprisoned for not more than thirty (30) years, or fined not more than one

- 1 hundred thousand dollars (\$100,000) nor less than three thousand dollars (\$3,000), or both;
- 2 (ii) A controlled substance classified in schedule III or IV, is guilty of a crime and upon 3 conviction may be imprisoned for not more than twenty (20) years, or fined not more than forty 4 thousand dollars (\$40,000), or both; provided, with respect to a controlled substance classified in 5 schedule III(d), upon conviction may be imprisoned for not more than five (5) years, or fined not
- (iii) A controlled substance classified in schedule V, is guilty of a crime and upon conviction may be imprisoned for not more than one year, or fined not more than ten thousand dollars (\$10,000), or both.
  - (b) (1) Except as authorized by this chapter, it is unlawful for any person to create, deliver, or possess with intent to deliver, a counterfeit substance.
    - (2) Any person who violates this subsection with respect to:

more than twenty thousand dollars (\$20,000), or both.

- (i) A counterfeit substance classified in schedule I or II, is guilty of a crime and upon conviction may be imprisoned for not more than thirty (30) years, or fined not more than one hundred thousand dollars (\$100,000), or both;
- (ii) A counterfeit substance classified in schedule III or IV, is guilty of a crime and upon conviction may be imprisoned for not more than twenty (20) years, or fined not more than forty thousand dollars (\$40,000), or both; provided, with respect to a controlled substance classified in schedule III(d), upon conviction may be imprisoned for not more than five (5) years, or fined not more than twenty thousand dollars (\$20,000) or both.
- (iii) A counterfeit substance classified in schedule V, is guilty of a crime and upon conviction may be imprisoned for not more than one year, or fined not more than ten thousand dollars (\$10,000), or both.
- (c) (1) It shall be unlawful for any person knowingly or intentionally to possess a controlled substance, unless the substance was obtained directly from or pursuant to a valid prescription or order of a practitioner while acting in the course of his or her professional practice, or except as otherwise authorized by this chapter.
- (2) Any person who violates this subsection with respect to:
- 29 (i) A controlled substance classified in schedules I, II and III, IV, and V, except the 30 substance classified as marijuana, is guilty of a crime and upon conviction may be imprisoned for 31 not more than three (3) years or fined not less than five hundred dollars (\$500) nor more than five thousand dollars (\$5,000), or both;
- 33 (ii) A More than one ounce (1 oz.) of a controlled substance classified in schedule I as
  34 marijuana is guilty of a misdemeanor and upon conviction may be imprisoned for not more than

one year or fined not less than two hundred dollars (\$200) nor more than five hundred dollars (\$500), or both.

(iii) Notwithstanding any public, special or general law to the contrary, the possession of one ounce (1 oz.) or less of marijuana by a person who is eighteen (18) years of age or older and who is not exempted from penalties pursuant to chapter 21-28.6-1 shall constitute a civil offense, rendering the offender liable to a civil penalty in the amount of one hundred fifty dollars (\$150) and forfeiture of the marijuana, but not to any other form of criminal or civil punishment or disqualification. Notwithstanding any public, special or general law to the contrary, this civil penalty of one hundred fifty dollars (\$150) and forfeiture of the marijuana shall apply if the offense is the first (1<sup>st</sup>) or second (2<sup>nd</sup>) offense issued to the offender within the previous eighteen (18) months.

(iv) Notwithstanding any public, special or general law to the contrary, possession of one ounce (1 oz.) or less of marijuana by a person who is under the age of eighteen (18) years and who is not exempted from penalties pursuant to chapter 21-28.6-1 shall constitute a civil offense, rendering the offender liable to a civil penalty in the amount of one hundred fifty dollars (\$150) and forfeiture of the marijuana; provided the minor offender completes an approved drug awareness program and community service as determined by the court or hearing board with jurisdiction. If the person under the age of eighteen (18) years fails to complete an approved drug awareness program and community service within one year of the offense, the penalty shall be a three hundred dollar (\$300) civil fine and forfeiture of the marijuana, except that if no drug awareness program or community service is available, the penalty shall be a fine of one hundred fifty dollars (\$150) and forfeiture of the marijuana. The parents or legal guardian of any offender under the age of eighteen (18) shall be notified of the offense and the availability of a drug awareness and community service program. The drug awareness program must be approved by the court or juvenile hearing board having jurisdiction over the offense, but shall, at a minimum, provide four (4) hours of instruction or group discussion, and ten (10) hours of community service. Notwithstanding any other public, special or general law to the contrary, this civil penalty shall apply if the offense is the first (1<sup>st</sup>) or second (2<sup>nd</sup>) offense issued to the offender within the previous eighteen (18) months.

(v) Notwithstanding any public, special, or general law to the contrary, a person not exempted from penalties pursuant to chapter 21-28.6 found in possession of one ounce (1 oz.) or less of marijuana is guilty of a misdemeanor and upon conviction may be imprisoned for not more than thirty (30) days or fined not less than two hundred dollars (\$200) nor more than five hundred dollars (\$500), or both, if that person has been previously cited for possession of less

1	than one ounce (1 oz.) of marijuana under subparagraphs 21-28-4.01(c)(2)(iii) or 21-28-
2	4.01(c)(2)(iv) two (2) times in the eighteen (18) months prior to the third (3 <sup>rd</sup> ) offense.
3	(vi) Any unpaid civil fine issued under subparagraphs 21-28-4.01(c)(2)(iii) or 21-28-
4	4.01(c)(2)(iv) shall double to three hundred dollars (\$300) if not paid within thirty (30) days of
5	the offense. The civil fine shall double again to six hundred dollars (\$600) if it has not been paid
6	within ninety (90) days.
7	(vii) No person may be arrested for a violation of subparagraphs 21-28-4.01(c)(2)(iii) or
8	21-28-4.01(c)(2)(iv) except as provided in this subparagraph. Any person in possession of an
9	identification card, license, or other form of identification issued by the state or any state, city or
10	town, or any college or university, who fails to produce the same upon request of a police officer
11	who informs the person that he or she has been found in possession of what appears to the officer
12	to be one ounce (1 oz.) or less of marijuana, or any person without any such forms of
13	identification that fails or refuses to truthfully provide his or her name, address, and date of birth
14	to a police officer who has informed such person that the officer intends to provide such
15	individual with a citation for possession of one ounce (1 oz.) or less of marijuana, may be
16	arrested.
17	(viii) No violation of subparagraphs 21-28-4.01(c)(2)(iii) or 21-28-4.01(c)(2)(iv) shall be
18	considered a violation of parole or probation.
19	(ix) Records of violations of subparagraphs 21-28-4.01(c)(2)(iii) or 21-28-4.01(c)(2)(iv)
20	shall be confidential and shall not be disclosed to anyone except for municipal or state law
21	enforcement for the sole purpose of determining if an individual has been previously cited for a
22	violation of subparagraphs 21-28-4.01(c)(2)(iii) or 21-28-4.01(c)(2)(iv) in the previous eighteen
23	(18) months, except that aggregate non-identifiable data, including the total number of citations
24	issued, the number of fines paid, and demographic information about individuals issued citations,
25	shall be released to the public at least once per year for the previous year and shall be available to
26	researchers upon request.
27	(x) Any records collected by any state agency or tribunal that include personally
28	identifiable information about violations of subparagraphs 21-28-4.01(c)(2)(iii) or 21-28-
29	4.01(c)(2)(iv) shall be destroyed eighteen (18) months after the issuance of said civil fine.
30	(3) The money associated with the civil fine issued under subparagraphs 21-28-
31	4.01(c)(2)(iii) or 21-28-4.01(c)(2)(iv) shall be payable to the Rhode Island traffic tribunal. Fifty
32	percent (50%) of all fines collected by the Rhode Island traffic tribunal from civil penalties issued
33	pursuant to subparagraphs 21-28-4.01(c)(2)(iii) or 21-28-4.01(c)(2)(iv) shall be expended on drug

(3)(4) Additionally every person convicted or who pleads nolo contendere under

(d) It shall be unlawful for any person to manufacture, distribute, or possess with inten-					
to manufacture or distribute, an imitation controlled substance. Any person who violates thi					
subsection is guilty of a crime, and upon conviction shall be subject to the same term of					
imprisonment and/or fine as provided by this chapter for the manufacture or distribution of the					
controlled substance which the particular imitation controlled substance forming the basis of the					
prosecution was designed to resemble and/or represented to be; but in no case shall the					
imprisonment be for more than five (5) years nor the fine for more than twenty thousand dollar					
(\$20,000).					
(e) It shall be unlawful for a practitioner to prescribe, order, distribute, supply, or sell as					
anabolic steroid or human growth hormone for: (1) enhancing performance in an exercise, sport					
or game, or (2) hormonal manipulation intended to increase muscle mass, strength, or weigh					
without a medical necessity. Any person who violates this subsection is guilty of a misdemeano					
and upon conviction may be imprisoned for not more than six (6) months or a fine of not more
