It is enacted by the General Assembly as follows:

| 1 | SECTION 1. Title 16 of the General Laws entitled "EDUCATION" is hereby amended |

| 3 | CHAPTER 22.1 |
| 4 | THE STATEWIDE VIRTUAL EDUCATION ACT |
| 5 | 16-22.1-1. Short title This chapter shall be known as and may be cited as "The Rhode |
| 6 | Island statewide virtual education act." |
| 7 | 16-22.1-2. Legislative findings The legislature hereby finds and declares the |
| 8 | following: |
| 9 | (1) A well-educated population benefits Rhode Island, supports its communities, |
| 10 | enhances the standard of living for all of its citizens, increases its capacity for success, and lays |
| 11 | the foundation for shared prosperity. |
| 12 | (2) Students in Rhode Island's public elementary, secondary, and postsecondary schools |
| 13 | and institutions should be able to take advantage of as many opportunities as possible to support |
| 14 | and extend their learning. Their learning opportunities should allow them to acquire the |
| 15 | knowledge and technology skills that will allow them to contribute to and participate in a digital |
| 16 | world. |
| 17 | (3) The number and type of virtual learning programs and courses have increased |
| 18 | considerably, and the prevalence of virtual learning continues to grow. Virtual learning utilizes |
| 19 | the power and scalability of technology to remove the constraints of traditional classroom |

| 2 | any place, and in ways that complement and extend traditional school settings. |

| 3 | (4) Public schools, school districts, and postsecondary institutions in Rhode Island should |
| 4 | have the freedom to work with teachers, families, and students to create customizable learning |
| 5 | opportunities that incorporate technology and reflect effective practices. |
| 6 | (5) The freedom that comes from technologically-supported opportunities to learn must |
| 7 | be accompanied by a clear responsibility to ensure that such opportunities are of high quality, |
| 8 | consistent with state standards for teaching and instruction, fulfill high school graduation |
| 9 | requirements, reflect the principles of equity and access, and include accountability provisions |
| 10 | that assure citizens that any investment of public tax dollars is well spent. |
| 11 | (6) Rhode Island is one of a few states that has not established the kind of statewide |
| 12 | policies on virtual education that will create the optimal conditions for effective learning and |
| 13 | instruction. |
| 14 | (7) The general assembly therefore finds that it is in the best interests of the people of the |
| 15 | state of Rhode Island to enact the Rhode Island statewide virtual education act to create |
| 16 | comprehensive regulations that will result in high quality, integrated virtual K-20 learning |
| 17 | experiences that will engage and challenge students through structured, sustained study. |
| 18 | <u>16-22.1-3. Purpose.</u> – The purpose of this chapter is to provide access to high quality, |
| 19 | rigorous, and relevant online learning opportunities for all of Rhode Island's public school |
| 20 | students and to ensure promulgation of virtual learning regulations supporting access to high |
| 21 | quality virtual instruction consistently throughout the state. |
| 22 | 16-22.1-4. Definitions. – When used in this chapter, the following terms shall have the |
| 23 | following meanings: |
| 24 | (1) "Board" means the Rhode Island board of regents for elementary and secondary |
| 25 | education. |
| 26 | (2) "Commissioner" means the Rhode Island commissioner for elementary and secondary |
| 27 | education. |
| 28 | (3) "Course" means a course of study consistent with subdivision 16-1-5(4) and that |
| 29 | meets the requirements of the basic education program. |
| 30 | (4) "School district" means local education agencies in Rhode Island operated by |
| 31 | municipalities and those entities established under sections 16-77.2-1, 16-77.3, and 16-77.4. |
| 32 | (5) "Teacher of record" means the teacher responsible for content instruction and |
| 33 | determining student grades. |
| 34 | (6) "Virtual course" means a course in which: |

| 7 | academic program; |
| 8 | (v) Extensive communication between a student and a teacher and among students is |

| 10 | (vi) A student is not necessarily required to be located on the physical premises of a |
| 11 | public school. |
| 12 | (7) "Virtual course provider" means: |
| 13 | (i) A public school district or school in Rhode Island that provides virtual courses to: |
| 14 | (A) Students enrolled in that district or school; or |
| 15 | (B) Students enrolled in another school district or school; |
| 16 | (ii) An accredited public or private institution of higher education in Rhode Island or |
| 17 | another state that provides virtual courses or programs to students attending public schools in |
| 18 | Rhode Island; |
| 19 | (iii) A not-for-profit or for-profit organization whose work includes offering virtual |
| 20 | courses or programs to students attending public schools in Rhode Island. |
| 21 | 16-22.1-5. Regulations for virtual learning. – With the direction and approval of the |
| 22 | board of regents for elementary and secondary education, the commissioner for elementary and |
| 23 | secondary education shall develop and promulgate regulations for Rhode Island school districts |
| 24 | and other educational organizations that are using or intend to use virtual courses and other online |
| 25 | learning opportunities with K-12 students and adult learners. The regulations shall include: |
| 26 | (1) Objective, standard criteria that ensures virtual courses and content for K-12 students |
| 27 | are aligned with state content standards, meet or exceed the requirements of the state's basic |
| 28 | education program, fulfill high school graduation requirements, and promote articulation with |
| 29 | public higher education institutions in the state; |
| 30 | (2) Objective, standard criteria for school districts to use to select quality providers of |
| 31 | virtual courses and online content, which may include local school districts, not-for-profit and |
| 32 | for-profit postsecondary institutions, and other organizations; |
| 33 | (3) Objective, standard criteria that ensures teachers of virtual courses and other online |
| 34 | learning activities are appropriately trained and qualified and meet certification requirements set |

| 11 | student progress and performance using grade-appropriate and content-appropriate assessments; |
| 12 | (8) Objective, standard criteria that ensures that RIDE participates in statewide efforts to |
| 13 | support virtual learning education with a focus on student access to quality online learning |
| 14 | opportunities and ensuring efficiencies gained by coordinating resources; |
| 15 | (9) Any other requirements or limitations for virtual courses in Rhode Island. |
| 16 | 16-22.1-6. Oversight, quality assurance, reporting, and evaluation of virtual courses. |
| 17 | <u>- (a) The commissioner shall utilize existing evaluation processes and protocols established</u> |
| 18 | through regulations adopted by the board of regents to ensure student access to quality and |
| 19 | effective online content and instruction. |
| 20 | (b) Quality assurance reporting shall occur through the existing comprehensive data |
| 21 | collection, analysis and accountability procedures at both the local and state level. |
| 22 | (c) The commissioner shall prepare a report each fiscal year that documents the |
| 23 | conditions under which virtual education supports student learning in Rhode Island. The report |
| 24 | shall include: |
| 25 | (1) Virtual course participation rates, with participation information disaggregated for |
| 26 | core content areas; |
| 27 | (2) Expenditures related to virtual education, in aggregate and by district; |
| 28 | (3) The results of student assessments for students participating in virtual education in |
| 29 | core content areas, disaggregated from overall district data; and |
| 30 | (4) Any other information the commissioner deems relevant. |
| 31 | (d) The commissioner's report shall be delivered to the speaker of the house of |
| 32 | representatives and to the president of the senate by January 31 of each year, and the information |
| 33 | posted for public inspection on the Rhode Island department of education's website. |
| 34 | 16-22.1-7. Cooperation with public institutions of higher education. – In partnership |

- 1 with the commissioner of higher education, the commissioner of elementary and secondary
- 2 education shall promote access to high quality virtual courses for all public elementary,
- 3 secondary, and postsecondary students.
- 4 SECTION 2. This act shall take effect upon passage.
