AUTHORIZING THE TOWN OF NORTH PROVIDENCE TO REDISTRIBUTE THE TOWN
COUNCIL AND SCHOOL COMMITTEE DISTRICTS

It is enacted by the General Assembly as follows:

1 SECTION 1. The town of North Providence is hereby authorized to redistrict its town
2 council and school committee districts as follows:

3 Town council and school committee district one:

4 District 1 of the town of North Providence shall consist of all that part of the town
5 bounded by a line beginning at the intersection of the North Providence-Lincoln boundary line
6 and Douglas Avenue; thence southerly on Douglas Avenue to Mineral Spring Avenue; thence
7 westerly on Mineral Spring Avenue to Fruit Hill Avenue; thence southwesterly on Fruit Hill
8 Avenue to Smith Street; thence westerly on Smith Street to Allen Avenue; thence southwesterly
9 on Allen Avenue to Woonasquatucket Avenue; thence northerly on Woonasquatucket Avenue to
10 Smith Street; thence westerly on Smith Street to the Johnston-North Providence boundary line;
11 thence northerly on the Johnston-North Providence boundary line to the Smithfield-North
12 Providence boundary line; thence easterly on the Smithfield-North Providence boundary line to
13 the Lincoln-North Providence boundary line; thence easterly on the Lincoln-North Providence
14 boundary line to the point of origin.

15 Town council and school committee district two:

16 District 2 of the town of North Providence shall consist of all that part of the town
17 bounded by a line beginning at the intersection of the North Providence-Lincoln boundary line
18 and Douglas Avenue; thence southerly on Douglas Avenue to Mineral Spring Avenue; thence

1 easterly on Mineral Spring Avenue to the West River; thence southerly on the West River to
2 Alexander Street; thence easterly on Alexander Street to Lexington Avenue; thence southerly on
3 Lexington Avenue to Goldsmith Street; thence westerly on Goldsmith Street to Douglas Avenue;
4 thence southerly on Douglas Avenue to the North Providence-Providence boundary line; thence
5 easterly on the North Providence-Providence boundary line to the Pawtucket-North Providence
6 boundary line; thence northerly on the Pawtucket-North Providence boundary line to the Lincoln-
7 North Providence boundary line; thence westerly on the Lincoln-North Providence boundary line
8 to the point of origin.

9 Town council and school committee district three:

10 District 3 of the town of North Providence shall consist of all that part of the town
11 bounded by a line beginning at the intersection of the North Providence-Providence boundary line
12 and Douglas Avenue; thence northwesterly on Douglas Avenue to Goldsmith Street; thence
13 easterly on Goldsmith Street to Lexington Avenue; thence northerly on Lexington Avenue to
14 Alexander Street; thence westerly on Alexander Street to the West River; thence northerly on the
15 West River to Mineral Spring Avenue; thence westerly on Mineral Spring Avenue to Fruit Hill
16 Avenue; thence southwesterly on Fruit Hill Avenue to Smith Street; thence westerly on Smith
17 Street to Allen Avenue; thence southwesterly on Allen Avenue to Woonasquatucket Avenue;
18 thence northerly on Woonasquatucket Avenue to Smith Street; thence westerly on Smith Street to
19 the Johnston-North Providence boundary line; thence southerly on the Johnston-North Providence
20 boundary line to the North Providence-Providence boundary line; thence northeasterly on the
21 North Providence-Providence boundary line to the point of origin.

22 SECTION 2. This act shall take effect upon passage.
