1 WHEREAS, Child abuse and neglect are community-wide conditions and problems, and 2 finding solutions depends on the involvement of people in the community; and 3 WHEREAS, Approximately three million children are reported abused and neglected in 4 this country each year, with nearly three thousand of these children residing in Rhode Island; and WHEREAS, The effects of child abuse and neglect are felt by whole communities and 5 6 need to be addressed by the entire community; and 7 WHEREAS, Prevent Child Abuse Rhode Island, the Rhode Island Family and Children's 8 Trust Fund at the Department of Children, Youth, and Families, and the Family Care Community 9 Partnerships are sponsoring several events throughout April to heighten public awareness of 10 abuse and neglect in communities around the state. These events will provide information and 11 material that support families to prevent child maltreatment and celebrate people who work with 12 and support children and families; and 13 WHEREAS, A statewide "Pinwheels for Prevention" campaign has been launched 14 through the media, public schools, libraries, social services, and businesses during the month of 15 April to celebrate and bring awareness of the great potential of all children in Rhode Island and 16 the need to strengthen all families with support and nurturing; and 17 WHEREAS, The "Pinwheels for Prevention" campaign includes the planting of 18 "Pinwheel Gardens" statewide celebrating community partnerships for strengthening the family

1	WHEREAS, Effective child abuse prevention programs succeed because of partnerships
2	created among social service agencies, schools, religious and civic organizations, law
3	enforcement agencies, and the business community; and
4	WHEREAS, All citizens should become more aware of the negative effects of child
5	abuse and the benefits of its prevention within the community, and become involved in
6	supporting parents to raise their children in a safe, nurturing environment; now, therefore be it
7	RESOLVED, That this House of Representatives of the State of Rhode Island and
8	Providence Plantations does hereby proclaim April, 2013, as "Child Abuse and Neglect
9	Prevention Month" in the state of Rhode Island and calls upon all citizens, community agencies,
10	religious organizations, medical facilities, and businesses to increase their participation in our
11	efforts to prevent child abuse, thereby strengthening the communities in which we live; and be it
