RELATING TO EDUCATION -- SCHOOL COMMITTEES AND SUPERINTENDENTS

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 16-2-2 of the General Laws in Chapter 16-2 entitled "School
2 Committees and Superintendents" is hereby amended to read as follows:

3 **16-2-2. City and town schools required -- School year -- Location -- Kindergartens. -**

4 : (a)(1) Except as specifically provided in this section, every city or town shall establish and
5 maintain for at least one hundred eighty (180) days annually or the equivalent thereof, exclusive
6 of holidays a sufficient number of schools in convenient places under the control and
7 management of the school committee and under the supervision of the board of regents for
8 elementary and secondary education. In lieu of convenient location the school committee may
9 provide transportation for pupils to and from school in accordance with the provisions of chapter
10 21 of this title. Provided, that a school district may establish a school year which is the equivalent
11 of one hundred eighty (180) days through the use of longer school days in terms of hours, and
12 which may total less than one hundred eighty (180) separate days, so long as through the use of
13 the longer school day, the school district annually provides a minimum of one thousand eighty
14 (1080) school hours in a single school year. This figure is based on a minimum of six (6) hours
15 per school day. For purposes of clarification, the intent herein is to permit school districts to
16 amend their school year to provide for longer school days while reducing the actual number of
17 days in which the school facilities must be fully staffed and maintained, but to insure that in doing
18 so, school districts shall still provide the minimum amount of instruction time contemplated by
19 this section. Nothing herein shall be deemed to limit a school district from exceeding the

1 minimum amounts of days and hours set forth herein.
2 (2) School districts intending to make use of the option provided herein to lengthen
3 school days and shorten the school year shall submit a detailed school day plan and a proposed
4 school calendar to the commissioner of elementary and secondary education for approval. The
5 commissioner shall review the submitted school day plan and the submitted calendar to determine
6 whether the plan and calendar are academically sound and fiscally efficient. The commissioner
7 may grant or deny approval of the plan and/or the calendar.

8 (b) School facilities shall include a sufficient number of kindergartens.

9 SECTION 2. This act shall take effect upon passage.

EXPLANATION
BY THE LEGISLATIVE COUNCIL
OF

RELATING TO EDUCATION -- SCHOOL COMMITTEES AND SUPERINTENDENTS

1 This act would allow school districts to use longer school days to educate students during
2 the school year, and to do so in less than one hundred eighty (180) days, so long as the total
3 amount of school hours provided at a minimum was one thousand eighty (1,080) school hours per
4 school year.

5 The act would also require school districts intending to make use of this option to provide
6 a detailed school day plan and a proposed school calendar to the commissioner of elementary and
7 secondary education for approval.

8 This act would take effect upon passage.
