It is enacted by the General Assembly as follows:

1	SECTION 1. Title 23 of the General Laws entitled "HEALTH AND SAFETY" is hereby
2	amended by adding thereto the following chapter:
3	CHAPTER 89
4	THE RHODE ISLAND PALLIATIVE CARE AND QUALITY OF LIFE ACT
5	23-89-1. Establishment of advisory council - Purposes (a) There is hereby
6	authorized, created and established a nine (9) member advisory council to be known as "The
7	Rhode Island Palliative Care and Quality of Life Interdisciplinary Advisory Council" within the
8	department of health with the powers and duties set forth in this chapter.
9	(b) The director of the department of health shall appoint nine (9) members to the council
10	who shall have expertise in various aspects of palliative care including, but not limited to,
11	medical, nursing, social work, pharmacy and spiritual; and patient and family caregivers.
12	Membership shall specifically include experience in palliative care in a variety of inpatient,
13	outpatient and community settings such as acute care, long-term care and hospice and with a
14	variety of populations including pediatric, youth and adult care. One (1) council member shall be
15	a designee of the Rhode Island American Cancer Society and two (2) member's shall be a chief
16	executive of a licensed homecare agency or their designee. At least two (2) council members shall
17	be board-certified hospice and palliative medicine physicians and/or nurses. Members shall serve
18	for a term of three (3) years. Members shall receive no compensation for their services.

- 1 (c) The Rhode Island palliative care and quality of life interdisciplinary advisory council
- 2 shall consult with and advise the department of health on matters related to the establishment,
- 3 maintenance, operation, and outcomes evaluation of palliative care initiatives in the state.
- 4 23-89-2. Establishment of palliative care consumer and professional information 5 and education program. -- (a) There is hereby created and established a statewide "Palliative Care Consumer and Professional Information and Education Program" within the department of 6 7 health. 8 (b) The purpose of the palliative care consumer and professional information and 9 education program shall be to maximize the effectiveness of palliative care initiatives in the state 10 by ensuring that comprehensive and accurate information and education about palliative care is 11 available to the public, healthcare providers, and healthcare facilities. 12 (c) The department of health shall publish on its website information and resources, 13 including links to external resources, about palliative care delivery for the public, healthcare 14 providers, and healthcare facilities. This shall include, but not limited to, continuing educational 15 opportunities for healthcare providers; information about palliative care delivery in the home, 16 primary, secondary, and tertiary environments; best practices for palliative care delivery; and 17 consumer educational materials and referral information for palliative care, including hospice. 18 (d) The department of health may develop and implement any other initiatives regarding 19 palliative care services and education that the director determines would further the purposes of 20 this subsection. 21 (e) The department shall consult with the palliative care and quality of life 22 interdisciplinary advisory council in implementing this section. 23 23-89-3. Access to palliative care. -- (a) As used in this section, the following terms 24 shall have the following meanings: 25 (1) "Appropriate" means consistent with applicable legal, health and professional 26 standards, the patient's clinical and other circumstances, and the patient's reasonably known 27 wishes and beliefs. 28 (2) "Medical care" means services provided, requested, or supervised by a physician or 29 advanced practice nurse. 30 (3) "Palliative care" means patient and family centered medical care that optimizes 31 quality of life by anticipating, preventing, and treating suffering caused by serious illness. 32 Palliative care throughout the continuum of illness involves addressing physical, emotional,
- 33 social, and spiritual needs and facilitating patient autonomy, access to information, and choice.
- 34 Palliative care includes, but is not limited to, discussions of the patient's goals for treatment;

- 1 discussion of treatment options appropriate to the patient, including, where appropriate, hospice
- 2 care; and comprehensive pain and symptom management.
- 3 (4) "Serious illness" means any medical illness or physical injury or condition that
- 4 substantially impacts quality of life for more than a short period of time. Serious illness includes,
- 5 but is not limited to, cancer; heart, renal or liver failure; lung disease; and Alzheimer's disease
- 6 <u>and related dementias.</u>
 - (b) On or before January 1, 2015, all healthcare organizations which required a license to
- 8 <u>operate shall:</u>

- 9 (1) Consult with the organization's physicians to educate them on how to provide
- 10 information about appropriate palliative care services for those patients or residents with serious
- 11 <u>illnesses, who, in their professional medical opinion, would benefit from them.</u>
- 12 (c) The department shall carry out this section with the consultation of the palliative care
- 13 and quality of life interdisciplinary advisory council.
- 14 (d) In carrying out this section, the department shall take into account factors that may
- 15 impact the development of such a system and its ability to facilitate access to palliative care,
- 16 including the size of the healthcare organization; access and proximity to palliative care services,
- 17 including the availability of hospice and palliative care board-certified practitioners and related
- 18 workforce staff; and geographic factors.
- 19 SECTION 2. This act shall take effect upon passage.

EXPLANATION

BY THE LEGISLATIVE COUNCIL

OF

RELATING TO STATE AFFAIRS AND GOVERNMENT - PALLIATIVE CARE AND QUALITY OF LIFE - SERVICES AND EDUCATION
