It is enacted by the General Assembly as follows:

1 SECTION 1. Title 5 of the General Laws entitled "BUSINESSES AND PROFESSIONS" 2 is hereby amended by adding thereto the following chapter: 3 **CHAPTER 87** 4 SERVICE MEMBER LICENSURE 5 5-87-1. Service member licensure. -- (a) The director and each member of the examining and licensing boards shall, upon presentation of satisfactory evidence by an applicant 6 7 for certification or licensure, accept education, training, or service completed by an individual as a member of the Armed Forces or Reserves of the United States, the National Guard of any state, 8 9 the Military Reserves of any state, or the Naval Militia of any state toward the qualifications to 10 receive the license or certification. The director and each appropriate examining and licensing 11 board shall promulgate rules to implement this section. 12 (b) Each business/profession related board shall establish a procedure to expedite the 13 issuance of a license, certification or permit to perform professional services regulated by each 14 such board to a person who is certified or licensed in another state to perform professional services in a state other than Rhode Island. The procedure shall include: 15 (1) Issuing the person a license, certificate or permit, if, in the opinion of the board, the 16 17 requirements for certification or licensure of such other state are substantially equivalent to that 18 required in this state; or

(2) Developing a method to authorize the person to perform professional services

5	SECTION 2. Title 23 of the General Laws entitled "HEALTH AND SAFETY" is hereby
6	amended by adding thereto the following chapter:
7	CHAPTER 91
8	SERVICE MEMBER LICENSURE
9	23-91-1. Service member licensure (a) The director and each member of the
10	examining and licensing boards shall, upon presentation of satisfactory evidence by an applicant
11	for certification or licensure, accept education, training, or service completed by an individual as
12	a member of the Armed Forces or Reserves of the United States, the National Guard of any state
13	the Military Reserves of any state, or the Naval Militia of any state toward the qualifications to
14	receive the license or certification. The director and each appropriate examining and licensing
15	board shall promulgate rules to implement this section.
16	(b) Notwithstanding any other law to the contrary, each health related board shall

33	5-88-1. Military spouse licensure (a) Notwithstanding any other law to the contrary
34	each business/profession related board shall establish a procedure to expedite the issuance of a

1	license, certification or permit to perform professional services regulated by each such board to a
2	person:
3	(1) Who is certified or licensed in another state to perform professional services in a state
4	other than Rhode Island;
5	(2) Whose spouse is a member of the armed forces of the United States;
6	(3) Whose spouse is the subject of a military transfer to Rhode Island; and
7	(4) Who left employment to accompany the person's spouse to Rhode Island.
8	(b) The procedure shall include:
9	(1) Issuing the person a license, certificate or permit, if, in the opinion of the board, the
10	requirements for certification or licensure of such other state are substantially equivalent to that
11	required in this state; or
12	(2) Developing a method to authorize the person to perform professional services
13	regulated by the board in this state by issuing the person a temporary permit for a limited period
14	of time to allow the person to perform professional services while completing any specific
15	requirements that may be required in this state that were not required in the state in which the
16	person was licensed or certified.
17	SECTION 4. Title 23 of the General Laws entitled "HEALTH AND SAFETY" is hereby
18	amended by adding thereto the following chapter:
19	CHAPTER 92
20	MILITARY SPOUSE LICENSURE
21	23-92-1. Military spouse licensure (a) Each health related board shall establish a
22	procedure to expedite the issuance of a license, certification or permit to perform professional
23	services regulated by each such board to a person:
24	(1) Who is certified or licensed in another state to perform professional services in a state
25	other than Rhode Island;
26	(2) Whose spouse is a member of the armed forces of the United States;
27	(3) Whose spouse is the subject of a military transfer to Rhode Island; and
28	(4) Who left employment to accompany the person's spouse to Rhode Island.
29	(b) The procedure shall include:
30	(1) Issuing the person a license, certificate or permit, if, in the opinion of the board, the
31	requirements for certification or licensure of such other state are substantially equivalent to that
32	required in this state; or
33	(2) Developing a method to authorize the person to perform professional services
34	regulated by the board in this state by issuing the person a temporary permit for a limited period

- 1 of time to allow the person to perform professional services while completing any specific
- 2 requirements that may be required in this state that were not required in the state in which the
- 3 person was licensed or certified.
- 4 SECTION 5. This act shall take effect upon passage.
