It is enacted by the General Assembly as follows:

1	SECTION 1. Title 45 of the General Laws entitled "TOWNS AND CITIES" is hereby
2	amended by adding thereto the following chapter:
3	CHAPTER 24.6
4	RHODE ISLAND COMMUNITY PRESERVATION ACT
5	45-24.6-1. Short title This chapter shall be known and may be cited as the "Rhode
6	Island Community Preservation Act."
7	45-24.6-2. Findings and purposes. – The general assembly finds and declares that:
8	(1) Capital investments in our communities are essential to protecting their character,
9	environment, heritage, affordability, quality of life, and economic vitality;
10	(2) Cities and towns need capital funding to protect special open spaces, working farms,
11	natural areas, and historic landmarks, as well as, to create parks, outdoor recreation facilities and
12	housing that support all residents' health and wellbeing; and
13	(3) Cities and towns need a reliable "pay as you go" source of funding for these capital
14	investments to reduce dependence on bond funding.
15	Therefore, the general assembly is providing cities and towns with the authority to
16	propose, for consideration and decision by their voters, a reliable source of capital funding for
17	investing in their community. The general assembly is also creating a dedicated state funding
18	source to provide matching funds for communities that choose to adopt the community

2	45-24.6-3. Definitions. – As used in this chapter, the following words shall, unless the
3	context clearly indicates a different meaning, have the following meanings:
4	(1) "Acquire" means obtain by gift, purchase, devise, grant, rental, rental purchase, lease
5	or otherwise.
6	(2) "Capital improvement" means reconstruction or alteration of real property that: (i)
7	Materially adds to the value of the real property, or appreciably prolongs the useful life of the real
8	property; (ii) Becomes part of the real property or is permanently affixed to the real property so
9	that removal would cause material damage to the property or article itself; and (iii) Is intended to
10	become a permanent installation or is intended to remain there for an indefinite period of time.
11	(3) "Community housing" means low or moderate income housing for individuals and
12	families, including low or moderate income senior housing.
13	(4) "Community preservation" means the acquisition, creation and preservation of open
14	space, the acquisition, creation and preservation of historic resources and the creation and
15	preservation of community housing.
16	(5) "Community preservation committee" means the committee established by the city or
17	town council of a city or town to make recommendations for community preservation, as
18	provided in section 45-24.6-6.
19	(6) "Community preservation fund" means the municipal fund established under section
20	<u>45-24.6-8.</u>
21	(7) "CP" means community preservation.
22	(8) "Historic resources" means any real property, structure, natural object, place,
23	landmark, landscape, archaeological site or configuration or any portion or group of the preceding
24	which has been listed on the federal or state register of historic places or that is considered by the
25	Rhode Island historical preservation and heritage commission to meet the eligibility criteria for
26	listing on the state register of historic places pursuant to section 42-45-5 or is located in a historic
27	district established by a municipality in accordance with chapter 45-24.1, "Historic Area Zoning."
28	(9) "Maintenance" means incidental repairs which neither materially add to the value of
29	the property or appreciably prolong the property's life, but keep the property in a condition of
30	fitness, efficiency or readiness.
31	(10) "Low or moderate income housing" means any housing, whether built or operated
32	by any public agency or any nonprofit organization, or by any limited equity housing cooperative
33	or any private developer, that is subsidized by a federal, state, or municipal government subsidy
34	under any program to assist the construction or rehabilitation of housing affordable to low or

1	moderate income households, as defined in the applicable federal or state statute, or local
2	ordinance and that will remain affordable through a land lease and/or deed restriction for ninety-
3	nine (99) years or such other period that is either agreed to by the applicant and town or
4	prescribed by the federal, state, or municipal government subsidy program but that is not less than
5	thirty (30) years from initial occupancy.
6	(11) "Open space" means, but is not limited to, land to protect existing and future well
7	fields, aquifers and recharge areas, watershed land, agricultural land, grasslands, fields, forest
8	land, fresh and salt water marshes and other wetlands, ocean, river, stream, lake and pond
9	frontage, beaches, dunes and other coastal lands, lands to protect scenic vistas, land for wildlife or
10	nature preserve, and land for recreational use.
11	(12) "Preservation" means protection of personal or real property from injury, harm, or
12	destruction.
13	(13) "Real property" means land, buildings, appurtenant structures and fixtures attached
14	to buildings or land, including, where applicable, real property interests.
15	(14) "Real property interest" means a present or future legal or equitable interest in or to
16	real property, including easements and restrictions, and any beneficial interest therein, including
17	the interest of a beneficiary in a trust which holds a legal or equitable interest in real property, but
18	shall not include an interest which is limited to the following: an estate at will or at sufferance and
19	any estate for years having a term of less than thirty (30) years; the reversionary right, condition
20	or right of entry for condition broken; the interest of a mortgagee or other secured party in a
21	mortgage or security agreement.
22	(15) "Recreational use" means active or passive recreational use including, but not
23	limited to, the use of land for community gardens, trails, and noncommercial youth and adult
24	sports, and the use of land as a park, playground or athletic field. "Recreational use" shall not
25	include horse or dog racing or the use of land for a stadium, gymnasium or similar structure.
26	(16) "Rehabilitation" means capital improvements, or the making of extraordinary
27	repairs to historic resources, open spaces, lands for recreational use and community housing for
28	the purpose of making such historic resources, open spaces, lands for recreational use and
29	community housing functional for their intended uses, including, but not limited to,
30	improvements to comply with the Americans with disabilities act and other federal, state or local
31	building or access codes; provided, that with respect to historic resources, "rehabilitation" shall
32	comply with the standards for rehabilitation stated in the United States secretary of the interior's
33	standards for the treatment of historic properties codified in 36 C.F.R. part 68; and provided
34	further that with respect to land for recreational use "rehabilitation" shall include the

1	replacement of playground equipment and other capital improvements to the land or the facilities
2	thereon which make the land or the related facilities more functional for the intended recreational
3	use.
4	(17) "Support of community housing" means, but is not limited to, programs that provide
5	grants, loans, rental assistance, security deposits, interest-rate write downs or other forms of
6	assistance directly to individuals and families who are eligible for community housing, or to an
7	entity that owns, operates or manages such housing, for the purpose of making housing
8	affordable.
9	45-24.6-4. Voter approval required. – (a) Any ordinance providing for the
10	implementation of sections 45-24.6-4 through 45-24.6-8, which has been duly adopted by a city
11	or town, shall only be effective upon its approval by the voters of the city or town through a ballot
12	question as set forth in this section.
13	(b) The city or town council may vote to accept sections 45-24.6-4 through 45-24.6-8,
14	inclusive, by approving a surcharge on real property of not more than three percent (3%) of the
15	real estate tax levy against real property, as determined annually by the assessor. The amount of
16	the surcharge shall not be included in a calculation of total maximum levy for purposes of section
17	<u>44-5-2.</u>
18	(c) All exemptions and abatements of real property authorized by chapter 44-3 ("Property
19	Subject to Taxation"), section 44-3-3, or any other law for which a taxpayer qualifies as eligible
20	shall not be affected by this section. A taxpayer receiving an exemption of real property
21	authorized by chapter 44-3, section 44-3-3, or any other law shall be exempt from any surcharge
22	on real property established under this section. The surcharge to be paid by a taxpayer receiving
23	an abatement of real property authorized by chapter 44-3, section 44-3-3, or any other law shall
24	be reduced in proportion to the amount of such abatement.
25	(d) Any amount of the surcharge not paid by the due date shall bear interest at the rate per
26	annum provided in section 44-5-9.
27	(e) The city or town council may also vote to accept one or more of the following
28	exemptions:
29	(1) For property owned and occupied as a domicile by a person who would qualify for
30	low or moderate income housing in the city or town;
31	(2) For commercial and industrial properties in cities or towns with classified tax rates; or
32	(3) For one hundred thousand dollars (\$100,000) of the value of each taxable parcel of
33	residential real property; or
34	(4) For one hundred thousand dollars (\$100,000) of the value of each taxable parcel of

1	commercial property and industrial property.
2	(f) Upon approval by the city or town council, the actions of the body shall be submitted
3	for acceptance to the voters of a city or town at the next regular or special municipal or state
4	election. The city or town clerk or the secretary of state shall place the proposition on the ballot
5	in the form of the following question:
6	"Shall this (city or town) accept sections 45-24.6-4 through 45-24.6-8, inclusive of
7	chapter 45 of the general laws, as approved by its city or town council, a summary of which
8	appears below?"
9	(Set forth here a fair, concise summary and purpose of the law to be acted upon, as
10	determined by the city or town solicitor, including in said summary the percentage of the
11	surcharge to be imposed.)
12	If a majority of the voters voting on said question vote in the affirmative, then its
13	provisions shall take effect in the city or town, but not otherwise.
14	45-24.6-5. Imposition of surcharge. – (a) Upon acceptance of sections 45-24.6-4
15	through 45-24.6-8, inclusive, and upon the assessor's warrant to the tax collector, the accepted
16	surcharge shall be imposed.
17	(b) After receipt of the warrant, the tax collector shall collect the surcharge in the amount
18	and according to the computation specified in the warrant and shall pay the amounts so collected,
19	quarterly, according to the schedule for collection of property taxes for the tax on real property, to
20	the city's or town's treasurer. The tax collector shall cause appropriate books and accounts to be
21	kept with respect to such surcharge, which shall be subject to public examination upon reasonable
22	request from time to time.
23	(c) The remedies provided by section 44-7 for the collection of taxes upon real estate
24	shall apply to the surcharge on real property pursuant to this section.
25	45-24.6-6. Community preservation committee. – (a) A city or town that accepts
26	sections 45-24.6-4 through 45-24.6-8, inclusive, shall establish by ordinance a community
27	preservation committee. The committee shall consist of not less than five (5) nor more than nine
28	(9) members. The ordinance shall determine the composition of the committee, the length of its
29	term and the method of selecting its members, whether by election or appointment or by a
30	combination thereof. The committee shall include, but not be limited to: one member of the
31	planning board established under section 45-22-1 as designated by the board; one member of the
32	municipal land trust or non-profit land trust established per paragraph 42-17.1-2(28)(ii)
33	designated by the land trust; if no land trust exists, one member of the conservation commission
34	established pursuant to chapter 45-35 ("Conservation Commissions") as designated by the

commission; one member representing historical preservation interests; one member representing park and outdoor recreation interests and one member representing affordable housing interests, or persons, as determined by the ordinance or bylaw, acting in the capacity of or performing like duties of the commissions, board, or authority if they have not been established in the city or town. If there are no persons acting in the capacity of or performing like duties of any such commission, board, or authority, the ordinance or bylaw shall outline an appointment process that assures that membership of the community preservation committee shall include individuals appointed with knowledge and interest in each subject matter: land conservation, parks, historic preservation, and community preservation committee shall study the needs, possibilities, and

(b)(1) The community preservation committee shall study the needs, possibilities, and resources of the city or town regarding community preservation, including the consideration of regional projects for community preservation. The committee shall consult with existing municipal boards, including the conservation commission, the historical commission, the planning board, the board of park commissioners, and the housing authority, or persons acting in those capacities or performing like duties, in conducting such studies. As part of its study, the committee shall hold one or more public informational hearings on the needs, possibilities, and resources of the city or town regarding community preservation possibilities and resources, notice of which shall be posted publicly and published for each of two (2) weeks preceding a hearing in a newspaper of general circulation in the city or town.

(2) The community preservation committee shall make recommendations to the city or town council for the acquisition, creation, and preservation of open space; for the acquisition, preservation, rehabilitation, and restoration of historic resources; for the acquisition, creation, preservation, rehabilitation, and restoration of land for recreational use; for the acquisition, creation, preservation, and support of community housing; and for rehabilitation or restoration of open space and community housing that is acquired or created as provided in this section; provided, however, that funds expended pursuant to this section shall not be used for maintenance. With respect to community housing, the community preservation committee shall recommend, wherever possible, the reuse of existing buildings or construction of new buildings on previously developed sites. With respect to recreational use, the acquisition of artificial turf for athletic fields shall be prohibited.

(3) The community preservation committee may include in its recommendation to the city or town council a recommendation to set aside for later spending funds for specific purposes that are consistent with community preservation but for which sufficient revenues are not then available in the community preservation fund to accomplish that specific purpose.

1	(c) The community preservation committee shall not meet or conduct business without
2	the presence of a quorum. A majority of the members of the community preservation committee
3	shall constitute a quorum. The community preservation committee shall approve its actions by
4	majority vote. Recommendations to the city or town council shall include their anticipated costs.
5	(d) After receiving recommendations from the community preservation committee, the
6	city or town council shall take such action and approve such appropriations from the community
7	preservation fund as set forth in section 45-24.6-8 and such additional non-community
8	preservation fund appropriations as it deems appropriate to carry out the recommendations of the
9	community preservation committee.
10	(f) No real property, or interest therein, shall be acquired by any city or town for a price
11	exceeding the value of the property as determined by such city or town through procedures
12	customarily accepted by the appraising profession as valid.
13	A city or town may appropriate money in any year from the community preservation fund
14	to an affordable housing trust fund.
15	45-24.6-7. Minimum spending requirements for community preservation fund. – (a)
16	In each fiscal year and upon the recommendation of the community preservation committee, the
17	city or town council shall spend, or set aside for later spending, not less than ten percent (10%) of
18	the annual revenues in the community preservation fund for open space, not less than ten percent
19	(10%) of the annual revenues for historic resources, and not less than ten percent (10%) of the
20	annual revenues for community housing. In each fiscal year, the city or town council shall make
21	appropriations from the community preservation fund as it deems necessary for the administrative
22	and operating expenses of the community preservation committee and such appropriations shall
23	not exceed five percent (5%) of the annual revenues in the community preservation fund.
24	(b) Funds that are set aside shall be held in the community preservation fund and spent in
25	that year or later years; provided, however, that funds set aside for a specific purpose shall be
26	spent only for the specific purpose. Any funds set aside may be expended in any city or town.
27	The community preservation funds shall not replace existing operating funds, only augment them.
28	45-24.6-8. Establishment of community preservation fund. – A city or town that
29	accepts sections 45-24.6-4 through 45-24.6-8, inclusive, shall establish a separate account to be
30	known as the community preservation fund of which the municipal treasurer shall be the
31	custodian. The authority to approve expenditures from the fund shall be limited to the city or
32	town council upon recommendation from the community preservation committee, and the
33	municipal treasurer shall pay such expenses.
34	The following monies shall be deposited in the fund: (1) All funds collected from the real

1	property surcharge or bond proceeds in anticipation of revenue pursuant to sections 45-24.6-5 and
2	45-24.6-9; (2) All funds received from the state or any other source for such purposes; and (3)
3	Proceeds from the disposal of real property acquired with funds from the community preservation
4	fund. The treasurer may deposit or invest the proceeds of the fund in a savings bank incorporated
5	under the laws of the state, banking companies incorporated under the laws of the state which are
6	members of the federal deposit insurance corporation, or national banks, or savings and loan
7	associations doing business in the state, and any income therefrom shall be credited to the fund.
8	The expenditure of revenues from the fund shall be limited to implementing the recommendations
9	of the community preservation committee and providing administrative and operating expenses to
10	the committee.
11	45-24.6-9. Authority to issue bonds. – A city or town that accepts sections 45-24.6-4
12	through 45-24.6-8, inclusive, may issue, from time to time, general obligation bonds or notes in
13	anticipation of revenues to be raised pursuant to section 45-24.6-4, the proceeds of which shall be
14	deposited in the community preservation fund. Bonds or notes so issued may be at such rates of
15	interest as shall be necessary and shall be repaid as soon after such revenues are collected as is
16	expedient. Cities or towns that choose to issue bonds pursuant to this section shall make every
17	effort to limit the administrative costs of issuing such bonds by cooperating among each other
18	using methods including, but not limited to, common issuance of bonds or common retention of
19	bond counsel.
20	<u>45-24.6-10. Permanent conservation or preservation restrictions. – (a) A real property</u>
21	interest that is acquired with monies from the community preservation fund shall be bound by a
22	permanent conservation or preservation restriction pursuant to the provisions of chapter 34-39
23	("Conservation and Preservation Restrictions on Real Property"), recorded as a separate
24	instrument and limiting the use of the interest to the purpose for which it was acquired. The
25	permanent restriction shall run with the land and shall be enforceable by the city or town or the
26	state. The permanent restriction may also run to the benefit of a nonprofit organization,
27	charitable corporation or foundation selected by the city or town with the right to enforce the
28	restriction. The city or town council may appropriate monies from the community preservation
29	fund to pay a nonprofit organization created pursuant to paragraph 42-17.1-2(28)(ii) to hold,
30	monitor, and enforce the deed restriction on said property.
31	(b) Real property interests acquired under this section shall be owned and managed by the
32	city or town, but the city or town council may delegate management of such property to a land
33	trust, conservation commission, historical commission, park commission, or housing authority as
34	appropriate for the property interests acquired, or, in the case of interests to acquire sites for

1	future wellhead development for drinking water, a water board, a water supply district, or a fire
2	district. The city or town council may also delegate management of such property to a nonprofit
3	organization created under paragraph 42-17.1-2(28)(ii).
4	45-24.6-11. Accounting to be kept. – The community preservation committee shall keep
5	a full and accurate account of all of its actions, including its recommendations, and the action
6	taken on them, and records of all appropriations or expenditures made from the community
7	preservation fund. The committee shall also keep records of any real property interests acquired,
8	disposed of or improved by the city or town upon its recommendation, including the names and
9	addresses of the grantors or grantees and the nature of the consideration. The records and
10	accounts shall be public records.
11	45-24.6-12. Acceptance of state grants. – Notwithstanding the provisions of any general
12	or special law to the contrary, every city and town may accept sections 45-24.6-4 through 45-
13	24.6-8, inclusive, and may thereupon receive state grants under subsection 42-142-4 (d). A city
14	or town that accepts sections 45-24.6-4 through 45-24.6-8, inclusive, shall not be precluded from
15	participating in state grant programs.
16	State grant programs may include local adoption of this section among the criteria for
17	selection of grant recipients. Funds in the community preservation fund may be made available
18	and used by the city or town as the local share for state or federal grants upon recommendation of
19	the community preservation committee and the city or town council, as provided for in section
20	45-24.6-6, if such grants and such local share are used in a manner consistent with the
21	recommendations of the community preservation committee.
22	45-24.6-13. Amendment and revocation. – (a) At any time after imposition of the
23	surcharge, the city or town council may approve and the voters may accept an amendment to the
24	amount and computation of the surcharge, or to the amount of exemption or exemptions, in the
25	same manner and within the limitations set forth in this section.
26	(b) At any time after the expiration of five (5) years after the date on which sections 45-
27	24.6-4 through 45-24.6-8, inclusive, have been accepted in a city or town, said sections may be
28	revoked in the same manner as they were accepted by such city or town, but the surcharge
29	imposed under section 45-24.6-4 shall remain in effect in any such city or town, with respect to
30	unpaid taxes on past transactions and with respect to taxes due on future transactions, until all
31	contractual obligations incurred by the city or town prior to such termination shall have been fully
32	discharged.
33	SECTION 2. Section 42-142-4 of the General Laws in Chapter 42-142 entitled
34	"Department of Revenue" is hereby amended to read as follows:

1	42-142-4. Division of property valuation and municipal finance (a) There is hereby
2	established within the department of revenue a division of property valuation and municipal
3	finance. The head of the office shall be the chief of property valuation and municipal finance.
4	(b) The division of property valuation and municipal finance shall have the following
5	duties:
6	(i) Provide assistance and guidance to municipalities in complying with state law;
7	(ii) To encourage cooperation between municipalities and the state in calculating,
8	evaluating and distributing state aid;
9	(iii) To maintain a data center of information of use to municipalities;
10	(iv) To maintain and compute financial and equalized property value information for the
11	benefit of municipalities and public policy decision makers;
12	(v) To encourage and assure compliance with state laws and policies relating to
13	municipalities especially in the areas of public disclosure, tax levies, financial reporting, and
14	property tax issues;
15	(vi) To encourage cooperation between municipalities and the state by distributing
16	information and by providing technical assistance to municipalities;
17	(vii) To give guidance to public decision makers on the equitable distribution of state aid
18	to municipalities;
19	(viii) To provide technical assistance for property tax administration-:
20	(ix) To administer the community preservation act as set forth in subsection (c) herein.
21	(c)(1) There shall be established and set up on the books of the state a separate fund, to be
22	known as the Rhode Island community preservation trust fund, for the benefit of cities and towns
23	that have accepted sections 45-24.6-4 through 45-24.6-8, inclusive, and pursuant to sections 45-
24	24.6-4 through 45-24.6-8, inclusive, have imposed a surcharge on their real property tax levy,
25	subject to any exemptions adopted by a municipality. The fund shall consist of all revenues
26	received by the state: (i) Under the provisions of section 34-13-7 from public and private sources
27	as gifts, grants and donations to further community preservation programs; or (ii) All other
28	monies credited to or transferred to from any other fund or source pursuant to law.
29	(2) The state treasurer shall deposit the fund in accordance with the provisions of
30	subsection 42-142-4(d) in such manner as will secure the highest interest rate available consistent
31	with the safety of the fund and with the requirement that all amounts on deposit be available for
32	withdrawal without penalty for such withdrawal at any time. All interest accrued and earnings
33	shall be deposited into the fund. The fund shall be expended solely for the administration and

2	(3) The state treasurer shall make all disbursements and expenditures from the Rhode
3	Island community preservation trust fund without further appropriation, as directed by the
4	director of revenue in accordance with subsection 42-142-4 (d). The department of revenue shall
5	report by source all amounts credited to said fund and all expenditures from said fund. The
6	director of revenue shall assign personnel of the department as it may need to administer and
7	manage the fund disbursements and any expense incurred by the department shall be deemed an
8	operating and administrative expense of the program. The operating and administrative expenses
9	shall not exceed five percent (5%) of the annual total revenue received under the provisions of
10	subsection 42-142-4 (d).
11	(d)(1) The director of revenue shall annually on or before November 15 disburse monies
12	from the Rhode Island community preservation trust fund established pursuant to this section to
13	cities and towns that have accepted sections 45-24.6-4 through 45-24.6-8, inclusive, and notified
14	the director of its acceptance. The community shall notify the director of the date and terms on
15	which the voters accepted said sections 45-24.6-4 through 45-24.6-8, inclusive. The municipal
16	tax collecting authority shall certify to the director the amount the city or town has raised through
17	June 30 by imposing a surcharge on its real property levy and shall certify the percentage of the
18	surcharge applied.
19	(2) The commissioner shall distribute to each city or town accepting said sections 45-
20	24.6-4 through 45-24.6-8, inclusive, in an amount not less than five percent (5%), but not greater
21	than one hundred percent (100%) of the total amount raised by the additional surcharge on real
22	property by each city or town. This shall be known as the match distribution. The percentage
23	shall be the same for each city and town and shall be determined by the director annually in a
24	manner that distributes the maximum amount available to each participating city or town.
25	(3) After distributing the Rhode Island community preservation trust fund in accordance
26	with this section, the commissioner shall keep any remaining funds in the trust for distribution in
27	the following year.
28	(e) The director of revenue shall have the authority to promulgate rules and regulations to
29	effect the purposes of the Rhode Island community preservation act.
30	SECTION 3. Chapter 44-5 of the General Laws entitled "Levy and Assessment of Local
31	Taxes" is hereby amended by adding thereto the following section:
32	44-5-84. Community preservation special purpose levy (a) Authority for levy.
33	Cities and towns that adopt and accept the provisions of sections 45-24.6-4 through 45-246-8,
34	inclusive, according to the procedures specified therein, may levy a surcharge on real property of

consistent with the provisions of this chapter.

3	(b) Notwithstanding any provision of law or ordinance to the contrary, a special levy		
4	adopted in accordance with the provision of chapter 45-24.6 shall not be included in the		
5	calculation or approval of the maximum levy as set forth in section 45-24	4.6-4 of this chapter.	
6	(c) Use of levy. The proceeds of said levy shall be used solely for the purposes set forth		
7	<u>in chapter 45-24.6.</u>		
8	SECTION 4. Section 34-13-7 of the General Laws in Chapter 34-13 entitled "Recording		
9	of Instruments" is hereby amended to read as follows:		
10	34-13-7. General recording fees (a) The fees to the recording officers for recording

EXPLANATION

BY THE LEGISLATIVE COUNCIL

OF

AN ACT

RELATING TO TOWNS AND CITIES - RHODE ISLAND COMMUNITY PRESERVATION ACT

This act would establish the Rhode Island Community Preservation Act to promote capital investment and development within Rhode Island communities. The act provides a source of funding for such investment and development.

Sections 1, 2, 3, and 5 of this act would take effect on July 1, 2013, and section 4 of this act would take effect on January 1, 2014.
