JOINT RESOLUTION

CREATING A BEHAVIORAL HEALTH AND FIREARMS SAFETY TASK FORCE TO REVIEW, AND MAKE RECOMMENDATIONS FOR, STATUTES RELATING TO FIREARMS AND BEHAVIORAL HEALTH ISSUES

WHEREAS, Recent and well-publicized events, including the tragic shootings at Sandy
 Hook Elementary School in neighboring Connecticut, have called into question how we as a
 society deal with firearm violence and public safety; and

WHEREAS, The Rhode Island General Assembly seeks to ensure that the laws of our State strike an appropriate balance between preserving the individual freedoms and liberties of responsible firearm ownership, on the one hand, and acknowledging that matters of public safety are recognized, on the other hand; and

8 WHEREAS, Many of the current laws enacted in our State relating to firearms have not 9 been reviewed for decades, and though various governmental stakeholders have come together 10 during the 2013 legislative session to propose ways to strengthen these laws, the General 11 Assembly believes that it is appropriate to conduct a comprehensive review of these laws; and

WHEREAS, It is of particular concern how the Rhode Island statutory framework deals
with the intersection of behavioral health and firearms safety; and

WHEREAS, It is in the best interest of the citizens of Rhode Island to convene a task force composed of representatives from the legislative, executive, judicial branches of government, and behavioral health community and firearms associations, to conduct a review of current law and make recommendations on legislation to improve public safety by developing a more comprehensive approach addressing the nexus between behavioral health and firearms safety; now, therefore be it

1	RESOLVED, That the Behavioral Health And Firearms Safety Task Force (hereinafter
2	referred to as the "Task Force") be and the same is hereby created consisting of the shall consist
3	of the following members (it being understood that any member of the Task Force may appoint a
4	designee to attend Task Force meetings in his/her absence, and a quorum of the Task Force shall
5	consist of a majority of its current membership):
6	(1) Three (3) members of the House of Representatives to be appointed by the Speaker of
7	the House, not more than two (2) of whom shall be from the same political party;
8	(2) Three (3) members of the Senate to be appointed by the President of the Senate, not
9	more than two (2) of whom shall be from the same political party;
10	(3) Two (2) members selected by the Governor;
11	(4) Attorney General;
12	(5) State Court Administrator;
13	(6) Director of the Department of Public Safety;
14	(7) Director of the Department of Environmental Management;
15	(8) Director of the Department of Behavioral Healthcare, Developmental Disabilities, and
16	Hospitals;
17	(9) President of the Police Chiefs' Association;
18	(10) Mental Health Advocate;
19	(11) A public member representing mental health service providers, to be appointed by
20	the President of the Senate; and
21	(12) A public member representing substance abuse service providers, to be appointed by
22	the Speaker of House and be it further; and
23	(13) Three (3) members representing the Sporting Community as appointed by the state's
24	largest non-profit Sportsman's organization, the Federated RI Sportsmen's Club, Inc.; and be it
25	further
26	RESOLVED, That the Representative appointed from the political party of the Speaker
27	of House and the Senator appointed from the political party of the President of the Senate shall
28	call the first meeting of the Task Force, and the members of the Task Force shall, at their first
29	meeting, elect a Chairperson, a Secretary, and any other officers they may find necessary; and be
30	it further
31	RESOLVED, That the Task Force shall assemble, at the call of the Chairperson or upon
32	petition of a majority of its members, upon written notice of each meeting stating the place, day,
33	and time of the meeting, along with purpose and/or agenda of the meeting. The written notice
34	shall be sent to all representatives not less than seven (7) nor more than ten (10) days before the

1 <u>meeting; and be it further</u>

2 RESOLVED, That the Task Force shall assemble no less than two (2) times per month, or more often at the call of the Chairperson or upon petition of a majority of its members; and be 3 4 it further 5 RESOLVED, That the Task Force shall perform the following functions with respect to the National Instant Criminal Background Check System ("NICS"): 6 7 (1) Conduct a review of different states' approaches for compliance with the NICS Index 8 (which includes information contributed by federal and state agencies identifying persons 9 prohibited from possessing firearms because of mental health or substance abuse history) to 10 ensure that the state conforms to best practices nationally; 11 (2) Propose legislation and recommendations to support the state's full participation in the 12 NICS Index; and 13 (3) Act in an advisory capacity to the relief board, under chapter 40.1-30 of the Rhode 14 Island General Laws, until it is fully operational; and be it further 15 RESOLVED, That the Task Force shall review chapter 11-47 of the Rhode Island 16 General Laws entitled "Weapons" and chapter 40.1-5 of the Rhode Island General Laws entitled 17 "Mental Health Law" and make recommendations to revise such chapters consistent with this 18 Joint Resolution, which recommendations shall include, but not be limited to, ensuring (i) The 19 privacy of information identifying persons with disqualifying behavioral health adjudications or 20 commitments; and (ii) That the definitions used in such chapters related to mental health and 21 substance abuse (or in contemporaneous legislation proposed by the Task Force or the Task Force 22 on Firearms Statutes) are consistent; and be it further 23 RESOLVED, That the Task Force shall transmit such recommendations to the Governor, 24 the Speaker of the House and the President of the Senate on or before January 1, 2014 January 30, 25 <u>2014</u>; and be it further RESOLVED, That before transmitting such recommendations to the Governor, the 26 27 Speaker of the House and the President of the Senate, the Task Force shall have conferred with 28 the Task Force on Firearms Statutes to ensure that their proposed recommendations for revising

29 the Rhode Island General Laws do not conflict; and be it further

RESOLVED, That the Secretary of State be and hereby is authorized and directed to
 transmit duly certified copies of this resolution to the Governor, the President of the Senate, and
 the Speaker of the House; and be it further

- 1 RESOLVED, That upon completion and transmission of its recommendations, the Task
- 2 Force shall be decommissioned and dissolved by June 30, 2014.

1	This resolution would create a twenty (20) member special legislative study commission
2	whose purpose would be to make a comprehensive review of current law and make

5	report back to the Governor, the Speaker of the House, and the President of the Senate, no later
6	than January 30, 2014, and whose life would expire on June 30, 2014.
