JOINT RESOLUTION

CREATING A BEHAVIORAL HEALTH AND FIREARMS SAFETY TASK FORCE TO REVIEW, AND MAKE RECOMMENDATIONS FOR, STATUTES RELATING TO FIREARMS AND BEHAVIORAL HEALTH ISSUES

1	WHEREAS, Recent and well-publicized events, including the tragic shootings at Sandy
2	Hook Elementary School in neighboring Connecticut, have called into question how we as a
3	society deal with firearm violence and public safety; and
4	WHEREAS, The Rhode Island General Assembly seeks to ensure that the laws of our
5	state strike an appropriate balance between preserving the individual freedoms and liberties of
6	responsible firearm ownership, on the one hand, and on the other hand, acknowledging that
7	matters of public safety are recognized; and
8	WHEREAS, Many of the current laws enacted in our state relating to firearms have not
9	been reviewed for decades, and though various governmental stakeholders have come together
10	during the 2013 legislative session to propose ways to strengthen these laws, the General
11	Assembly believes that it is appropriate to conduct a comprehensive review of these laws; and
12	WHEREAS, It is of particular concern how the Rhode Island statutory framework deals
13	with the intersection of behavioral health and firearms safety; and
14	WHEREAS, It is in the best interest of the citizens of Rhode Island to convene a task
15	force composed of representatives from the legislative, executive, and judicial branches of
16	government, members of the behavioral health community, and representatives from firearm
17	associations; now, therefore be it
18	RESOLVED, That the Behavioral Health And Firearms Safety Task Force (hereinafter
19	referred to as the "Task Force") be and the same is hereby created consisting of twenty (20)

1	members: three (3) of whom shall be members of the House of Representatives, to be appointed
2	by the Speaker of the House, not more than two (2) of whom shall be from the same political
3	party; three (3) of whom shall be members of the Senate, to be appointed by the President of the
4	Senate, not more than two (2) of whom shall be from the same political party; two (2) of whom
5	shall be members to be selected by the Governor; one of whom shall be the Attorney General, or
6	designee; one of whom shall be the State Court Administrator, of designee; one of whom shall be
7	the Director of the Department of Public Safety, or designee; one of whom shall be the Director
8	of the Department of Environmental Management, or designee; one of whom shall be the
9	Director of the Department of Behavioral Healthcare, Developmental Disabilities and Hospitals,
10	or designee; one of whom shall be the President of the Police Chiefs' Association, or designee;
11	one of whom shall be the Mental Health Advocate, or designee; one of whom shall be a public
12	member representing mental health service providers, to be appointed by the President of the
13	Senate; one of whom shall be a public member representing substance abuse service providers, to
14	be appointed by the Speaker of House; and three (3) of whom shall be public members of the
15	Federated Rhode Island Sportsmen's Club, Inc., one of whom shall be appointed by the Speaker
16	of the House, one of whom shall be appointed by the President of the Senate, and one of whom
17	shall be appointed by the Governor.
18	The purpose of said Task Force shall be to conduct a review of current law and make
19	recommendations on legislation to improve public safety by developing a more comprehensive
20	approach addressing the nexus between behavioral health and firearms safety and shall include
21	performing the following functions with respect to the National Instant Criminal Background
22	Check System ("NICS"):
23	(1) Conduct a review of different states' approaches for compliance with the NICS Index
24	(which includes information contributed by federal and state agencies identifying persons
25	prohibited from possessing firearms because of mental health or substance abuse history) to
26	ensure that the state conforms to best practices nationally;
27	(2) Propose legislation and recommendations to support the state's full participation in the
28	NICS Index; and

- 29 (3) Propose legislation and recommendations concerning the form and composition of the 30 relief from disabilities board based on a review of federal and state laws, rules, and regulations; 31 and be it further
 - RESOLVED, That the Task Force shall review chapter 11-47 of the Rhode Island General Laws entitled "Weapons" and chapter 40.1-5 of the Rhode Island General Laws entitled "Mental Health Law" and make recommendations to revise such chapters consistent with this

2	privacy of information identifying persons with disqualifying behavioral health adjudications or
3	commitments; and (2) That the definitions used in such chapters related to mental health and
4	substance abuse (or in contemporaneous legislation proposed by the Task Force) are consistent
5	before transmitting such recommendations to the Governor, the Speaker of the House, and the
6	President of the Senate.
7	In lieu of any appointment of a member of the legislature to a permanent advisory
8	commission, a legislative study commission, or any commission created by a General Assembly
9	resolution, the appointing authority may appoint a member of the general public to serve in lieu
10	of a legislator, provided that the majority leader or the minority leader of the political party which
11	is entitled to the appointment consents to the member of the general public.
12	Forthwith upon passage of this resolution, a Representative appointed from the political
13	party of the Speaker of House and a Senator appointed from the political party of the President of
14	the Senate shall call the first meeting of the Task Force, and the members of the Task Force shall,
15	at their first meeting, elect a Chairperson, a Secretary, and any other officers they may find
16	necessary.
17	The Task Force shall assemble no less than two (2) times per month, or more often at the
18	call of the Chairperson or upon petition of a majority of its members, upon written notice of each
19	meeting stating the place, day, and time of the meeting along with the purpose and/or agenda of
20	the meeting. The written notice shall be sent to all members of the Task Force not less than seven
21	(7), nor more than ten (10) days prior to the meeting.
22	A quorum of the Task Force shall consist of a majority of its current membership and the
23	membership shall receive no compensation for their services.
24	Vacancies in said Task Force shall be filled in like manner as the original appointment.
25	All departments and agencies of the state shall furnish such advice and information,
26	documentary and otherwise, to said Task Force and its agents as is deemed necessary or desirable
27	by the Task Force to facilitate the purposes of this resolution.
28	The Joint Committee on Legislative Services is hereby authorized and directed to provide
29	suitable quarters for said Task Force; and be it further
30	RESOLVED, That the Task Force shall report its findings and recommendations to the
31	Governor, the Speaker of the House, and the President of the Senate no later than January 31,
32	2014, and said Task Force shall expire on June 30, 2014.
