It is enacted by the General Assembly as follows:

1           SECTION 1. The Town of West Warwick is hereby authorized and empowered to issue  
2 bonds to an amount not exceeding six million four hundred thousand dollars (\$6,400,000), from  
3 time to time under its corporate name and seal, pursuant to an ordinance to be adopted by the  
4 Town in accordance with the West Warwick Home Rule Charter and Rhode Island General Laws  
5 section 45-12-2.

6           SECTION 2. In accordance with section 16-7-44 of the general laws, the principal of and  
7 interest on such bonds shall be eligible for state housing aid reimbursement.

8           SECTION 3. Notwithstanding section 16-7-41.1 of the general laws, this project, which  
9 was approved by the Commissioner of Elementary and Secondary Education on or about March  
10 23, 2007, shall be and remain eligible for school housing aid notwithstanding any period of  
11 inactivity in carrying out the project.

12           SECTION 4. This act serves as the enabling act required by Rhode Island General Laws  
13 section 16-7-44 and shall take effect upon passage.
