11	Forthwith upon passage of this resolution, the members of the commission shall meet at
12	the call of the Speaker of the House and organize. The Speaker of the House shall appoint a
13	chairperson.
14	Vacancies in said commission shall be filled in like manner as the original appointment.
15	The membership of said commission shall receive no compensation for their services.
16	All departments and agencies of the state shall furnish such advice and information,
17	documentary and otherwise, to said commission and its agents as is deemed necessary or
18	desirable by the commission to facilitate the purposes of this resolution.
19	The Speaker of the House is hereby authorized and directed to provide suitable quarters
