It is enacted by the General Assembly as follows:

1 SECTION 1. Section 41-5-22 of the General Laws in Chapter 41-5 entitled "Boxing and 2 Wrestling" is hereby amended to read as follows: 3 41-5-22. Rules and regulations. -- The division of racing and athetics department of 4 business regulation may make such rules and regulations for the administration and enforcement 5 of this chapter as it may deem necessary. Provided, further, notwithstanding any provision of the general or public laws to the contrary, the department of business regulation shall have the power 6 7 to adopt by rule or regulation, in whole or in part, any standards, rules, regulations, handbooks or 8 other standards and procedures governing boxing as approved by the American Boxing 9 Commission. The rules and regulations may also provide for and regulate the granting of a special 10 permit for exhibitions where no decision is to be rendered and where a skilled boxer or boxers 11 merely demonstrate the science of boxing. 12 SECTION 2. Section 41-5.2-25 of the General Laws in Chapter 41-5.2 entitled "Mixed 13 Martial Arts" is hereby amended to read as follows: 14 41-5.2-25. Rules and regulations. -- The division of racing and athletics department of 15 business regulation may make such rules and regulations for the administration and enforcement of this chapter as it may deem necessary. Provided, further, notwithstanding any provision of the 16 17 general or public laws to the contrary, the department of business regulation shall have the power 18 to adopt by rule or regulation, in whole or in part, any standards, rules, regulations, handbooks or

other standards and procedures governing mixed martial arts as approved by the American

- 1 <u>Boxing Commission.</u> The rules and regulations may <u>also</u> provide for and regulate the granting of
- 2 a special permit for exhibitions where no decision is to be rendered and where skilled mixed
- 3 martial artists merely demonstrate the science of boxing.
- 4 SECTION 3. This act shall take effect upon passage.
