AN ACT

RELATING TO EDUCATION - THE RHODE ISLAND BOARD OF EDUCATION ACT

<u>Introduced By:</u> Senators Felag, Pearson, Algiere, Gallo, and Lynch <u>Date Introduced:</u> January 30, 2014 <u>Referred To:</u> Senate Education

It is enacted by the General Assembly as follows:

SECTION 1. Section 16-97-1 of the General Laws in Chapter 16-97 entitled "The Rhode
 Island Board of Education Act" is hereby amended to read as follows:

<u>16-97-1. Rhode Island board of education established. --</u> (a) Effective January 1, 2013,
there is created a board of education which shall be and is constituted a public corporation,
empowered to sue and be sued in its own name, to have a corporate seal, and to be vested with all
the powers and duties currently vested in the board of governors for higher education established
in chapter 16-59 and the board of regents for elementary and secondary education established in
chapter 16-60.

9 (b) Upon its organization, the board of education shall be vested with the legal title (in 10 trust for the state) to all property, real and personal, now owned by and/or under the control or in 11 the custody of the board of governors for higher education and the board of regents for 12 elementary and secondary education, for the use of the board of education. The board of 13 education is hereby-designated successor to all powers, rights, duties, and privileges pertaining to 14 the board of regents for elementary and secondary education and the board of governors for 15 higher education.

(c) The board of education shall consist of <u>eleven (11)</u> <u>twelve (12)</u> public members
appointed by the governor with the advice and consent of the senate. <u>One of the members shall be</u>
<u>an employer community member of the state workforce investment board as established in §28-</u>
<u>45.1-2.</u> Four (4) of the members initially appointed pursuant to this section shall serve terms of

three (3) years; four (4) members initially appointed pursuant to this section shall serve terms of two (2) years; and, three (3) members initially appointed pursuant to this section shall serve terms of one year. Thereafter, all members appointed pursuant to this section shall serve terms of three (3) years. No board member shall be appointed to serve more than two (2) three (3) year terms.

(d) The governor shall select from the appointed members a chairperson and vice
chairperson. A quorum shall consist of six (6) members of the board. A majority vote of those
present shall be required for action.

8 (e) The statutory responsibilities of the department of elementary and secondary 9 education, the commissioner of elementary and secondary education, and the commissioner of 10 higher education shall remain unchanged. No later than July 1, 2013, the board of education shall 11 submit to the governor and the general assembly its final plan for the permanent administrative 12 structure for higher education. As a requisite element of the administrative structure for higher 13 education, the board of education shall establish a plan for distributing the assets, responsibilities, 14 powers, authorities, and duties of the office of higher education to the three (3) higher education 15 institutions and appropriate state agencies. Said distribution shall be done in a manner designed to 16 maximize efficiency, provide greater articulation of the respective responsibilities of elementary 17 and secondary and higher education, and ensure that students are prepared to succeed in school, 18 college, careers, and life. The permanent governance structure for higher education shall, at a 19 minimum: (1) Provide clear guidance on statutory, legal, financial and contractual obligations; (2) 20 Establish a policy framework that furthers the goals of this chapter; and (3) Establish appropriate 21 administrative structures, support, policies and procedures. Effective July 1, 2014, the office of 22 higher education shall be abolished.

(f) The board shall prepare a plan that ensures that career and technical education, adult
education and the community college of Rhode Island are given due consideration as important
components of the state's public education system as well as its workforce development efforts.
The plan shall be developed with input from Rhode Island-based employers and shall be
submitted to the governor, the speaker of the house and the president of the senate no later than
January 12, 2015.
SECTION 2. This act shall take effect upon passage.

BY THE LEGISLATIVE COUNCIL
