It is enacted by the General Assembly as follows:

1 SECTION 1. That act entitled, "AN ACT EXEMPTING FROM TAXATION CERTAIN  
2 REAL AND PERSONAL ESTATE HELD BY ST. ANDREW'S INDUSTRIAL SCHOOL IN  
3 BARRINGTON, RHODE ISLAND. (Name now changed to the St. Andrew's school.)", enacted  
4 by the general assembly at its January session, 1950, is hereby repealed.

5 ~~Section 1. St. Andrew's industrial school, in Barrington, Rhode Island, (Name now~~  
6 ~~changed to St. Andrew's school), a corporation organized by authority of law, March 7, 1896, is~~  
7 ~~hereby authorized to take, hold, transmit and convey the land, with all buildings and~~  
8 ~~improvements thereon, situate in Barrington, Rhode Island, now belonging to such corporation;~~  
9 ~~said real and personal estate to be taken, held, transmitted and conveyed for educational purposes~~  
10 ~~and exempt from taxation by authority of section 2 of chapter 29 of the general laws, entitled~~  
11 ~~"Property liable to and exempt from taxation," as amended.~~

12 ~~Sec. 2. The real and personal estate of said St. Andrew's industrial school, Barrington,~~  
13 ~~Rhode Island, shall be exempt from taxation so long as the same shall be used for the purposes of~~  
14 ~~said corporation.~~

15 ~~Sec. 3. This act shall take effect upon its passage.~~

16 SECTION 2. Chapter 44-5 of the General Laws entitled "Levy and Assessment of Local  
17 Taxes" is hereby amended by adding thereto the following section:

18 **44-5-13.39. Barrington - Exemption for St. Andrew's School. -- (a) The tax assessor of**

1 the town of Barrington is authorized to grant an exemption from real property taxation to St.  
2 Andrew's School, a non-profit educational corporation located in said town, to the extent of five  
3 (5) acres of the real property of said corporation, said five (5) acres to be identified and so  
4 designated by the corporation, and to be exempt from taxation so long as the same shall be used  
5 for the purposes of said corporation.

6 (b) This section applies only to assessment and taxes in the town of Barrington.

7 SECTION 3. This act shall take effect upon passage.
