RELATING TO PROPERTY - RESIDENTIAL SECURITY DEPOSITS

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 34-18-19 of the General Laws in Chapter 34-18 entitled
2 "Residential Landlord and Tenant Act" is hereby amended to read as follows:

3 **34-18-19. Security deposits.** -- (a) A landlord may not demand or receive a security
4 deposit, however denominated, in an amount or value in excess of one month's periodic rent.

5 (b) Upon termination of the tenancy, the amount of security deposit due to the tenant
6 shall be the entire amount given by the tenant as a security deposit, minus any amount of unpaid
7 accrued rent, the amount due, if any, for reasonable cleaning expenses, the amount due, if any, for
8 reasonable trash disposal expenses and the amount of physical damages to the premises, other
9 than ordinary wear and tear, which the landlord has suffered by reason of the tenant's
10 noncompliance with § 34-18-24, all as itemized by the landlord in a written notice delivered to
11 the tenant. The landlord shall deliver the notice, together with the amount of the security deposit
12 due to the tenant, within twenty (20) days after the later of either termination of the tenancy,
13 delivery of possession, or the tenant's providing the landlord with a forwarding address for the
14 purpose of receiving the security deposit.

15 (c) If the landlord fails to comply with subsection (b), the tenant may recover the amount
16 due him or her, together with damages in an amount equal to twice the amount wrongfully
17 withheld, and reasonable attorney fees.

18 (d) This section does not preclude the landlord or tenant from recovering other damages
19 to which he or she may be entitled under this chapter.

1 (e) In the event the landlord transfers his or her interest in the premises, the holder of the
2 landlord's interest in the premises at the time of the termination of the tenancy is bound by this
3 section.

4 (f) No rental agreement shall contain any waiver of the provisions of this section.

5 SECTION 2. This act shall take effect upon passage.
