It is enacted by the General Assembly as follows:

SECTION 1. Title 45 of the General Laws entitled "TOWNS AND CITIES" is hereby 1 2 amended by adding thereto the following chapter: 3 CHAPTER 55.1 DISCLOSURE OF NAMES OF MUNICIPAL GOVERNMENT CONSULTANTS 4 5 45-55.1-1. Public disclosure required. – (a) All departments, agencies, commissions, 6 committees, boards, councils, or authorities or any subdivision thereof of a municipal government 7 and any fire district shall annually prepare and submit to the budget office by October 1 a list 8 containing: 9 (1) The name of any person, privatization contractor, or vendor who performed legal, 10 medical, accounting, engineering, or any other professional, technical or consultant service to the department, commission, board, council, agency or public corporation on a contractual basis 11 12 during the previous fiscal year; and (2) The amount of compensation received by each consultant during the previous fiscal 13 14 year. 15 (b) All departments, agencies, commissions, committees, boards, councils, or authorities 16 or any subdivision thereof of a municipal government and any fire district shall prepare and submit to the budget office on an annual basis by October 1 a contracting report containing: 17

(1) Digital/electronic copies of all contracts or agreements by which a nongovernmental
