1 WHEREAS, Jeannette Finch, daughter of John and Carol Finch, was born with
2 Osteogenesis Imperfecta (OI), also known as Brittle Bone Disease. Her father also suffers from
3 this disease. Osteogenesis has no cure and affects up to 50,000 Americans. It's a disease that leads
4 to frequent bone fractures in one's life and other possible symptoms include pulmonary disease,
5 curved bones or spines, loose joints, muscle weakness, hearing loss, brittle teeth, and shortness of
6 stature; and

7 WHEREAS, Jeannette suffered her first fracture at the age of six months and has already
8 suffered five fractures in her legs and arms. Despite suffering from this debilitating disease,
9 Jeannette lives her life like any other young kid. She loves to swim, an activity that is good for
10 people with her condition, and dreams of being an artist one day. Most importantly, she bravely
11 battles her condition on a daily basis with good spirits, a sense of optimism, and has become an
12 ambassador for those suffering from Osteogenesis; and

13 WHEREAS, On April 21, 2015, in recognition of Jeannette's courageous fight against
14 Osteogenesis and her resolve to live her life like any other nine year old kid, Hasbro Children's
15 Hospital honored Jeannette Finch as their 2015 Children's Network Hospitals Rhode Island
16 Champion. In her ambassadorial role, Jeannette will highlight the lifesaving work of Hasbro
17 Children's Hospital and the immense importance of donating funds to support research, treatment,
18 and ongoing care at the Hospital; now, therefore be it
